Tuesday, June 26 after 7 PM. in support of Fire and Life Safety Improvements Project, GSA contractors would like to drill a hole in the following offices: 128C (bookcase will be moved), 128D (safe will be moved), 128E, 134 (picture will be moved), 140 (desk will be moved) 140C (furniture will be moved away from the right wall as you face the window), 142B (fax will be moved). In order to maneuver the necessary equipment, some furniture will be temporarily moved out of the way and replaced before 5 AM. If it would not be too much of an imposition, please remove loose items on top of the furniture to be moved. The location of the hole to be drilled, in most instances, is marked with a white dot. No computer equipment is impacted.

Since some of the offices are keyed to USSS/TSD lock system, I have

prepared a memo for your signature, allowing USSS to open and lock any of your offices on their system. If this schedule is acceptable, please print out the attached memo, sign it and fax back to me at 5-1051.

The contractor will provide a temporary cover over the hole and will restore the affected rooms to their original condition. GSA will provide blue passholder escort to and from the rooms and will be on the job site throughout the work.
