**DANNY REEVES**  
**U. S. District Court for the Eastern District of Kentucky**

- Danny Reeves, 44, is an accomplished trial lawyer. He is a partner and chair of the litigation department at the law firm of Greenbaum Doll & McDonald, PLLC, where he has worked since completing his judicial clerkship in 1983 for Judge Eugene E. Siler, Jr.
- Reeves is a 1978 honors graduate of the Eastern Kentucky University. He earned the money to put himself through college by working as a laborer for a Kentucky coal mining company and in a General Motors assembly plant, among other places.
- Reeves was awarded a scholarship to attend the Salmon P. Chase College of Law, Northern Kentucky University, where he graduated in 1981 with honors.
- Reeves is a member of, and has held leadership positions in, several professional organizations including the American Bar Association, the Federal Bar Association, the Kentucky Bar Association, and the Fayette County Bar Association. He is a life member of the Sixth Circuit Judicial Conference and has served on the Bench/Bar Liaison Committee of the U.S. District Court for the Western District of Kentucky.
- Reeves has also served his community as a director of the Volunteer Center of the Bluegrass, an organization affiliated with the United Way, as a director of the Kentucky Museum of Natural History, and as an officer and director of the Bluegrass Youth Hockey Association.
- Reeves's nomination to the district court has the support of both Senator Mitch McConnell and Senator Jim Bunning.
