Friends: I am sending the following letter to the president of ABC.

Peter Jennings is unworthy to live in our country. I served a full

career in the Army and in combat for two years to protect his right to run his mouth, but also for my right to seek his firing--and I do; please join me. Denny Gillem

Dear Sir:

I was horrified by Peter Jennings' comments this morning as he referred to President Bush. His comment that President Bush should "quit hiding behind the Secret Service, come out and face the Nation and explain 'the President's failure' to protect the country from these terrorists attacks."

This is at best "the lowest form of attack" and unworthy of any news organization, and at worst could easily be considered an act of "treason." As a result, I am asking all of my friends and acquaintances to join me in a boycott of ABC--all programs as all times--and will not watch your network again as long as Peter Jennings is an ABC employee. I will also ask sponsors to cancel their support of ABC. While people are removed from the air for using "politically incorrect" words, the words of Peter Jennings are orders of magnitude more egregious and offensive than any of these other offenses.

I ask, indeed, demand, that you immediately fire Peter Jennings for his lack of journalistic integrity and his unworthy attack on the President during this National Crisis.
