Statement by Peggy M. Venable President, Texas Women's Alliance Announces Organization's Support of Justice Owen

The Texas Women's Alliance is announcing support for Texas' own Supreme Court Justice Priscilla Owen for the 5th Circuit Court of Appeals.

Justice Owen is one of President Bush's original May 9, 2001 nominees to the federal bench. Priscilla Owen is a strong constitutional advocate. Currently a Justice on the Supreme Court of Texas, Priscilla Owen first won election in 1994. In her re-election bid in 2000, every major newspaper in Texas endorsed her. The American Bar Association has deemed her "highly qualified."

"Justice Owen has represented Texans well," said Peggy Venable, president of TWA. "She will continue to serve with distinction, provided the liberal special interest groups stop playing politics with our court appointees and allow the confirmation to move forward."

While not endorsing every decision Justice Owen has ever rendered, the TWA deems her a highly qualified, independent mainstream justice. This is the first such endorsement for TWA, an organization established 17 years ago to express a fiscal conservative voice for Texas women.

The Texas Women's Alliance is nonpartisan, statewide, educational organization of women leaders whose purpose is to articulate an independent conservative viewpoint and influence public policy in Texas.
