Brett M. Kavanaugh

Brett Kavanaugh is Associate Counsel to President Bush and works in the office of Judge Alberto Gonzales, Counsel to the President. Mr. Kavanaugh graduated from Yale College in 1987 and from Yale Law School in 1990. He clerked for Judge Walter Stapleton on the United States Court of Appeals for the Third Circuit and for Judge Alex Kozinski on the United States Court of Appeals for the Ninth Circuit. He worked in 1992-93 as an attorney in the Office of Solicitor General at the Department of Justice. Mr. Kavanaugh clerked for Justice Anthony M. Kennedy on the Supreme Court of the United States in 1993-94. After his clerkship with Justice Kennedy, Mr. Kavanaugh worked for the Office of Independent Counsel Kenneth W. Starr from 1994 to 1997 and again in 1998. Mr. Kavanaugh was a partner in the Washington office of Kirkland & Ellis from 1997 to 1998 and from 1999 to January 2001.
