The Senate Judiciary Committee has delayed a vote on the nomination of Priscilla Owen until after the August recess. This doesn't mean that we can forget about this important nomination! It is essential that you learn more about the issues so you are ready for the vote, which may happen in early September.

On July 23, the Senate Judiciary Committee held a hearing on Owen's nomination. In a letter to Senator Patrick Leahy (D-VT), Chair of the Senate Judiciary Committee, a total of 14 progressive organizations, including Planned Parenthood, National [C Council of Jewish Women](http://www.benchmarkcampaign.org), People for the American Way, and the NAACP stated: "Our exhaustive and careful review of Priscilla Owen's record on the Texas Supreme Court has left us with little alternative but to oppose her confirmation because of her activist and extreme views on important civil rights, worker's rights, consumer's rights, and women's rights issues." 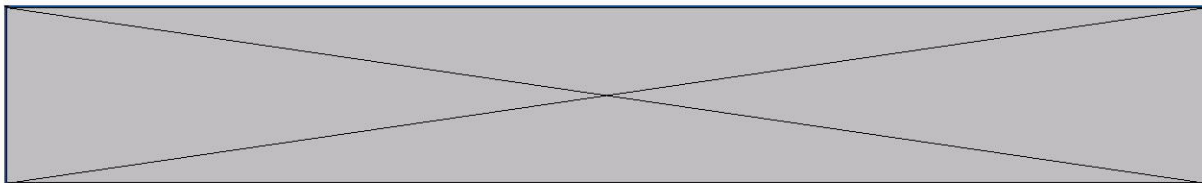
