Diana,

I know you had an opportunity to meet with Mike Horowitz about various legal reform issues, including auto choice. I wondered if you might be interested in a briefing on auto choice alone, inasmuch as it would seem to fit nicely into the president's agenda on a number of scores, including --

(1) The equivalent of roughly a \$48 billion tax cut (the approximate number that the new JEC study will produce of annual savings if all motorists chose the new PIP system).

(2) An approximate 5% increase in the income of low-income people, because they receive a disproportionately higher percentage of the savings and, when they reside in inner cities, a higher absolute amount of savings. While acolor blind system, minorities would clearly be among the greatest beneficiaries.

(3) A significant reduction in federal and state Medicaid costs because auto insurance would pay instead of Medicaid in many cases. For the same reason, there would also be savings in Medicare and Social Security.

Needless to say, there are many other good reasons for supporting this legislation. FYI, I am attaching a paper on federalism that was largely put together by the offices of Senator McConnell and Majority Leader Arney. As always, you can get detailed information from my web site at autoreform.org.
