This should cause us to redouble our efforts to get members of our coalition group to call Southern, Maine and Rhode Island Senators to ensure Pryor is treated fairly once the committee sends his name to the floor of the Senate.

Senator Schumer:

Kennedy:

Kennedy: "An important question we must ask is whether or not you have an agenda. You are entitled to your opinion, but you aren't entitled to be voted for. We have to make an independent decision. We won't be a rubber stamp [on your nomination]."

Kennedy: "You want to roll back the Constitution to fit your agenda. You're an advocate so extreme that your statements at times are intemperate."
