As it turns out, I will not have an opinion on orders tomorrow, but my vote counts in some other matters that will be on orders. Orders are scheduled to issue at 9:00 a.m. Texas time. I am delivering my resignation letter to the Governor's office tomorrow (Friday) afternoon, and it is effective at 9:00 a.m. (again, Texas time) on Monday, June 6, or earlier if the Governor chooses to accept it before the stated effective date, which seems unlikely. There should be nothing between Friday afternoon and Monday morning that requires my participation or vote, and if an emergency were to arise, I would be shown as "not sitting." If you need any additional information or clarification, please let me know. We are scheduled for the oath to occur sometime between 9:30 a.m. and 10:00 Texas time on Monday.
