Court Sealed - The document is withheld under a court seal and is not subject to the Freedom of Information Act.

China-Related Trade Actions

- NTE Report: USTR's annual National Trade Estimates Report, which includes a lengthy chapter on Chinese trade barriers (published March 31)
- Anti-dumping cases: Commerce rulings are pending on a number of Chinese imports, including:
 - Color TVs (final determination due April 8)
 - Furniture (preliminary determination due April 28 but may be extended)
 - Shrimp (preliminary decision due June 8 but may be extended)
- Labor 301: Deadline for USTR decision on AFL-CIO's Section 301 petition on Chinese labor practices (April 30)
- Currency 301: Possible filing of a Section 301 petition on Chinese currency practices (late April/early May?)
- WTO Semiconductor VAT case: End of mandatory consultation period under WTO case on China's discriminatory semiconductor value-added tax rebate scheme (late May)
