SUBJECT: Fiscal Year 2004-2012 Nuclear Weapons Stockpile
Plan (U)

Nuclear forces remain a major element in U.S. national security strategy. Ensuring U.S. nuclear forces have the right types and quantities of nuclear warheads is critical to achieving defense policy goals. Likewise, maintaining the infrastructure that supports nuclear warheads, reserves of tritium, and special nuclear material is essential to sustaining reliable operations.

This NSPD approves and directs implementation of the Nuclear Weapons Stockpile Plan for FY 2004-2012. The Department of Defense (DOD) is authorized custody of the warhead types and quantities reflected in Table 1 (attached) for the years specified in the plan. The next Nuclear Weapons Stockpile Plan should be submitted to me by September 30, 2005. Additionally, the Assistant to the President for National Security Affairs shall be advised of any changes that exceed plus or minus 10 percent of the total stockpile for each year. (U)

While there is no immediate requirement for new nuclear weapon production, it is vital to our national security to restore the capability to deliver new, certified weapons to the stockpile in a timely manner. (U)

There are a number of activities required to ensure stockpile sustainment and reliable operations. The following nuclear weapon activities are authorized for the period of this plan:

- Consistent with environmental, safety, and health standards, the Department of Energy (DOE) shall disassemble those quantities of nuclear warheads and produce nuclear warhead parts necessary to maintain the approved stockpile, and shall provide additional nuclear weapon parts as necessary for development and flight test programs. Until the nuclear weapons infrastructure is restored, risk will be managed through a balancing of retirements and disassemblies consistent with giving priority to refurbishing those warheads needed to support deployments. Non-deployed warheads will serve as a reserve and, in some specific cases, retired warheads awaiting disassembly may be returned to the stockpile to substitute for warheads that experience an unforeseen technical failure. (U)
- DOE, in coordination with DOD, shall authorize changes to custody plans for retired warheads in order to meet disassembly schedules that satisfy the safe and secure storage and transportation standards of each Department. (U)



Plan (U)

Nuclear forces remain a major element in U.S. national security strategy. Ensuring U.S. nuclear forces have the right types and quantities of nuclear warheads is critical to achieving defense policy goals. Likewise, maintaining the infrastructure that supports nuclear warheads, reserves of tritium, and special nuclear material is essential to sustaining reliable operations. It is of vital importance to U.S. interests to maintain a safe, secure, reliable, and effective nuclear weapons stockpile. (U)

The Department of Defense (DOD) is authorized custody of the warhead types and quantities reflected in Table 1 (attached) for the years specified in the plan. Additionally, the Assistant to the President for National Security Affairs shall be advised of any changes that exceed plus or minus 10 percent of the total stockpile for each year. (U)

Significant reductions in deployed nuclear weapons by 2012 and beyond will place a high premium on reliability. Stockpile age

will act against reliability. I approve the Secretaries of Defense and Energy's plan to examine a Reliable Replacement Warhead concept that has a greater potential of sustaining a highly reliable nuclear arsenal for the foreseeable future. (U)


There are a number of activities required to ensure stockpile sustainment and reliable operations. The following nuclear weapon activities are authorized for the period of this plan: (U)

- Consistent with environmental, safety, and health standards, the Department of Energy (DOE) shall disassemble those quantities of nuclear warheads and produce nuclear warhead parts necessary to maintain the approved stockpile and shall provide additional nuclear weapon parts as necessary for development and flight test programs. (U)
- Until the nuclear infrastructure is restored and capable of delivering new certified or replacement warheads in a timely fashion, I approve the approach to managing risk by balancing retirements and disassemblies consistent with giving priority to refurbishing those warheads needed to support deployments. I also approve the plan that relies on some nondeployed warheads as a reserve and, in specific cases, could use retired warheads awaiting disassembly to substitute for operational warheads. (U)
- DOE, in coordination with DOD, shall authorize changes to custody plans for retired warheads in order to meet disassembly schedules that satisfy the safe and secure storage and transportation standards of each department. (U)
