FOIA 2014-0304-F contains materials related to correspondence between President Bush and Senator Elizabeth Dole from March 25, 2006 to September 30, 2006.

This FOIA primarily contains letters, drafts of a letter, a correspondence tracking sheet, a barcode scanning sheet, and an email. They consist of correspondence between Senator Elizabeth Dole and President Bush requesting the President to nominate attorneys from North Carolina to fill vacancies in the United States Court of Appeals for the Fourth Circuit. Also included is a birthday message to Senator Dole from the President.

### **System of Arrangement**

The materials in FOIA 2014-0304-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA request 2014-0304-F contains records on correspondence between President Bush and Senator Elizabeth Dole between March 25, 2006 and September 30, 2006.
