#### Access

Collection is open to all researchers. Access to George W. Bush Presidential Records is governed by the Presidential Records Act (PRA) (44 USC 2201) and the Freedom of Information Act (FOIA) (5 USC 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

#### Copyright

Documents in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Researchers are advised to consult the copyright law of the United States (Title 17, USC) which governs the making of photocopies or other reproductions of copyrighted material.

#### **Provenance**

Official records of George W. Bush's presidency are housed at the George W. Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

#### **Scope and Content**

The materials in FOIA 2014-0329-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2014-0329-F contains materials related to notes from Prime Minister Tony Blair of the United Kingdom to President George W. Bush concerning the Iraq War.

This FOIA primarily contains routing sheets and a letter transmitting a letter from Prime Minister Tony Blair.

It should be noted that many of the documents listed here have been closed to National Security classification and/or exemptions of the Freedom of Information Act.

#### **System of Arrangement**

The materials in FOIA 2014-0329-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA request 2014-0329-F contains records on notes sent to President George W. Bush from Prime Minister Tony Blair of the United Kingdom regarding the Iraq War.

Documents responsive to this FOIA were found in these collection areas – White House Office of Records Management (WHORM) Subject Files and Staff Member Office Files

Staff Member Office Files are maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Staff Member Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

WHORM Subject Files are processed at the document level.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category.
