FOIA 2014-0365-F requested materials related to records created by or sent to Kathleen Casey, SEC Commissioner.

This FOIA primarily contains electronic records consisting of articles; invitations; emails setting up phone calls and lunches; a Statement of Administration Policy regarding H.R. 1257; and a press release, Q and A, talking points, and agreement related to the Principles and Guidelines Regarding Private Pools of Capital. These emails are mainly between Kathleen Casey and Keith Hennessey or Bryan Corbett.

System of Arrangement

The materials in FOIA 2014-0365-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – George W. Bush Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.
