#### **Extent**

13 folders, approximately 462 pages / 216 assets

#### **Access**

Collection is open to all researchers. Access to George W. Bush Presidential Records is governed by the Presidential Records Act (PRA) (44 USC 2201) and the Freedom of Information Act (FOIA) (5 USC 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

#### **Scope and Content**

The materials in FOIA 2014-0378-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2014-0378-F requested materials related to Laura Unger, SEC Acting Chairman from February 12, 2001 to August 3, 2001.

This FOIA primarily contains correspondence, correspondence tracking sheets, fax transmittal sheets, routine memoranda, and press releases. These materials consist of correspondence to President George W. Bush and Andy Card from individuals and organizations including meeting requests, requests for assistance, and invitations. Included are articles, press releases, and reports sent from organizations. Additionally, a 2002 report on Sudan from the U.S. Commission on International Religious Freedom is present. Also covered is correspondence with Laura Unger,

SEC Chairman, regarding the long-term lease of property, the transmittal of reports from the SEC and Securities Investor Protection Corporation, and a White House tour request. In addition, one will find routine memoranda, orders, and press releases regarding the designation of Laura Unger as Acting Chairman of the SEC and also the transmittal of her resignation from the SEC.

The electronic records in this FOIA consist of news clippings, newsletters, correspondence confirming the President's appointment of Laura Unger as Acting Chairman of the SEC, invitations to public events, summaries of upcoming Congressional activities, phone lists, talking points, excerpts of the Congressional Record related to the No Child Left Behind Act, comments from interest groups on proposed regulations, scheduling proposals for photographs with the President, routine administrative correspondence, and routine correspondence about the resignation of government officials.

### **System of Arrangement**

The materials in FOIA 2014-0378-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – White House Office of Records Management (WHORM) Subject Files, Staff Member and Office Files, and George W. Bush Presidential Electronic Records.

WHORM Subject Files are processed at the document level.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category. A complete listing of the subject categories including a detailed description of each category is available in our research room and on our website at [www.georgewbushlibrary.smu.edu](http://www.georgewbushlibrary.smu.edu)

Staff Member and Office Files are maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Staff Member and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.
