FOIA 2017-0069-F requested materials containing the term "350ppm" or "350 ppm" between December 13, 2007 and January 20, 2009.

This FOIA primarily contains articles, published reports, newsletters, congressional testimony, CRS reports on climate change and the environment, presentations by Dr. Robert C. Marlay from the Department of Energy before the National Academy of Sciences in 2008 and 2009, and public comments regarding Corporate Average Fuel Economy (CAFE) standards.

Please note that a portion of classified records related to this request has not yet been processed. Additional records will be provided as they become available.

System of Arrangement

The materials in FOIA 2017-0069-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – George W. Bush Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House’s electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.
