Scope and Content

The materials in FOIA 2017-0145-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2017-0145-F requested materials related to the nomination and appointment of Neil M. Gorsuch.

This FOIA primarily contains correspondence, meeting agendas, resumes, routine vetting reports, routine personnel forms, and news clippings. These materials are from the White House Office of Records Management Subject Files, White House Counsel's Office, and White House Office of Presidential Personnel and consist of routine correspondence and resumes to and from Gorsuch about employment opportunities within the administration; resumes from the Office of

Presidential Personnel for potential judicial branch positions; and meeting agendas, resumes, and candidate reports about nominees from White House Judicial Selection Committee meetings with President Bush.

Electronic records consist of emails to and from Neil Gorsuch discussing appointments, resumes and paperwork pertaining to Mr. Gorsuch's employment, and WAVES (Worker and Visitor Entry System) records of Mr. Gorsuch's visits to the White House. Additionally, lists, spreadsheets, and reports tracking the progress of administration nominees, and emails from discussing Mr. Gorsuch's qualifications for administration positions are present. Also included are administrative emails regarding nominations and appointments, talking points regarding Presidential nominees and the nominations process, as well as biographies of Presidential nominees, and news articles. These electronic records are from the Exchange Email, Exchange Restored 40 Days, Worker and Visitor Entry System (WAVES), RNC Personal Storage Table (PST), and WHO Shared Drive Search and Access Sets.

System of Arrangement

The materials in FOIA 2017-0145-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – White House Office of Records Management (WHORM) Subject Files and Alpha Files, Staff Member and Office Files, and George W. Bush Presidential Electronic Records.

WHORM Subject and WHORM Alpha Files are processed at the document level.

The WHORM Alpha File was compiled by the White House Office of Records Management and is a series of documents arranged by name of persons, organizations, or events.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category. A complete listing of the subject categories including a detailed description of each category is available in our research room and on our website at www.georgewbushlibrary.smu.edu

Staff Member and Office Files are maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Staff Member and Office Files are usually processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. Due to the high-profile and expedited nature of this particular FOIA request, textual records were processed at the document level.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records

captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.
