#### Scope and Content

The materials in FOIA 2018-0080-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2018-0080-F requested materials from the National Security Council related to meeting minutes and correspondence regarding meetings between President George W. Bush and First Vice President of Sudan Salva Kiir, which occurred on July 20, 2006, November 15, 2007, and January 5, 2009.

This FOIA primarily contains NSC Profile Sheets, routing forms, routine printed e-mails, routing memoranda, fax cover sheets, night notes summaries, meeting participant lists, press statements, press points and drafts thereof, and scheduling materials for visits by Salva Kiir, other members of the Sudanese government, and members of the Darfur Action Group. Included are letters from Congress and the public regarding the situation in Darfur and Sudan.

It should be noted that many of the documents in this FOIA have been closed due to National Security classification and/or exemptions of the Freedom of Information Act.

#### System of Arrangement

The materials in FOIA 2018-0080-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – Staff Member Office Files.

Staff Member Office Files are maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Staff Member Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.
