**Biographical History:** Prior to his service in the George W. Bush Administration, Philo D. Hall worked in the Congress as a Health Policy Aide with the U.S. Senate Committee on Health, Education, Labor and Pensions. He held this position from 1997-2001, and was involved in legislation related to insurance regulation, health information privacy, and Medicare provider reimbursement.

During the George W. Bush Administration, Mr. Hall served as an Associate Director on the Domestic Policy Council, where he advised on health care issues. He held this position from 2001-2005, when he joined the Department of Health and Human Services as a Counselor to the Secretary.

After leaving the Department of Health and Human Services in 2008, Mr. Hall studied law at the Catholic University of America, Columbus School of Law, and graduated in 2012 with a JD.

**Scope and Content Note:** Philo D. Hall's records consist of material related to health and health care issues. These materials date primarily from 2001-2005, although some research and reference materials were produced or published in the late 1990s. Only the Printed Materials series is currently processed and available for research. It contains published materials and reports used for reference and background information on policy issues.

This collection is only partially processed and some boxes may be unavailable for research.

**System of Arrangement:** Philo D. Hall's records are arranged into four sub-series: Subject Files, Briefing Books, Printed Materials, and Notebooks. All sub-series are thereunder arranged alphabetically by folder title. Only the Printed Materials have been processed at this time.

**Related Collections:** Philo D. Hall's Domestic Policy Council records contain three additional unprocessed sub-series: Subject Files, Briefing Books, and Notebooks. These sub-series contain an additional 9 linear feet, 2 linear inches of material. These records are also currently unprocessed.
