#### **Scope and Content**

The materials in FOIA 2018-0263-F[24] are a selective, not necessarily all inclusive, body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 2018-0263-F[24] requested previously unprocessed materials related to emails sent or received by Brett Kavanaugh referencing pregnan\* between July 2003 and May 2006.

This FOIA primarily contains draft remarks, administrative emails, news articles, draft messages, meeting information, briefing papers, comments on news articles regarding Judge John Roberts, and information concerning previous Supreme Court nominees and questions asked during hearings. Additionally, there are agendas, briefing slides, and meeting information for September

19, 2005 and September 20, 2005 meetings regarding Hurricanes Katrina and Rita. Records from this segment date from May 4, 2005 to September 20, 2005.

### **System of Arrangement**

The materials in FOIA 2018-0263-F[24] are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – George W. Bush Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.

Pregnan Exchange\_3b contains 164 assets, of which 84 are released in full, 33 are withheld in part, and 47 assets are withheld in full.
