# Records on Correspondence between White House Staff and Employees of Koch Industries

### Extent

10,131 assets

### Access

Collection is open to all researchers. Access to George W. Bush Presidential records is governed by the Presidential Records Act (PRA) (44 USC 22, as amended) and the Freedom of Information Act (FOIA) (5 USC 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

### Copyright

Records in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Researchers are advised to consult the copyright law of the United States (Title 17, USC) which governs the making of photocopies or other reproductions of copyrighted material.

### Provenance

Official records of George W. Bush's presidency are housed at the George W. Bush Presidential Library and are administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

### Scope and Content

The materials in FOIA 2014-0396-F[1] are a selective, not necessarily all inclusive, body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 2014-0396-F[1] requested correspondence between staff of the George W. Bush administration and employees or representatives of Koch Industries.

The first segment of this FOIA primarily contains electronic newsletters sent out by various White House offices, news articles, published reports, fact sheets, Press Pool reports, emails arranging White House tours for employees of Koch Industries and their families, personnel discussions regarding individuals who were selected for employment in the George W. Bush administration, informal policy discussions between White House staff and Koch employees,

scheduling of business meetings and lunches, and visitor log entries. The first segment of this FOIA contains emails sent from January 20, 2001 to June 30, 2004.

### **System of Arrangement**

The materials in FOIA 2014-0396-F[1] are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – George W. Bush Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.

The following is a list of electronic search results lists (SRLs) processed in response to FOIA 2014-0396-F[1]:

#### ***George W. Bush Electronic Records***

ARMS 2001 contains 2,031 assets, of which 353 are released in full, 73 are withheld in part, and 1,605 are withheld in full.

ARMS 2002 contains 1,369 assets, of which 46 are released in full, 77 are withheld in part, and 1,246 are withheld in full.

ARMS 2003 contains 864 assets, of which 315 are released in full, 39 are withheld in part, and 510 are withheld in full.

ARMS 2004 contains 29 assets, of which 6 are released in full, 8 are withheld in part, and 15 are withheld in full.

Exchange 2002 contains 10 assets, of which 10 are withheld in full.

Exchange 2003 contains 2,780 assets, of which 456 are released in full, 440 are withheld in part, and 1884 are withheld in full.

Exchange 2004 contains 2,004 assets, of which 149 are released in full, 60 are withheld in part, and 851 are withheld in full.

RNC\_PST 2001 contains 1,353 assets, of which 56 are withheld in part, and 1,297 are withheld in full.

RNC\_PST 2002 contains 280 assets, of which 20 are withheld in part, and 260 are withheld in full.

RNC\_PST 2003 contains 334 assets, of which 76 are released in full, 98 are withheld in part, and 160 are withheld in full.

RNC\_PST 2004 contains 19 assets, of which 1 are withheld in part, and 18 are withheld in full.

WAVES contains 2 assets, of which all are withheld in part.
