Bush Presidential records is governed by the Presidential Records Act (PRA) (44 USC 22, as amended) and the Freedom of Information Act (FOIA) (5 USC 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

Copyright

Records in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Provenance

Official records of George W. Bush's presidency are housed at the George W. Bush Presidential Library and are administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

Scope and Content

The materials in FOIA 2016-0027-F are a selective, not necessarily all inclusive, body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 2016-0027-F requested materials related to the conversation between President George W. Bush and Sudanese President Omar al-Bashir on May 1, 2006.

This FOIA primarily contains the Presidential Daily Diary for May 1, 2006 as well as background information for compiling the diary such as schedules, call and movement logs, a trip book, website printouts of remarks and photos, event memoranda, administrative emails, a press briefing, and visitor appointment information. Electronic records consist of transcripts of a conference call on Sudan, draft remarks by Steve Hadley at the African Growth and Opportunity

Act (AGOA) forum and background material, and a memorandum and administrative emails regarding the telephone call on May 1, 2006.

Please note that a portion of classified records related to this request has not yet been processed. Additional records will be provided as they become available.

System of Arrangement

The materials in FOIA 2016-0027-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – Staff Member Office Files and George W. Bush Presidential Electronic Records.

Staff Member Office Files are maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Staff Member Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.

The following is a list of electronic search results lists (SRLs) and folders processed in response to FOIA 2016-0027-F:

George W. Bush Electronic Records

Exchange contains 82 assets, of which 59 are released in full, 0 are withheld in part, and 23 are withheld in full.

Exchange_2 contains 53 assets, all of which are released in full.

NSC contains 9 assets, all of which are released in full.

WHO contains 1 asset, which is released in full.

WHO_2 contains 2 assets, of which 1 is released in full and 1 is withheld in part.
