Bush or his staff and Vicente Fox, Felipe Calderón, Patricia Espinosa, Eduardo Medina-Mora Icaza, E. Gen. Francisco Armando Meza Castro, Adm. Raul Santos Galvan Villanueva, Facundo Rosas, and Arturo Sarukhan regarding the Merida Initiative.

This FOIA primarily contains emails to and from Arturo Sarukhan regarding meetings related to the Merida Initiative and United States legislation on the Merida Initiative in 2008, and a press statement by Mexico's Secretary of the Interior Juan Camilo Mouriño Terrazo.

Please note that a portion of classified records related to this request has not yet been processed. Additional records will be provided as they become available.

System of Arrangement

The materials in FOIA 2016-0260-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – George W. Bush Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.
