Scope and Content

FOIA 2020-0192-F requested materials related to Secretary of Defense Donald Rumsfeld and speechwriter Justin Walker from 2005 to 2006.

This FOIA primarily contains organization charts, background information for a tribute, emails between Justin Walker and Joseph Kildea, and emails discussing remarks between Justin Walker and John McConnell.

Please note that a portion of classified records related to this request has not yet been processed. Additional records will be provided as they become available.

System of Arrangement

The materials in FOIA 2020-0192-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – George W. Bush Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.

The following is a list of electronic search results lists (SRLs) processed in response to FOIA 2020-0192-F:

George W. Bush Electronic Records

Exchange contains 38 assets, of which 27 are released in full, 4 are withheld in part, and 7 are withheld in full.

Exchange - 40 Days contains 4 assets, of which 1 is released in full and 3 are withheld in part.

RNC contains 15 assets, of which 1 is released in full, 0 are withheld in part, and 14 are withheld in full.
