Scope and Content

The materials in FOIA 2018-0263-F[27] are a selective, not necessarily all inclusive, body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 2018-0263-F[27] requested previously unprocessed materials related to emails sent or received by Brett Kavanaugh referencing Roe between July 2003 and May 2006.

This FOIA primarily contains draft speeches, telephone call script drafts, draft talking points, draft and final reports, weekly legislative reports, cabinet reports, briefing papers, draft lists of acknowledgements, schedules, transcripts, email messages, and news articles. Records in this segment include blog posts and news articles discussing possible candidates for the Supreme

Court of the United States, a transcript of Brett Kavanaugh's nomination to the DC Circuit court before the United States Senate Committee on the Judiciary in 2004, and Brett Kavanaugh's written responses to questions from United States Senators following his DC Circuit court nomination. Records from this segment date from July 2003 through July 2005.

System of Arrangement

The materials in FOIA 2018-0263-F[27] are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – George W. Bush Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.

George W. Bush Electronic Records

Roe ARMS contains 13 assets, of which 12 are released in full, 0 are withheld in part, and 1 is withheld in full.

Roe Exchange_1 contains 189 assets, of which 162 are released in full, 0 are withheld in part, and 27 are withheld in full.

Roe Exchange_2 contains 71 assets, of which 44 are released in full, 14 are withheld in part, and 13 are withheld in full.

Roe 33 Days contains 2 assets, of which 1 is released in full, 0 are withheld in part, and 1 is withheld in full.

Roe 40 Days contains 7 assets, of which 6 are released in full, 0 are withheld in part, and 1 is withheld in full.
