#### Scope and Content

The materials in FOIA 2019-0217-F are a selective, not necessarily all inclusive, body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 2019-0217-F requested photographs by Eric Draper of President George W. Bush on November 19, 2008 and December 3, 2008 at specific times.

This FOIA primarily contains photographs of President George W. Bush arriving to Ft. Drum on December 3, 2008, viewing static displays, greeting troops and their families, and delivering remarks to a large audience. Photographs also show troops deploying from helicopters and an artillery gun demonstration. Photographs from November 19, 2008, include President George W. Bush and Mrs. Laura Bush visiting the Smithsonian National Museum of American History, President Bush delivering remarks, and returning to the White House.

### **System of Arrangement**

The materials in FOIA 2019-0217-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – George W. Bush Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program.
