As of 09/25, Health and Human Services reported 49,423 total patients treated. - The Radio tower for Jefferson Parish Sheriff's Office was delivered 9/24 and is pending a site inspection.
- Cruise ships with evacuees that departed New Orleans may be returning to port earlier than anticipated, necessitating restoration of phone service.
- Mobile Emergency Response System (MERS) will be bringing out an Inmarsat satellite phone system for St. Bernard Parish, LA.

**Hurricane RITA**

- Generators in support of telecommunications continue to be a heavy requirement.
- The Houston Astrodome been designated as staging area for telecommunications crews and trucks.
- Industry monitoring the fuel situation as many sites are on generator backup.
- 5 Joint Communications Support Teams assisting with restoration efforts have reported to the Houston Astrodome and are under State control for future travel.
- The NCS provided 127 Globalstar satellite phones to the State of Texas for distribution to State and local authorities working in the disaster area. The State will receive a total of 200 satellite phones to aid in response work.
- ESF-2 Baton Rouge contacted to procure calling cards for displaced persons and will coordinate action with EFS-7 as required.
- Carriers begun initial assessments in affected areas.

Commercial power fluctuation makes it difficult to provide accurate outage data at this time.

**ESF-3 Public Works and Engineering**

**Status: Activated**

**Hurricane KATRINA**

**General (Katrina/Rita):**

2,731 US Corps of Engineers (USACE) personnel and 18 Prime Power soldiers supporting Katrina. Teams and contractors assigned to Katrina operations that took protective measures for the landfall of Rita and are in the process of returning.

**Task Force Un-watering Commander's Assessment:**

The pump station infrastructure in place before Hurricane Rita remains operable and should be back to pre-Rita un-watering operations in 3-5 days.

Orleans Parish: Work continues at the overtopped sites along the Inner Harbor Navigation Canal (IHNC). On the east side of the canal, several helicopters dropped sandbags to stop the flow of water into the Ninth Ward throughout the day. The water was nearly cut off as of the last report. ESF-3 is repositioning temporary pumps to Pump Station 5 to help evacuate the water. Pump Stations 1 and 6 in St. Bernard Parish will pump out most of the water.

East Orleans: Returned to pre-Rita operations. Focus remains removing water from the Six Flags area. ESF-3 is moving two 30-inch portable pumps from St. Charles Pump Station to the Ninth Ward.

St. Bernard Parish: Pump Stations 1 and 6 continue to bear the brunt of removing water from Chalmette and the Ninth Ward and continuing operations there are the focus for this parish. Successful temporary repairs of the back levee before the storm were a key to protecting the parish from a second total disaster.

Plaquemines Parish: ESF-3 is delivered a total of eight truckloads of sandbags from the Coast Guard station near the 17th Street Canal to the parish over the last 24 hours. Work to reinforce the parish levees is ongoing.

The Animal and Plant Health Inspection Service (APHIS) Incident Management Team (IMT) in Mississippi reports that Animal supply deliveries have been hampered. There are 10 established distribution centers identified by MS Extension Service. Mississippi Cooperative Extension will house agricultural supplies until producers are able to handle deliveries/pick up.

US Department of Agriculture (USDA) has assisted Texas in preparation of Food Stamp Program waivers in anticipation of what might be needed.

USDA has worked with Texas to assess commodity and infant food inventories in order to redirect and purchase commodities as needed.

Inventories within Texas and surrounding States have been identified and are being pre-positioned for deployment into affected areas. Specifically, orders are being processed for household size commodities (rice, fruits, vegetables, meats, juices, cereal, and ultra-high temperature (UHT) milk) for Houston, Dallas, San Antonio, Austin, Ft. Worth, Lubbock, Beaumont, and Tyler to replace depleted inventories from Texas' service to Katrina evacuees and institutional size commodities for anticipated congregate feeding sites in Houston, Dallas, San Antonio, Austin, Ft. Worth, Lubbock, and Beaumont.

2.3 million lbs. of food are on the road to Dallas, Austin and San Antonio.

7.5 million lbs. have been purchased and are on standby for delivery by 9/30.

5.4 million lbs. will be purchased next week to address new needs.

USDA has approved the Texas Special Supplemental Nutrition for Women Infants and Children (WIC) Program to provide ready-to-feed (RTF) infant formula (single serve bottles with nipples) to meet the needs of babies displaced by Rita.

The Special Supplemental Nutrition for Women Infants and Children (WIC) Program has been extended to Rita evacuees.

The Animal and Plant Health Inspection Service (APHIS) ability to perform critical mission functions in LA and TX are suspended. In MS, they are limited due to inaccessible areas and response priorities.

APHIS working closely with the TX Animal Health Commission (TAHC) and other State, local and private organization partners in TX to support damage assessments of animal-related facilities, animal sheltering efforts, carcass disposal activities, and veterinary medical treatment. All efforts being coordinated with the State Operations Center and TAHC's headquarters in Austin.

APHIS Wildlife Services provided some limited support to search and rescue efforts following Hurricane RITA; using boats and four personnel.

The Natural Resource Conservation Service (NRCS) in TX received very few reports of downed poultry houses. Concern is with fuel for emergency generators, delay in power restoration and feed and water for birds.

NRCS Emergency Watershed Protection Program assessments in TX hampered due to downed timber; assessments will begin when accessibility is established. The program manager currently working with Governor Perry and the TX Department of Emergency Management

NRCS in TX currently working with the Texas Department of Emergency Management and will staff two workstations at the Joint Field Office.

There are 12 NRCS TX watershed project areas in hurricane RITA affected areas. Assessments will proceed as accessibility improves.

- Tropical Depression Rita was located near 80 miles North Northwest of Indianapolis, IN.
- The Depression is now moving North Northeast at 30 mph and expected to continue.
- Tropical Depression Rita will weaken and become absorbed by a frontal wave later this morning.

# Hurricane Rita

## ■ Current Situation:

- Hurricane Rita made landfall as a Category 3 Hurricane at 230 AM CDT on September 24. The center came ashore on the extreme Southwest Coast of Louisiana between Sabine Pass, Texas and Johnson's Bayou, Louisiana.
- No deaths directly resulting from the hurricane have been reported.
- Aerial reconnaissance and assessments were completed in Texas. There was minimal damage noted in the impact area.
- The Trinity River Authority requested activation of the emergency alert system to broadcast a mandatory evacuation for portions of Polk, San Jacinto, and Liberty Counties, below Lake Livingston Dam, in the East area of Houston, TX. Emergency releases from the dam will cause rapid rises below the dam on the Trinity River.
- Generators purchased for delivery are en-route to Beaumont, TX.
- 775,298 customers are without power in Texas; 80% power restoration is expected by Tuesday or Wednesday.
- NDMS, HHS, ESF 1, DOD, Veterans Administration and the State are coordinating to develop a plan to return evacuated patients.
- American Red Cross began serving hot meals in Texas on September 25.
- No signs of significant damage to petro-chemical facilities with 3 to 5 days to return to full production.
- American Red Cross reports 297,749 evacuees housed in “transient accommodations” (hotels, motels, etc.).

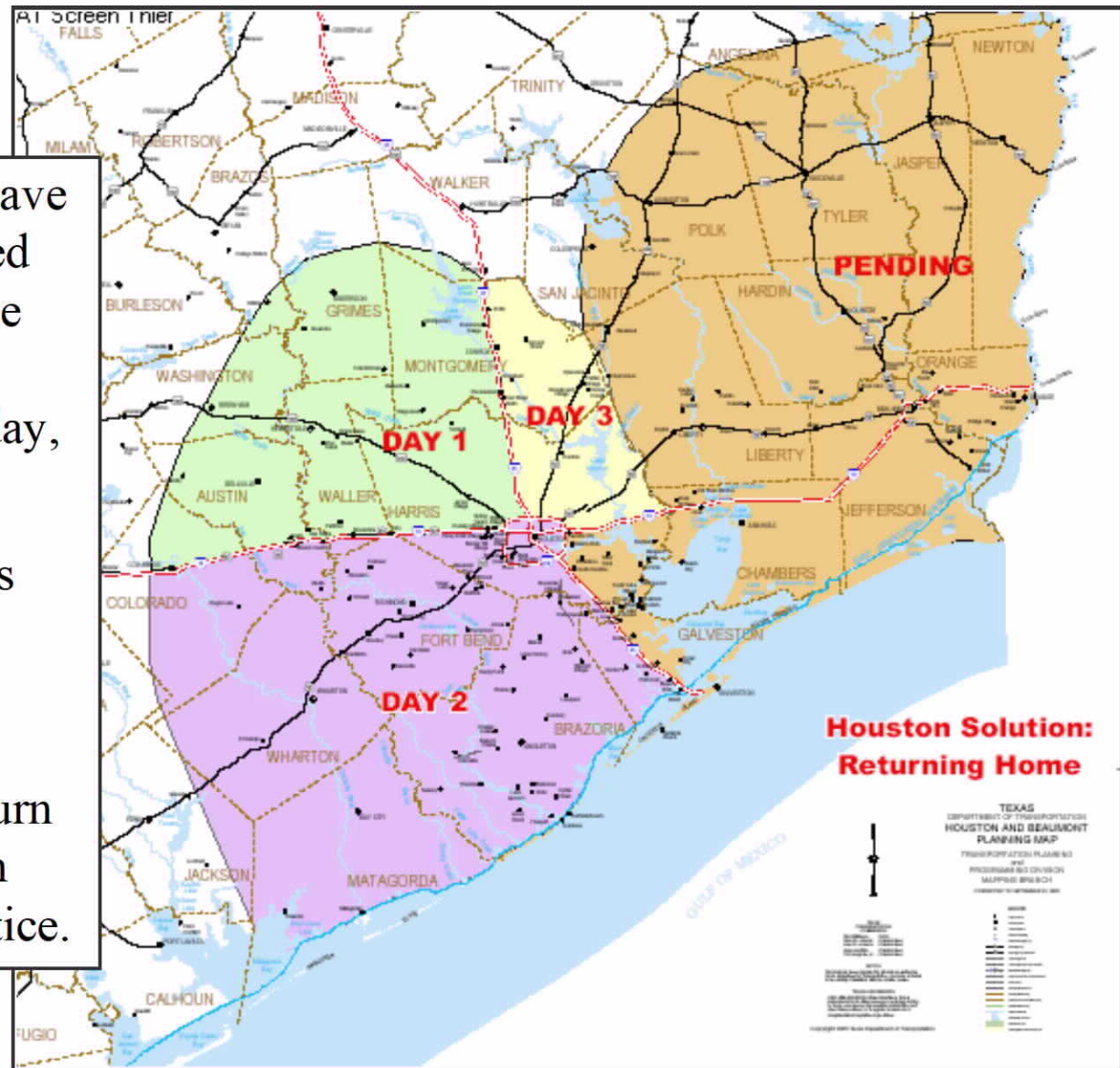
## ■ Situation Summary:

- Federal Disaster Declared for Texas: (DR-1606-TX) for counties of Chambers, Galveston, Hardin, Jasper, Jefferson, Liberty, Newton, Orange, and Tyler.
- The “Fuel Farm” concept plan was modified and is being implemented by Texas Department of Transportation (TXDOT). TXDOT is supported by the Texas National Guard and is providing gas to all responders.
- 2.7 million evacuees need to be returned to an area from Corpus Christi to Beaumont.
- National Disaster Medical System, Health and Human Services, ESF 1, DOD, Veterans Administration, and the State are coordinating to develop a plan to return evacuated patients.
- Texas plans a 7-day re-entry operation, but power will need to be restored first.
- Significant traffic delays reported as evacuees begin to return to coast areas.
- Authorities ask residents not to return until areas are cleared for re-occupation.
- 12,500 special needs patients who were evacuated will stay where they are until Texas National Guard develops a plan to return them.
- No reports of significant damage to petrochemical refineries in Houston, Beaumont/Port Arthur, or Galveston.
- South Texas Project nuclear facility reports as operating normally.
- I-10 exits from the Texas state line to Iowa, Louisiana are closed until damage in Calcasieu and Cameron parishes is assessed.



# Houston, Texas – Return Map

- State officials have planned a phased return during the next 7 days, beginning Sunday, September 25.
- However, Texas Department of Transportation strongly discourages return trips to Houston until further notice.

# Hurricane Rita - Louisiana

## ■ Situation Summary

- Federal Disaster Declared for Louisiana (DR-1607-LA). Includes parishes of Cameron, Calcasieu, Beauregard, Vermilion, and Jefferson Davis.
- Flooding reported in all areas South of I-10.
- USCG report 600+ people rescued in Louisiana; rescues continued in Vermillion Parish today.
- Significant traffic delays as residents begin to return to evacuated parishes.
- City of Lake Charles has reported major wind damage and flooding.
- All major airports in the Louisiana coastal areas are operating normally or with minor delay with the exception of Lake Charles Regional Airport.
- Main terminal and hangar facilities damaged at Lake Charles Regional Airport.
- Major road closures in Calcasieu Parish (Lake Charles area).
- New Orleans levees:
  - Three breaches or overtopping of the levees secured on the east side of the IHNC, near St. Bernard Parish/9th Ward, New Orleans.
  - 3,000- to 7,000-pound sandbags are being dropped into the 25 to 30-foot gap where water still flowed into the evacuated Lower Ninth Ward.
- 36,299 Individual Assistance registrations have been received.

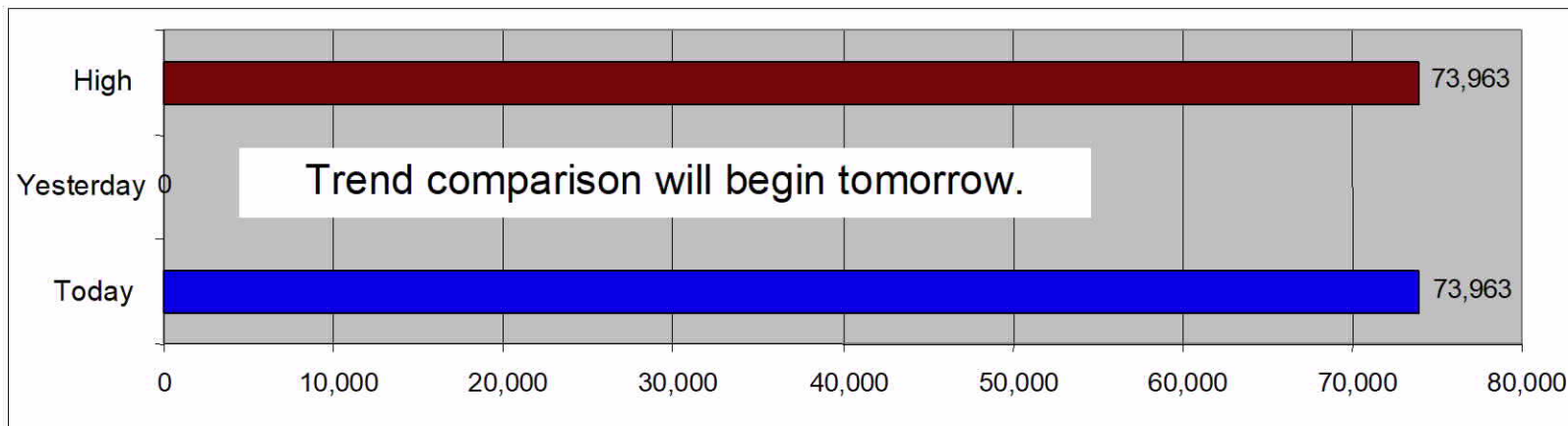

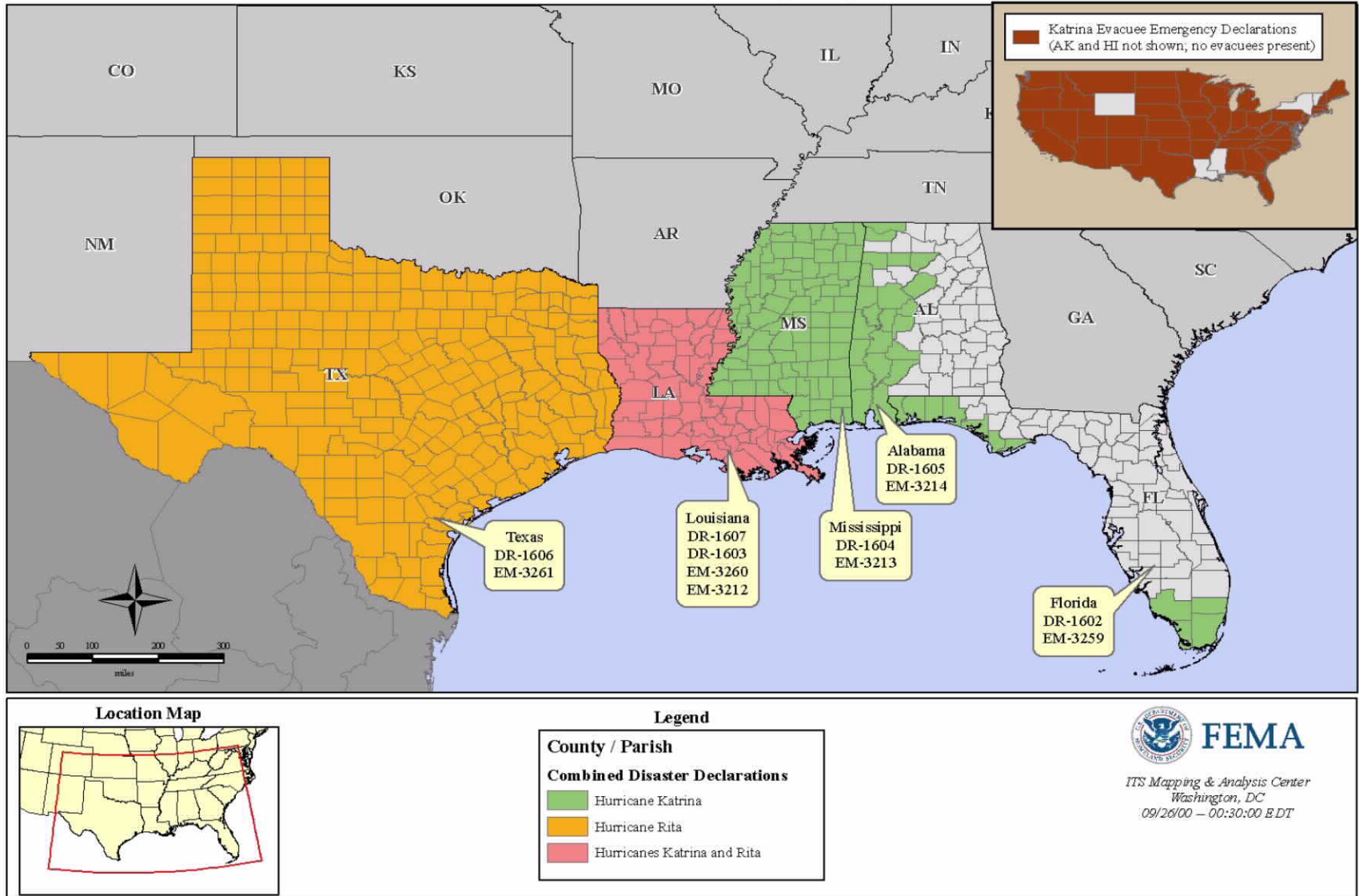

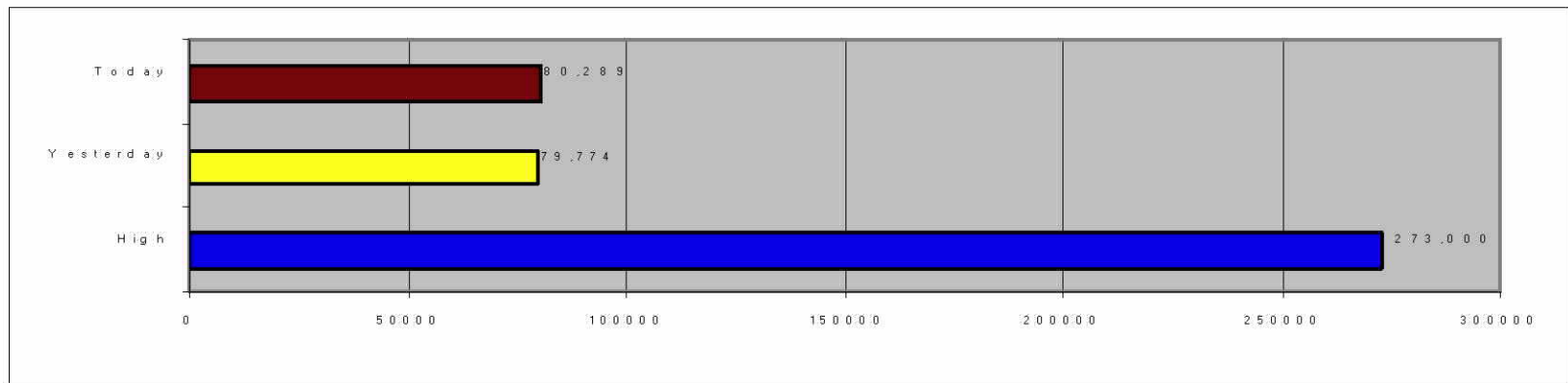

# Department of Defense

- Hurricane Rita
  - 6,876 Active Duty and National Guard personnel are deployed to support relief operations in Texas.
    - 623 Active Duty
    - 6,253 Texas National Guard
  - 169 helicopters and 38 fixed wing aircraft are available for search and rescue, evacuation, and aero-medical evacuation.
  - Evacuated 3,263 people (1,290 medical patients and 1,373 ambulatory/elderly evacuees, and an additional 600 passengers) from Houston and Beaumont, Texas, and Lake Charles, Louisiana to 9 locations in 8 States. Over 40 sorties were flown by a mix of C-130, C-5 and C-17 aircraft.
  - Substantial communications assets have been approved for support of relief operations.
  - DOD is providing personnel for distribution of ice, water, food, medical supplies; logistical planners; temporary bridging; boat salvage and channel clearing ships; debris removal equipment; and medical personnel to staff field hospitals.



# Department of Defense

- Hurricane Katrina
  - 46,171 Active Duty and National Guard personnel are supporting relief operations.
    - 11, 518 Active Duty
    - 33,073 National Guard
  - 64 helicopters in Louisiana and Mississippi.
  - 45 airplanes are deployed to assist in response efforts.
  - 13 mortuary affairs teams from the 54th Quartermaster Company are in New Orleans supporting mortuary affairs at the New Orleans Convention Center.
  - 17 sorties for mosquito abatement have been flown to date in Southern Louisiana; total of 1,125,139 acres have been treated.
  - 10 ships are currently in the area: 6 Navy (USS IWO JIMA, USS Shreveport, USNA COMFORT, USS TORTUGA, AND USNS PATUXENT) and 4 Coast Guard ships.
  - 1 Military Veterinary Medical Support Team with 44 personnel was approved to deploy and provide support to Louisiana.
  - Louisiana Governor requested Department of Defense (DOD) be prepared to provide an additional 15,000 federal troops and shelter for up to 100,000 persons.





# Emergency Management Assistance Compact (EMAC)

    - Alabama filled a request for 2 Hemmit fuel trucks to assist in ground refueling operations for transportation assets returning to evacuated areas.

    - EMAC assistance requests may pick up as parishes are inspected for further damage.

    - Minnesota filled a request for Public Information Officers (PIOs).
    - Operations returned to the Joint Field Office on September 25.



# Emergency Support Functions (ESFs)

- **ESF 1 Transportation**

- Hurricane Rita

- Survey crews began assessing the Ports of Houston, Galveston, Texas City, and Freeport for damage on September 25.
    - The Ports will not be opened to vessels until the assessments are completed.
    - The Federal Railroad Administration, at FEMA's request, is investigating whether railroad refueling services in Louisiana could provide supplies to meet fuel needs.
    - Evacuees are encouraged not to return to Beaumont, Jefferson, or Orange County, Texas until they are declared safe.
    - The State of Texas plans a phased return of evacuees to ensure an adequate supply of fuel, food, and water on return routes.

- Hurricane Katrina

- Maritime Administration evaluating additional resources for chartering of commercial vessels to meet FEMA mass housing requirements.





# Emergency Support Functions (ESFs)

- **ESF 2 Communications**

- Hurricane Rita

- Houston Astrodome has been designated as a staging area for telecommunications repair crews and trucks.
    - Coordinating procedures for telecom industry representatives into restricted areas, to include staging areas; providing FEMA letter authorizing access in to restricted areas.
    - Shared Resources HF Radio Program (SHARES) activated 24 hour operations and 139 stations are participating.

- Hurricane Katrina

- Communications carriers continue assessments and restorations to the extent possible, however accessibility issues continue to impede efforts in certain areas.
    - 4 satellite communications vehicles being deployed to Disaster Recovery Centers (DRC) in Mississippi; continuing to monitor reallocation of 6 satellite communication solutions as other DRCs are established.
    - Providing communications support to parishes in southeastern Louisiana where restoration has been hampered by flooding.



# Emergency Support Functions (ESFs)

- **ESF 3 Public Works and Engineering**
  - Hurricane Rita
    - A toll-free hotline (888-721-0905) is being established to handle queries from counties regarding debris removal.
    - Fixing damaged New Orleans levees
      - Work continued at the overtopped breach sites along the Inner Harbor Navigational Channel (IHNC).
        - On the east side, sandbags were dropped to stop the flooding into the 9<sup>th</sup> Ward. Temporary pumps were repositioned to Pump Station 5 to assist removing water. Pump Stations 1 and 6 will remove most of the water in Chalmette and the 9<sup>th</sup> ward.
        - On the west side, HESCO bastions (prefabricated, multi-cellular wall systems) and rocks are being used to increase elevation of the levee.
      - Plaquemines Parish: Work to reinforce the levees with sandbags is ongoing.





# Emergency Support Functions (ESFs)

- **ESF 4 Firefighting**

- Hurricane Rita

- An Incident Management Team (IMT) will operate a base camp for hurricane evacuees at the Reliance Center in Houston, Texas.
    - An IMT has been ordered to coordinate the emergency management zone around Houston, TX.
    - An IMT accepted transfer of command of the San Antonio, TX base camp on September 25.
    - An IMT is expected to report to the National Forests in Texas. Damage assessments are pending both in National Forests of Texas and the Kisatchie National Forest in Louisiana.

- Hurricane Katrina

- An IMT is en route to Mississippi to relieve the current IMT and assume command of the Stennis Space Center.



# Emergency Support Functions (ESFs)

- **ESF 6 Mass Care, Housing, Human Services**

- Hurricane Rita

- The first meals were served on September 25 in Texas by the Southern Baptist Convention (SBC); SBC kitchens have the capacity to serve 100,000 meals daily.
    - American Red Cross (ARC) kitchens should be operational tomorrow in Texas.
    - ARC kitchens will be staged in fixed feeding locations with drive-by pick up capability to make best use of limited resources.
    - ARC will expand to mobile feeding as resources become available.

- Hurricane Katrina

- All 14 SBC kitchens are serving meals in Louisiana as of September 25.

- **ESF 7 Resource Support**

- Hurricane Rita

- 185 ambulance units are confirmed arrival to Reliant Stadium in Texas.



# Emergency Support Functions (ESFs)

- **ESF 8 Public Health and Medical**

- Hurricane Rita

- Total patients treated: 205; total personnel in the field: 482
    - The National Disaster and Medical System (NDMS), Health and Human Services, Department of Defense, and the Veterans Administration are working with the states on a joint plan to return evacuated patients.
    - Deployed 40 mental health workers to provide clinical services to evacuees in Houston, TX and San Antonio, TX shelters.
    - Federal Medical Shelters are ready to deploy if requested.

- Hurricane Katrina

- Total patients treated: 49,423; total personnel in the field: 644
    - NDMS will return to pre-Rita operations and staffing in affected areas on September 26.
    - Continuing to provide mental health clinical services to first responders and their families housed on 2 Carnival cruise ships in New Orleans.





# Emergency Support Functions (ESFs)

- **ESF 9 Urban Search and Rescue**

- Hurricane Rita

- 3 Task Forces moved from staging in Houston, TX to Lake Charles, LA and are staged at the Burton Coliseum in Lake Charles in Calcasieu Parish.
    - 1 Incident Support Team is planning to move to Lake Charles.
    - State of Texas expects that they will not need any Federal Urban Search & Rescue (US&R) resources, but plan on making final determination on September 26.

- Hurricane Katrina

- Performed secondary searches on a total of 15,801 occupancies have been cleared out of an anticipated total of 22,000. The IST advises that they expect secondary search and rescue operations to continue at least through next weekend.



# Emergency Support Functions (ESFs)

- **ESF 10 Oil/Hazardous Materials**

- Hurricane Rita

- Anticipate moderate need for salvage and pollution response capability, particularly in Port Arthur, TX and Lake Charles, LA.
    - Surveillance flights in Port Arthur, TX and Beaumont, TX show damage to numerous facilities and one small sheen in the Neches River in East Texas.
    - Rapid Needs Assessment (RNA) teams noted a vapor and liquid release from a tank in a Nederland facility. Materials are suspected to be liquid nitrogen and oxygen.
    - RNA also noted a significant oil spill east of Baytown, TX and a heavy sheen coming from underwater near an offshore platform.

- Hurricane Katrina

- All pollution response efforts will continue when safe in New Orleans, Louisiana.



# Emergency Support Functions (ESFs)

- **ESF 11 Agriculture and Natural Resources**

- Hurricane Rita

- The Animal and Plant Health Inspection Service (APHIS) is supporting animal and livestock rescue, damage assessments of animal-related facilities, sheltering efforts, carcass disposal, and veterinary medical treatment.
      - Approximately 10,000 livestock evacuated.
      - About 7,000 companion animals sheltered by care organizations.
    - The Food and Nutrition Service (FNS) is assisting Texas in preparing Food Stamp program waivers.
      - FNS is working with Texas to assess commodity and infant food inventories.
      - FNS approved the Texas Special Supplemental Nutrition for Women Infants and Children (WIC) Program to provide ready-to-feed infant formula.

- Hurricane Katrina

- APHIS personnel continue to support animal sheltering and care operations.
    - FNS continues to expedite services for displaced Katrina evacuees applying for the Child Nutrition and Special Supplemental Nutrition for WIC programs.





# Emergency Support Functions (ESFs)

- **ESF 12 Energy**

- Hurricane Rita

- ExxonMobil and Shell have announced that they will prioritize re-supplying and re-opening service stations along the primary evacuation routes in Texas.
    - The Strategic Petroleum Reserve reports that one of its four storage sites, Bill Hill, sustained minor damage. Another site, West Hackberry, has not been assessed yet due to flooding. The Bayou Choctaw site is still operating.
    - 775,298 customers are without power in Texas as of September 25.

- Hurricane Katrina

- Entergy Corporation, Entergy New Orleans, Louisiana Congressional Delegation, New Orleans City Council, and New Orleans Mayor Ray Nagin are coordinating to obtain direct assistance from the Federal government.
    - 689,519 or 41% of customers are without power in Louisiana; and 13,199 in Mississippi. Louisiana includes new customer outages due to Hurricane Rita as well as outages remaining from Hurricane Katrina.



# Emergency Support Functions (ESFs)

- **ESF 13 Public Safety/Security**

- Hurricane Rita

- 100 State Police Troopers were reassigned from New Orleans, LA to the western portion of Louisiana to support response operations.
    - Approximately 736 individuals were rescued in Louisiana parishes flooded by Hurricane Rita.
    - 400 security officers are available to protect American Red Cross sheltering and feeding operations.

- Hurricane Katrina

- 1,883 Federal Law Enforcement Officers representing 18 Federal agencies are deployed.

- **ESF 14 Long-Term Recovery and Mitigation**

- Recovery

- Hurricane Katrina

- FEMA and Housing and Urban Development (HUD) are working together to provide innovative housing solutions. HUD has a new housing voucher program which will allow eligible evacuees the flexibility to find housing for 18 months in cities and towns of their choice where housing is available.

- Mitigation Assessment Team will conduct field investigations and work closely with local and state officials in Louisiana, Mississippi, and Alabama to develop recommended improvements in building design and construction, code development and enforcement, and mitigation activities.

- **ESF 15 External Affairs**

- Hurricane Rita

- Promoting federal response assets emphasizing the federal/state partnership.
    - Fielding media inquiries regarding the Presidential emergency declarations for Texas and Louisiana for Hurricane Rita.
    - Promoting the daily response and recovery briefings from FEMA Headquarters and the Joint Field Offices (JFO) in Austin, Texas and Baton Rouge, Louisiana.

## ESF 15 External Affairs (con't.)

- Hurricane Katrina
  - Promoting the rollout of expedited transitional housing assistance, including a report on the early high-volume statistics and the importance of updating contact information.
  - Proactive outreach to multilingual and special needs communities regarding registration and assistance programs.
- Safety
  - Hurricane Rita
    - A medical clinic and counseling center was established for FEMA and other Federal agency employees at the Joint Field Office in Austin, Texas.
    - Disaster safety officers are in place at the clinic and counseling center.
    - Safety plans and programs are being established for FEMA and other Federal agency employees assigned in support of Hurricane Rita by Occupational Health and Safety Administration.
  - Hurricane Katrina
    - 6 response personnel staying in Baton Rouge, Louisiana were treated and released from the local hospital for carbon monoxide exposure. Safety will investigate the incident further.
