#### Scope and Content

The materials in FOIA 2014-0228-F are a selective, not necessarily all inclusive, body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 2014-0228-F requested materials sent to, sent by, or received by President Bush regarding the decision to fire Donald Rumsfeld / Rumsfeld resignation, the "surge," General David Petraeus, Blackwater, Erik Prince, Falluja/Fallujah, Nisour Square, civil war, sectarian violence, Iraq Study Group, James Baker, Jalal Talabani, Nouri al-Maliki, al-Qaeda in Iraq, Sunni Awakening, Battle of Basra, Mehdi Army, Muqtada al-Sadr, Ayman al-Zawahiri, Coalition Provisional Authority, L. Paul Bremer, Ba'ath Party, and de-Ba'athification, from April 2003 - January 2008.

This FOIA primarily contains records between April 2003 and January 2008 and includes correspondence, White House memoranda, speech drafts, reports, and scheduling files. The bulk of the records consist of speech drafts from the Office of the Staff Secretary and scheduling files from the White House Office of Records Management Subject Files – FG001-07 (Briefing Papers). The correspondence includes both routine public and Congressional correspondence; White House memoranda consist of final policy decisions. Additionally, there are speech drafts and final reading copies of speeches used by President George W. Bush, reports, and scheduling records.

Topics include the resignation of Donald Rumsfeld and the nomination of Robert Gates as Secretary of Defense, progress in Iraq, and the larger War on Terror. Reports include the final report from the Iraq Study Group and routine administration reports on Iraq, as required by Congress. Also present are routine fact sheets, briefing papers and schedules, news clips, press releases, and statistical presentations on Iraq.

### **System of Arrangement**

The materials in FOIA 2014-0228-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – White House Office of Records Management (WHORM) and Staff Member Office Files (SMOF).

The White House Office of Records Management (WHORM) contains a variety of series created to organize and track documents and correspondence. The WHORM Subject Files and Alpha Files were compiled by staff in the White House Office of Records Management and are a series of documents assigned a letter/number combination and filed in a series of categories by subject. WHORM Subject Files and WHORM Alpha Files are processed at the document level.

Staff Member Office Files are maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Staff Member Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.
