Provenance

Official records of George W. Bush's presidency are housed at the George W. Bush Presidential Library and are administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

Scope and Content

The materials in FOIA 2018-0263-F[36] are a selective, not necessarily all inclusive, body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 2018-0263-F[36] requested previously unprocessed materials related to emails sent or received by Brett Kavanaugh referencing Casey between July 2003 and May 2006.

This FOIA primarily contains draft remarks on the War on Terror, a q and a, briefing book inserts for a Cabinet Meeting and draft remarks, personnel announcements, news articles, press gaggles, the final Statement of Administration Policy on H.R. 2446 - Afghanistan Freedom and Security Support Act of 2007, lists of questions presented in grants for the Supreme Court, a

cabinet report, a night note, administrative alerts, and hurricane updates. Records from this segment date from September 10, 2003 to June 9, 2008.

System of Arrangement

The materials in FOIA 2018-0263-F[36] are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – George W. Bush Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.

Casey Exchange_6 contains 120 assets, of which 97 are released in full, 15 are withheld in part, and 8 are withheld in full.

Casey RNCPST_1 contains 217 assets, of which 88 are released in full, 107 are withheld in part, and 22 are withheld in full.
