Scope and Content

The materials in FOIA 2016-0103-F[1] are a selective, not necessarily all inclusive, body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 2016-0103-F[1] requested materials related to the United States' support of the Turkish candidacy for accession to the European Union.

The textual portion of this FOIA primarily contains cover sheets, printed routing emails and memoranda, talking points, press points, fact sheets, published reports, news articles and releases, schedules and schedule proposals, routine printed emails, and correspondence. Included are letters from Congress, such as a letter from Congressional members to Prime Minister Recep Tayyip Erdogan regarding religious freedom and the Ecumenical Patriarchate, and formal responses to Congressional letters from the White House and Department of State. There are also several routine head of state letters such as an end-of-term letter to outgoing Cypriot President

Glafcos Clerides and a beginning of term cable to Turkish President Ahmet Necdet Sezer; both are from President George W. Bush. Also included are administrative documents related to the appointment of Charles Ries as ambassador to Greece, an unclassified cable from Condoleezza Rice to Turkish Foreign Minister Abdullah Gul reaffirming United States support for reunification of Cyprus, and the 2002 Amendments to the International Telecommunication Union constitution and convention along with ratification documents such as transmittal memos and a notification to Congress. Lastly, there are briefing papers, Q&As, media reactions, and scheduling proposals related to interviews given by President George W. Bush to Irish and Turkish journalists.

The electronic records include invitations to Turkey/EU related conferences and similar events, discussions about news articles, copies of speeches given by President Bush, Foreign Broadcast Information Service reports, cable round-ups, remarks from foreign officials on Turkey's accession, congressional testimony, and running commentary on the mark-up of the House resolution confirming the United States' position on the Armenian genocide. Other records include profiles of Turkey, profiles of pro-Turkey groups, inflation reports, notes from Turkey's session with the Trans-European Networks on energy, and a report by the Deutsche Bank on Turkey's accession efforts.

It should be noted that many of the records in this FOIA have been closed due to National Security classification and/or exemptions of the Freedom of Information Act.

Please note that a portion of classified records related to this request has not yet been processed. Additional records will be provided as they become available.

System of Arrangement

The materials in FOIA 2016-0103-F[1] are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – White House Office of Records Management (WHORM) Subject Files, Staff Member Office Files, and George W. Bush Presidential Electronic Records.

The White House Office of Records Management (WHORM) contains a variety of series created to organize and track documents and correspondence. The WHORM Subject Files and Alpha Files were compiled by staff in the White House Office of Records Management and are a series of documents assigned a letter/number combination and filed in a series of categories by subject. WHORM Subject Files and WHORM Alpha Files are processed at the document level.

Staff Member Office Files are maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Staff Member Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.

RNC_PST contains 2 assets, which are withheld in part.

CEA contains 8 assets, which are released in full.

NSC contains 16 assets, which are released in full.

OPD contains 1 asset, which is released in full.

WHO contains 22 assets, which are released in full.
