Scope and Content

The materials in FOIA 2022-0061-F are a selective, not necessarily all inclusive, body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 2022-0061-F requested materials related to White House Office of Records Management files that mention Reagan Dunn.

This FOIA primarily contains block and narrative schedules of President George W. Bush as well as briefing materials regarding events on those schedules from June 2006; speech drafts and correspondence between White House staff and the Department of Justice, including Reagan Dunn, regarding the National Youth Summit on Preventing Violence in February 2002; press release and information on the USA Freedom Corps-Citizen Corps; correspondence from the Office of Presidential Personnel, employment applications, resumes, and letters of

recommendation, including Reagan Dunn, from 2000, 2001, and 2005; a list of individuals, including Reagan Dunn, who received a photo with President George W. Bush; photos, itineraries, and briefing materials for Mrs. Laura Bush's trip for the Launch of the National Plan of Action for Orphans and Vulnerable Children in Tanzania, 2008; White House staff comments, speech drafts, and an implementation guide for Project Safe Neighborhoods; and lists of and draft thank you letters for airport greeters, including Reagan Dunn, from President George W. Bush's trip to Washington state in 2006.

System of Arrangement

The materials in FOIA 2022-0061-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – White House Office of Records Management (WHORM) Subject Files and Alpha Files.

The White House Office of Records Management (WHORM) contains a variety of series created to organize and track documents and correspondence. The WHORM Subject Files and Alpha Files were compiled by staff in the White House Office of Records Management and are a series of documents assigned a letter/number combination and filed in a series of categories by subject. WHORM Subject Files and WHORM Alpha Files are processed at the document level.
