Ahi Ezer is a not-for-profit organization based in Brooklyn, New York, and has been in existence for 82 years. It provides a host of services to the local residents including educational opportunities for children and housing for the elderly. Ahi Ezer's vibrant membership is comprised of 8,000 families and growing.

We vill be convening a Founders Committee get-together consisting of 80-100 of the community's major players and donors. Among the invited guests will be highly successful and prominent Jewish philanthropists, community entrepreneurs and businessmen representing local and rational companies such as HSBC Bank, Safari Bank, Century 21 Clothing Stores, Duane Reade Drug Stores, Rainbow Shops, Jordache Jeans, Bonjour and The Wiz. Over \$6 million has been pre-solicited from the group and the event will be to thank everyone for their support and encouragement in realizing the community's dream of building the Center. We would be honored to have the President or Vice President as the guest speaker.

Understandably, we are most willing to accommodate the President's or Vice President's availability and would work closely with your office to accommodate schedule and logistics. Therefore, this by-invitation-only event can be held either in Deal, New Jersey, during July or August, where many of this community maintain summer homes, or back in New York City during the fall. We are open to any venue—brunch, lunch, cocktails or dinner.

The 160,000-square-foot Center has been in the planning since 1990 and a groundbreaking ceremony was held in June 2000. It will contain a 280-bed, skilled geriatric care unit designed to provide the elders of the community with comprehensive, state-of-the-art nursing services. It will also include a gymnasium, synagogue, recreation facilities, therapy rooms, lounges, dining areas, laundry facilities, family rooms, private and semi-private units, meditation room, library and designated floors for Alzheimer's and Parkinson's patients. A professional staff of 300 will be on duty round-the-clock.

HUD will be providing mortgage guarantees to cover approximately \$37 million of the \$48 million cost of the project. In a one-time capital campaign effort, the community will be responsible for raising over \$11 million with over half of that having been realized by this event. The Center's annual budget will be \$27 million. Once in operation, the facility will be self-sufficient.

The project only recently received a green light from the NYS Department of Health after an acros: the board moratorium on construction of all new adult care centers was lifted. In fact, this was the first project out of the gate and the community recently feted Governor Pataki, as he visited several of the area synagogues escorted by the Chief Rabbi. A private reception was then held in the home of one of the community leaders. The governor has indicated that he will attend the event and will accommodate the President's / Vice President's schedule.

Our community is extremely proud of this administration's outstanding record and positions in dealing with issues close to our hearts as Americans. A visit with our leadership would establish a strong bond enabling us to work together to build a stronger and more secure country.

Please advise us as to the feasibility of the request so that we can begin to make the necessary arrangements.

Dear Karl:

I want to first thank you for the letter of appreciation last week on the efforts of our Celebration of American Life committee to galvanize support for the President's domestic agenda. The June 4th ceremony with the President at the White House that honored over 50 of Michigan's "Ambassadors of Success" along with others from across the country in the area of welfare reform was especially poignant for myriad reasons. The impact that was made in Detroit and across the state that the President listens and cares about people throughout the entire American economic spectrum was not lost on either the Ambassadors themselves or on Michigan citizens as a whole. As Second Vice Chairman of the Michigan Republican State Party, I have promoted this event and the on-the-ground grassroots contact that was necessary to produce such a positive response to create a very successful vehicle to build urban support for the President's policies as well as assuring we have a voter ID base we can use in the mid-term and 2004 election cycle.

Karl, I realize you are quite busy. Two weeks ago I spoke with Angela Sailor and was informed that the original request for a video by the President for the July 15th Detroit Tigers and Celebration of American Life pre-game ceremony program was being pulled. That decision was made after a request for a draft script was made to us about two weeks before that. The request made by Rusty Hills, Chairman of the Michigan Republican State Committee, and myself was sent February 27th. I am attaching a copy of that letter.

The Detroit Tigers are estimating that based on their responses thus far a program audience of 30,000 of the 40,000 capacity will be at Comerica Park for the July 15 game. In addition, while Governor Ridge's office has informed us that he will not be able to attend as a guest speaker or to throw out the first pitch, the President's video -- with his focus on the Spirit of American Life -- is almost center to our point and to the program. We have always understood how valuable the President's time is in being able to devote time to this important endeavor.

I have called Gov. Engler's Lansing and Washington D.C. offices to see if there was anything that could be done to assist on this matter. We have been working 9, 14, and even 18 hour days over the past eight months to build solid support for the President as well as create new relationships with professional organizations such as the Detroit Tigers. After July 15th event, we will branch out for the same type of relationships with the other major sports franchises as well.

We are loyal volunteers who believe in the solid verifiables the White House Political Division needs. In addition, we have worked on program partnerships with health systems, Letter to Karl Rove from Kevin Fobbs June 26, 2002 Page 2 of 3

sheriff offices, private sector trainers, corporate sponsors, and, more importantly, nearly 3,000 welfare-to-work graduates and voters in Detroit, Michigan who now support the President's policies over unions and Democratic opposition. This is no mean feat in this union town!

Meanwhile over the past seven months, the Celebration to American Life week committee has been working with the Detroit Tigers, area human service agencies, dozens of welfareto-work training organizations, health service providers, as well as the over 700 southcast Michigan faith organizations and local as well as sports media to build support for an event that is being focused almost entirely on the President's Armies of Compassion as well as several of his domestic agenda priorities.

The Detroit Tigers have been so cooperative and supportive that they are preparing a second phase to be announced at the July 15th event to actively engage other MLB teams as well as other professional sports teams -- including the 2002 Stanley Cup Champions the Detroit Red Wings -- to assist with building a commitment to identify and support the Armics of Compassion and their efforts in their sports' cities and sports markets as well.

This would translate into easily hundreds of thousands of media hits all across the country and perhaps millions of Americans being called to arms in an entirely different but welcome definition of Homeland Defense. This also goes hand in hand with the President's USA Freedom Corps.

The unexpected result has been over 2,500 signature letters from welfare-to-work graduates mostly from Detroit who can be our ambassadors in an election year to tell other voters in their families or co-workers that his message and his deeds are truly compassionate. We have companies, firms, and religious leaders who believe there really is something unique and different in the tone of a GOP that targets urban poor.

This is tangible, and all the while we have been keeping both the state party as well as the Governor's office informed about activities such as the April 4th event where Angela Sailor spoke to two different groups on the President's fatherhood initiative. We sent her a video of the TV coverage from that event and have used the positive response that was generated in subsequent Celebration of American Life communications.

In fact, as soon as we knew about the welfare-to-work letter initiative that you wanted completed before Memorial Day, we were able to get a Democratic administration (Detroit's Mayor Kilpatrick's office) along with 37 training firms into motion. We organized volunteers and requested the allocation of City and training firms' staff to log hundreds of hours to begin to identify and coordinate the letter signing campaign.

I believe we are doing exactly what the Political Division would want to accomplish and that is to get the President's message across, build a new support base and ID on the Letter to Karl Rove from Kevin Fobbs June 26, 2002 Page 3 of 3

President's agenda, and move toward solidifying contacts and representatives who can speak on what has worked in their lives.

We are doing everything possible to ensure that major urban areas can be re-claimed by the GOP and be built upon for our statewide races as well as for the 2004 re-election campaign for the President. Karl, we need your help on this. We need a positive response on the Presidential video for the July 15 Celebration of Life pre-game ceremony at the Detroit Tigers vs. Boston Red Sox game.

Please give me let me know what we can do, what other proofs you might need, or if other supporting documentation is necessary.





WOLF CALLS ON PRESIDENT TO CONVENE PRIVATE/PUBLIC SECTOR CONFERENCE ON ADVANCED TECHNOLOGY SECURITY

Conference Would Streamline Homeland Security Process

Washington, D.C. — Rep. Frank Wolf (R-VA) today called on the White House to convene a conference that would provide private sector security companies, many of whom have existing and viable technology already in place, an opportunity to show their technology to the federal government, thereby helping to ensure homeland security.

Wolf, chairman of the appropriations subcommittee with jurisdiction over the Commerce, State and Justice departments, said the conference would ideally bring together the best and the brightest from the private and public sector to determine what technology is already available, what needs to be developed and how the existing federal funds directed toward homeland security can be most wisely spent.

The conference also would provide a forum for government agencies actively involved in homeland security, such as the INS, the FBI and the DEA, to collectively explore their shared needs and how the private sector can best assist the federal government in fighting the war on terror.

Wolf said the federal government is best positioned to oversee national homeland security, but many in the private sector have been developing relevant technologies in this field for years and are having difficulty getting that technology to the right people in government.

"In this era of heightened security it is imperative that we are wise and efficient in garnering these resources," Wolf said. "In the wake of the tragic events of September 11, the President has done an excellent job of making homeland security a top priority. This conference would be a natural step in the implementation of his national priorities as put forth in the FY 2003 budget."


A number of private sector companies already have developed innovative technologies, such as biometric systems, smart card systems and name recognition software, but are having a difficult time reaching the right people in government to market their products. A conference would afford the opportunity for a productive dialogue between private sector security technology experts, particularly small- and medium-sized businesses, and the agency personnel responsible for homeland security.

The conference also would be an ideal forum to gather together many of the federal agencies involved in the homeland security effort to discuss what their shared needs are and what the appropriate role of the private sector might be in meeting these needs.

The conference could be coordinated by Gov. Ridge, and the Office of Homeland Security, whose stated mission is to "develop and coordinate the implementation of a comprehensive national strategy to secure the United States from terrorist threats or attacks."

As you well know, your FY 2003 budget calls for greater investments in technology. This conference would be one step in ensuring that taxpayer resources are spent wisely and that the federal government is efficiently pursuing homeland security interests, so as to avoid inter-government overlap.

I have been encouraged by your active pursuit of and dedication to ensuring homeland security. I firmly believe that a private/public sector conference on advanced technology security could be invaluable in the war on terror.




