Scope and Content

The materials in FOIA 2018-0263-F[39] are a selective, not necessarily all inclusive, body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 2018-0263-F[39] requested previously unprocessed materials related to emails sent or received by Brett Kavanaugh referencing abort between July 2003 and May 2006.

This FOIA primarily contains administrative emails, news articles, routine memoranda, reports, draft letters, cabinet reports, charts, and a speech draft. Notable documents include night notes for key White House staff including Andy Card, Karl Rove, Joe Hagin, and Mike Gerson; White House Comment Line monthly reports; a speech draft of the comments President George W.

Bush made on December 15, 2003, after the capture of Saddam Hussein; and several copies of the State of Administrative Policy on S. 1426, Foreign Operations, Export Financing and Related Programs Appropriations Act for fiscal year 2004. Records from this segment date from July 8, 2003, through June 6, 2005.

System of Arrangement

The materials in FOIA 2018-0263-F[39] are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – George W. Bush Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.

The following is a list of electronic search results lists (SRLs) processed in response to FOIA 2018-0263-F[39]:

George W. Bush Electronic Records

Abort 21 Days contains 7 assets, all of which are released in full.

Abort 33 Days contains 11 assets, all of which are released in full.

Abort 40 Days contains 26 assets, of which 13 are released in full, 7 are withheld in full, and 6 are withheld in part.

Abort ARMS contains 116 assets, of which 102 are released in full, 1 is withheld in full, and 13 are withheld in part.

Abort Exchange_1a contains 109 assets, of which 36 are released in full, and 73 are withheld in part.
