The California Association of Public Hospitals and Health Systems (CAPH) would like to request a meeting with you to discuss several critical federal issues facing our state's public hospitals that provide access to care for low-income and uninsured Californians.

In particular, the status of California's pending Selective Provider Contracting Program waiver—the renewal of which is currently under consideration by the Administration—is of very serious concern to public hospitals and health systems. The loss of an estimated \$600 million in the next two years that will result if the waiver is not approved as submitted will harm California's entire health care system and gravely reduce access to health care services, including primary and preventive care, hospital services and emergency and trauma care for patients and communities throughout the state. Further, California's safety net hospitals face an additional loss of \$184 million in federal Medicaid funds effective October 1, 2002 if action is not taken to prevent scheduled reductions to the Disproportionate Share Hospital (DSH) program pursuant to the Balanced Budget Act of 1997.

We would very much appreciate the opportunity to meet with you in person to discuss these issues in further detail. CAPH and our members will be in Washington, DC next month and would respectfully request a meeting with you July 16 or July 17. CAPH will follow up with your office in the next few days regarding this request. Thank you for your consideration.







Thanks again for your assistance in helping us secure Mrs. Bush for participation in the Educational CHOICE Charitable Trust fundraising event here in Indianapolis. Attached is the letter of request which was sent to Mrs. Bush.

The Educational CHOICE Charitable Trust is a non-partisan organization with a Board composed of Republicans, Democrats and Independents. Our current chairman is Fred Klipsch who is a very active Republican and our Treasurer is Louis Mahern who is a very active Democrat. Louis was a state Senator for many years and then ran for Mayor against Steve Goldsmith. I do not know the political affiliations of all of our other Board members. (As I mentioned earlier, Mitch Daniels was a Board member before he joined the Bush team.)

Although our donor base tends to be mostly Republican, we have had a number of prominent Democrats who have financially supported the program.

As you know, the Educational CHOICE Charitable Trust's mission is to raise funds to support scholarships for low-income inner-city kids. Golden Rule Insurance Company pays the administrative costs of running the program which ensures that 100% of all donations are used for scholarships. More details about the program are provided in the attached letter to Mrs. Bush.

#### Dear Laura.

Congratulations for everything that you and the President have been doing for the past year. The two of you have truly been incredible since September 11<sup>th</sup>. The country has looked to you for leadership, and you have provided it in spades.

Kath and I enjoyed seeing both of you at your Christmas party. Thanks so much for including us. You were so kind to apologize to us for having to wait so long to see the two of you. Well, to be perfectly frank, we should have apologized to you for having to stand up for such a long period of time greeting so many friends of yours.

Kath and I believe that the biggest problem today facing communities across the country is the poor education opportunities for kids from low-income families who live in the inner-cities. As I know you are aware, kids who attend these public inner-city schools perform poorly on standardized tests. In 2001 in Indianapolis, 39% passed the 3<sup>rd</sup> grade test, 17% passed the 6<sup>th</sup> grade test, and only 27% passed the 8<sup>th</sup> grade test. For some schools the passing rate was actually less than 10% for each of these grades.

Unfortunately, as you know, low-income parents who live in the inner-city do not have a choice about where to send their kids to school. They are required to send their kids to these failing schools.

Ten years ago, Pat Rooney, a citizen of Indianapolis, became frustrated with the refusal of our elected officials to address this problem. His company committed to giving \$400,000 a year to support scholarships for inner-city kids here in Indianapolis so they could go to the school of their choice. He also committed to providing for the administrative costs of running this scholarship program which is called the Educational CHOICE Charitable Trust

To earn a scholarship a child must qualify for the federal reduced-price lunch program (which means he/she is poor) and must also cover the tuition remaining after the Educational CHOICE Charitable Trust awards its one-half tuition scholarship, which is worth up to \$1,000. Since its inception, the program has been, unfortunately, incredibly

popular. Nearly 2,000 kids will be educated in approximately 75 different private schools this year. There are more than 500 kids on the waiting list.

A couple of years ago, we raised additional funding and gave parents the opportunity to participate in a lottery. Nearly 6,000 kids participated in the lottery for 625 scholarships. (This program is Kath's and my number one charity to which we donate \$50,000 per year.)

Although most of these church and private schools operate with tuition levels of \$2,000 to \$3,000, their education results are quite impressive. In general, the longer kids are in public schools, the worse they do on standardized tests. The longer they are in private schools, the better they do on these same tests. The attached graph illustrates this phenomenon.

To celebrate our 10<sup>th</sup> anniversary, but more importantly to raise additional funding to meet the demand for scholarships, we plan to hold a fundraising dinner. We would love for you to be the honorary chairperson of this event and, of course, we can schedule the event around your calendar.

I know you have a great passion for reading. We would also love to sponsor an event to promote reading while you are here.

I realize you receive many, many more invitations than you can possibly accept. If this does not work for you, I certainly understand. It would be helpful to receive your response as soon as possible so we can begin making definitive plans for the event.

Again, thanks so much for everything you do as the First Lady. We are all so very proud of you.

As you probably know, three years ago Ted Forstman and John Walton created the Children's Scholarship Fund which was modeled on our program and raised money for over 45,000 kids across the country.
