in Boca Raton, Florida

I represent American Media, Inc. ("AMI"). AMI owns a 67,000 square foot building on three acres in the heart of Boca Raton, Florida that was the unfortunate target of the anthrax bioterrorism attack last year. The building is currently quarantined and unoccupied.

I am working with Congressman Clay Shaw (R-FL) and others to transfer the building to the General Services Administration (GSA) for the sum of \$1.00. This effort is supported by the local community as the only way to get the site decontaminated. [The building is located in the new part of Congressman Shaw's district. As you know, Shaw has had difficult races the past two elections, and this one could also be close. He opponent is on the Board of Supervisors for Palm Beach County. She played a high profile role in the Bush-Gore recount, and will most likely try to exploit the issue if the situation cannot be remedied]

Here are some relevant facts that I believe warrant this transfer:

As you are aware, the FBI has a compelling interest in entering the AMI Building at 5401 NW Broken Sound Boulevard, Boca Raton, Florida, to conduct a comprehensive analysis of the distribution of Bacillus anthracis spores. Such an analysis was not technically possible until recently. The development of new sampling strategies and techniques aimed at extracting forensic information from the distribution of spores has made it possible to efficiently process a large area such as the AMI Building. The primary difference between this new analysis and the analysis of last fall is that it will now be quantitative. That is, the quantity of spores at each sampling location will be estimated, providing data for a three-dimensional map relating levels of contamination with positions in the building. It is believed that such a map may allow a reconstruction of events that led to the illnesses of AMI employees. This in turn may produce new physical evidence or clues that will aid the investigation.

The first FBI analysis of AMI was the first analysis of a bioterror event anywhere. Much has been learned since then. Observations of the behavior of the anthrax spore powder led to the concept that even unopened contaminated letters would leave a telltale trail. A system has been developed that permits large numbers of samples to be taken very efficiently. Samples taken using this system can be assessed so rapidly that laboratory capacity will not be overwhelmed, which was a major hindrance to the AMI analysis of last year. This system was used to find the Leahy letter in November. Many other innovations are being developed specifically for this project.

The methods to be used for the analysis of AMI are on the cutting edge of bioterrorism investigations. In addition to the forensic information to be gleaned, this operation will put to the test a variety of methods and concepts that are among the first to be applied in the emerging field of microbial forensics. The experience and data from this project will

undoubtedly form the basis for investigative concepts-of-operation for years to come, and the difficulties and shortfalls that are sure to be encountered will provide ample background for future research and improvement. In addition, although this sampling project will be driven by forensic needs, the resulting data will contribute to the understanding of spore distribution from a public health perspective and aid the Centers for Disease Control and Prevention (CDC) in better managing future events. In short, this operation will have a tremendous impact on the way bioterrorism investigations are conducted well into the future.

The FBI plans to incorporate the aid of the CDC in its effort to scientifically analyze contamination at AMI. The FBI and CDC established a Memorandum of Understanding prior to the anthrax attacks of last year that established a framework for collaboration in the investigation of bioterrorist attacks. Experience of the past year has shown that no single agency can effectively manage all aspects of an anthrax scene. Indeed, the CDC was an integral part of the previous FBI investigation at AMI.

Although new techniques permit much more efficient sampling, complete mapping of spore distribution at the AMI Building remains a daunting task because of its size. The CDC and its subordinate agencies possess scientific specialists and resources relevant to this operation that are not available elsewhere. CDC scientists will be used to help develop scientifically sound strategies, and to provide specialized laboratory and data analyses. The participation of scientific specialists will go a long way toward establishing the credibility of the data should it be used in court. In addition, the CDC has committed sufficient personnel to effectively double the on-scene workforce available from the FBI alone. This will greatly enhance the efficiency and speed with which sampling can be conducted, an important consideration for the health and safety of personnel conducting hazardous materials operations in a hot environment.

Although the CDC has reasons of its own to analyze contamination at AMI, it has recognized the primacy of the forensic mission and has offered its assistance to the FBI in a purely subordinate role. The FBI greatly appreciates all of the cooperation afforded to it by AMI and will do its best to accommodate AMI's needs and concerns.

undoubtedly form the basis for investigative concepts-of-operation for years to come, and the difficulties and shortfalls that are sure to be encountered will provide ample background for future research and improvement. In addition, although this sampling project will be driven by forensic needs, the resulting data will contribute to the understanding of spore distribution from a public health perspective and aid the Centers for Disease Control and Prevention (CDC) in better managing future events. In short, this operation will have a tremendous impact on the way bioterrorism investigations are conducted well into the future.

The FBI plans to incorporate the aid of the CDC in its effort to scientifically analyze contamination at AMI. The FBI and CDC established a Memorandum of Understanding prior to the anthrax attacks of last year that established a framework for collaboration in the investigation of bioterrorist attacks. Experience of the past year has shown that no single agency can effectively manage all aspects of an anthrax scene. Indeed, the CDC was an integral part of the previous FBI investigation at AMI.

Although new techniques permit much more efficient sampling, complete mapping of spore distribution at the AMI Building remains a daunting task because of its size. The CDC and its subordinate agencies possess scientific specialists and resources relevant to this operation that are not available elsewhere. CDC scientists will be used to help develop scientifically sound strategies, and to provide specialized laboratory and data analyses. The participation of scientific specialists will go a long way toward establishing the credibility of the data should it be used in court. In addition, the CDC has committed sufficient personnel to effectively double the on-scene workforce available from the FBI alone. This will greatly enhance the efficiency and speed with which sampling can be conducted, an important consideration for the health and safety of personnel conducting hazardous materials operations in a hot environment.

Although the CDC has reasons of its own to analyze contamination at AMI, it has recognized the primacy of the forensic mission and has offered its assistance to the FBI in a purely subordinate role. The FBI greatly appreciates all of the cooperation afforded to it by AMI and will do its best to accommodate AMI's needs and concerns.





Support for Use of Ground Troops

Nearly three-fifths favor sending American ground troops to the Persian Gulf to remove Hussein from power. Support has increased since August and held steady through September.







The National Association of Wheat Growers (NAWG) today responded to a question that is being asked more and more in the press, relative to disaster assistance. Many apparently believe that disaster assistance only needs to be provided to those agricultural sectors which do not have access to crop insurance tools.

NAWG pointed out that the highest level of crop insurance available is 85% of production, but because of premium cost many producers must insure at even lower levels.

"Crop insurance is an effective tool, but even at the highest coverage levels it requires at minimum a 15 percent deductible every single year," said Gary Broyles, President of the association. "The most common coverage is at 70%, resulting in a 30% annual deductible. In wheat country we have faced five consecutive years of drought, and no one can sustain 30% deductibles every year for five years in a row. Nobody has margins to absorb that impact. We certainly agree that disaster assistance for livestock producers is necessary, but crop producers also have acute needs for disaster assistance."


Kansas State University agricultural economist Dr. Art Barnaby illustrated the point on his web site earlier this week. In a paper entitled If Crop Insurance is Working Why Do Farmers Need Disaster Assistance?, Barnaby made the following observation: "The worst outcome for insured growers is to suffer a 35% to 40% yield loss and higher prices. They will lose their counter cyclical payment because of higher prices, they have fewer bushels (production) to sell at the higher prices, even with this significant yield loss they will receive no payments under traditional ad hoc disaster aid, and their net insurance payments will be small or none." Barnaby referred to the lack of relief for insured acres as the "hole in the safety net".

The scenario described by Barnaby is exactly what is happening in wheat and other crops. Multiple years of drought, coupled with production problems elsewhere in the world, have led to a tightening of wheat supplies and resulted in rising prices. US producers have fewer bushels to sell, but will receive no aid from price-based mechanisms because the prices have risen above trigger levels.

"We're happy to see the Administration announce disaster relief for livestock producers," said Broyles. "We appreciate their creative proposal to address the needs in the livestock sector. We hope now Congress and the USDA will turn their attention to the serious needs of crop producers in this country, and meet that need as well."

NAWG also called on members of the House of Representatives to co-sponsor H.R. 5383, a disaster bill introduced by Congresswoman Barbara Cubin, which has attracted bipartisan support and is now circulating in the House.
