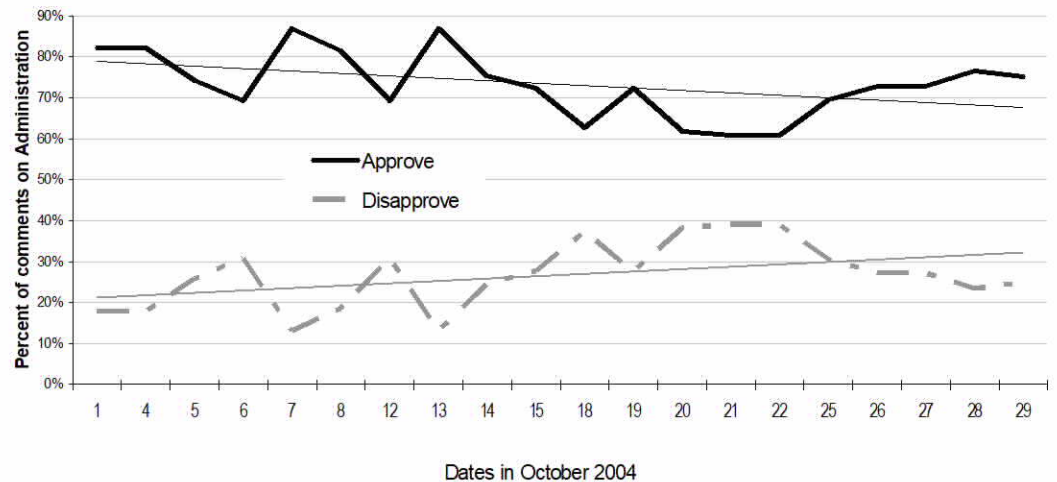

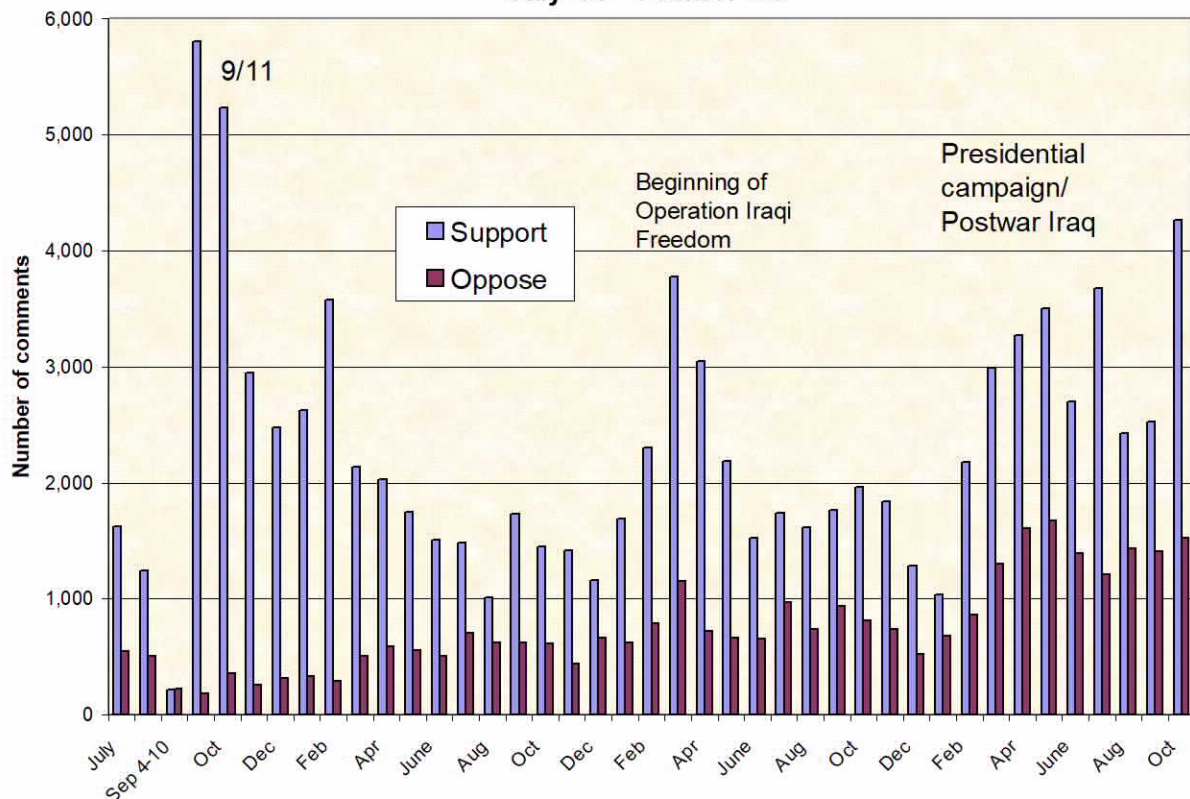

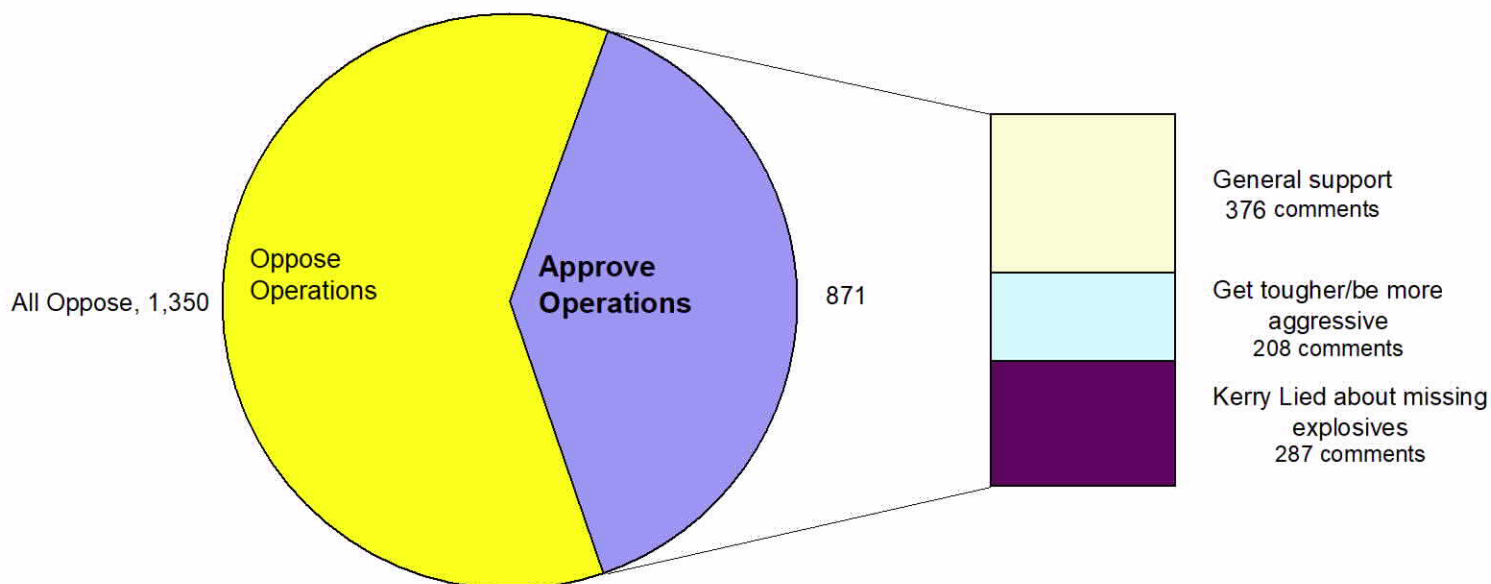
**Bush Administration Overall Performance

Iraq Operations: Comments in Support October 2004

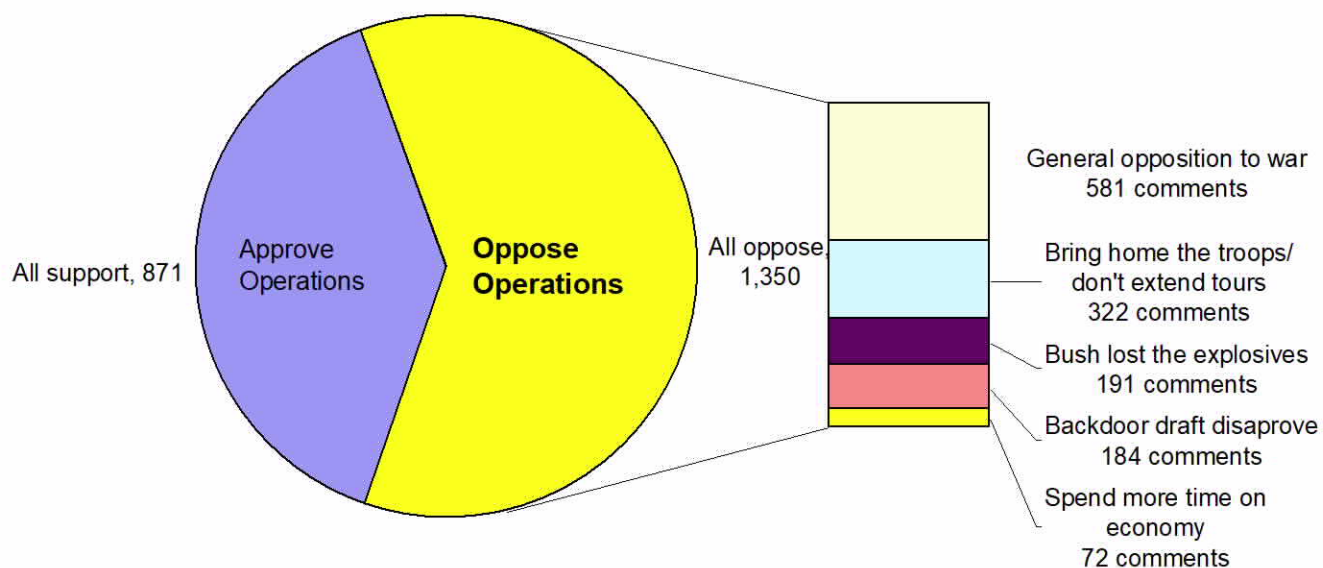

The chart below illustrates a summary of the categories of those comments disapproving U.S. involvement in Iraq.

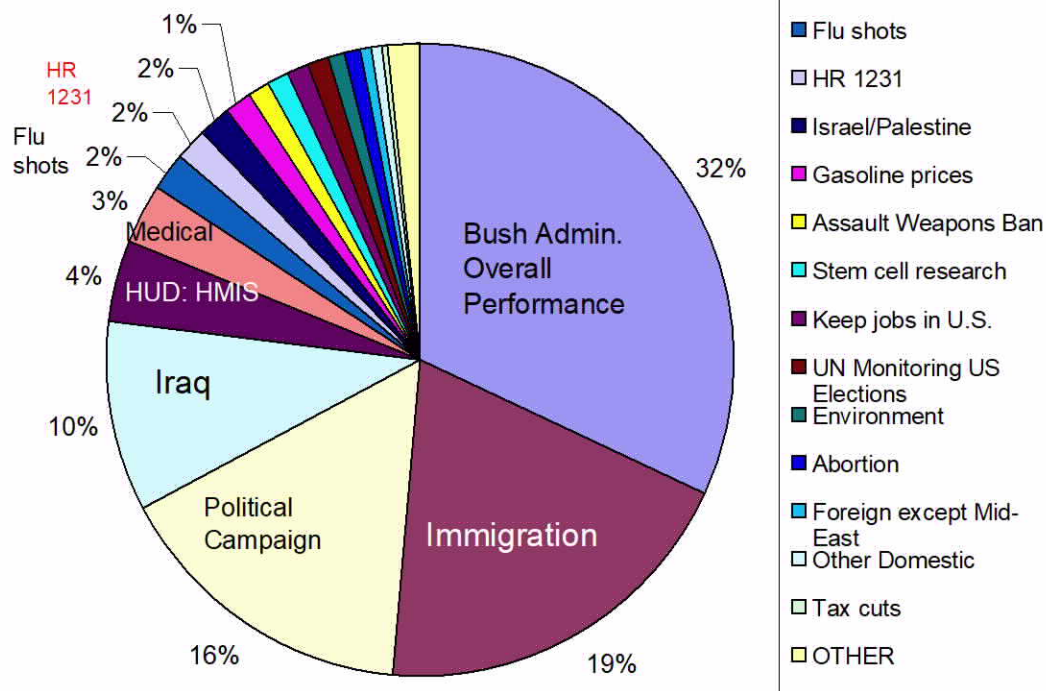

Israel & Palestine: 369 total comments

-111 Pro-Israel Comments. Of these, 105 callers indicate general support for Israel. 6 callers support the construction of a protective fence around their land.

-258 Pro-Palestine comments: Of these, 222 callers indicate general support for Palestine. 25 callers want Israel to withdraw from occupied territories. 9 callers disapprove U.S. financial aid to Israel. 2 callers disapprove building of fence.

Hud/HMIS: 964 total comments

-964 comments regarding Homeless Management Information Strategies System(HMIS), 100% strongly disapprove.

HR 1231: 386 total comments

386 total comments, 100% urge the administration to approve H.R. 1231 and S. 623.

-The vast majority of callers indicate they are Federal employees and have been encouraged the White House by www.narfe.org.

-The website provides a toll free number: 1-888-225-8418 that links directly to the Comment Line.

Assault Weapons: 255 total comments

-255 total comments, 93% urge the administration to renew the ban.

Cancer Care Cuts: 424 total comments

-424 comments, 100% callers urge the administration to protect Cancer Care Provision dollars from being cut from the Medicare Bill.

Flu Shots: 461 total comments

-461 callers are very upset about the U.S. flu-vaccine shortage.

The Voice of the People...

"If a woman is a victim of abuse...if HUD collects her personal information, her abuser can find her and hurt her again. The whole purpose of why we have domestic violence shelters is safety. If HUD goes forward with this, we won't be a shelter anymore."

"I'm an 81 year old woman and I am so angry at the President because I sat on the floor in a Rite -Aid waiting to get a flu-shot."

"Tell the President there is a house full of guys here in Mishewaka, Indiana who are praying for him and his family!"

"I want to urge the President to stop pressuring Congress to strip the immigration provisions of HR 10. Unless he gets his act together on immigration, I'm just gonna stay home on Nov. 2nd. And I'm a registered Republican!"
