## **Biography of Dr. Robert “Bob” Martin**

In June 2001, you nominated Robert Sidney Martin to be Director of the Institute of Museum and Library Services (IMLS); the U.S. Senate subsequently confirmed his nomination by unanimous consent. Dr. Martin is the first librarian to lead IMLS, formed in 1996.

IMLS is a federal grant-making agency dedicated to creating and sustaining a nation of learners by helping libraries and museums serve their communities.

Since Dr. Martin assumed the directorship of IMLS, the agency's budget has increased from \$232,321,000 to \$262,240,000. For 2005, the Administration is requesting an additional \$32,595,000 for IMLS—a record-level funding recommendation for the nation's museums and libraries. In addition, in September 2003, you signed the Museum and Library Services Act of 2003 reauthorizing the agency through 2009. The legislation received bi-partisan support from Congress and enthusiastic backing from library and museum communities. The reauthorization makes organizational, programmatic, and structural changes that help complete the transition begun in 1996 when the original Museum and Library Service Act placed the administration of federal library and museum programs in one federal agency for the first time.

Under Dr. Martin's leadership, IMLS launched a new grant program to recruit and educate the next generation of librarians. The program, announced by Mrs. Bush in January 2002, seeks to off-set a pending national shortage of librarians due to retirements. Dr. Martin acted as co-host to Mrs. Bush for two seminal White House conferences, one on school libraries and the other on libraries, museums, and lifelong learning.

IMLS has continued and strengthened its commitment to research. *True Needs, True Partners*, a 2001 study of museums' work with schools, found that America's museums spend more than \$1 billion annually and provide more than 18 million instructional hours every year on K-12 education. In 2002, IMLS published the first-ever report on the *Status of Technology and Digitization in the Nation's Museums and Libraries*. Dr. Martin's emphasis on accounting for results and measuring impact has led IMLS to promote outcomes-based evaluation among its grantees and develop a series of user-friendly tools and aids to prospective grantees, including an online project-planning tutorial.

Strategic partnerships figure prominently in Dr. Martin's vision for IMLS, and he has involved the agency in several interagency collaborations. Dr. Martin advanced the role of libraries and museums at the first ever U.N. World Summit on the Information Society in Geneva in December of 2003. As one of two US representatives in a session on Cultural Policies in Knowledge Societies, he shared a vision of a truly inclusive information society and assisted in the drafting of the resulting ministerial communiqué.

IMLS has taken a leadership role in identifying best practices for the creation, management, and preservation of digital resources, and in disseminating these practices throughout the library, archives, and museum communities. Since 2000, IMLS has sponsored an annual *Web-Wise* conference to share the latest research and newest inventions in digital technology.

A librarian, archivist, educator, and administrator, Dr. Martin was Professor and Interim Director of the School of Library and Information Studies at Texas Women's University prior to his appointment at IMLS. From 1995 to 1999, he was Director and Librarian of the Texas State Library and Archives Commission.

From 1985 until 1995, Dr. Martin was Associate Dean of Libraries for Special Collections at Louisiana State University. Before that, he worked in the archives and special collections at the University of Texas at Arlington and the University of Texas at Austin. He also taught at the University of Wisconsin at Madison.

He has authored and co-authored several scholarly treatises including two best-selling books, *Maps of Texas and the Southwest, 1513-1900* (1984, 1999) and *Contours of Discovery: Printed Maps Delineating the Texas and Southwestern Chapters of the Cartographic History of North America, 1513-1930* (1982). The books reflect another area of Dr. Martin's research interests and expertise: the history of the American southwest.

Dr. Martin has a Doctor of Philosophy in Library Science from the University of North Carolina at Chapel Hill, a Master of Library Science from the University of North Texas, and a Bachelor of Arts in History from Rice University.

## BACKGROUND ON PERFORMERS

**Smokie Norful** began his career as a history instructor for four years at the University of Arkansas before relocating to Chicago in 1998. In Chicago, he earned a Masters of Divinity degree from Garrett Theological Seminary. Upon completion of Seminary, Norful remained in Chicago as an assistant pastor at the Rock of Ages Baptist Church and stayed active in various church choirs. He eventually caught the ear of Joe Anne Brunson, leader of the Thompson Community Choir, who asked him to sing one of his original songs for the choir's *Real* album, launching Norful's professional singing career. He is from Muskogee, Oklahoma.

**Mary Mary**, a sister duo from Inglewood, California, began their singing career in the church choir before moving on to perform on the Bobby Jones Gospel show on BET and for the Michael Matthews traveling gospel shows, *Mama I'm Sorry* and *Sneaky*. Sisters, Erica and Tina Campbell, daughters of gospel singers, also toured as backup singers for a variety of R&B acts. Their most famous work includes *Dance*, a song they wrote and performed, which appeared on the *Dr. Doolittle* soundtrack in 1998. Also in 1998, their song, *Let Go, Let God*, was used on *The Prince of Egypt – Inspirational*, one of three soundtrack albums for the film.

**Donnie McClurkin**, a gospel vocalist, began his career singing back up vocals with Andraé Crouch. He stayed close to Crouch throughout his boyhood and began playing piano and singing with his church youth choir. He formed the McClurkin Singers as a teenager and later formed another group, the New York Restoration Choir. While serving as an associate minister at Marvin Winans' Perfecting Church in Detroit, Michigan, [REDACTED] b(6) [REDACTED] b(6) In 1996, a friendship with a Warner Alliance executive resulted in his first self-titled LP.

### **STATE ISSUES**

#### **ECONOMY**

As of April, Florida's unemployment rate was 4.2 percent, 1.8 percent below its peak of 6.0 percent in January 2002. As of May, the national unemployment rate was 5.1 percent.

#### **BASE REALIGNMENT AND CLOSURE (BRAC)**

The BRAC recommendations, made by the Department of Defense on May 13, would result in a net gain of 3,798 military jobs and a net loss of 1,002 civilian jobs in Florida. None of Florida's major military installations would be closed, while only two small installations – a Naval reserve center in St. Petersburg and a military finance office in Orlando – were recommended to be closed.

#### **GOVERNOR JEB BUSH SIGNS STATE BUDGET**

Governor Jeb Bush signed the State budget into law on May 26. At \$64.7 billion, the budget is significantly larger than last year's \$57.3-billion budget. Governor Bush says the increase is due to hurricane-related spending and the increased amount of money available from Florida's booming economy. The budget, which includes over \$200 million in tax cuts, provides for large increases in education, transportation, and health care. Governor Bush vetoed fewer items this year than in the past, but cut \$180 million in spending from over 250 individual items and programs.

#### **OFFSHORE DRILLING**

Senator Mary Landrieu (D, LA) recently introduced an amendment to the National Energy Policy that would allow drilling activity in the eastern Gulf of Mexico. The Senator later withdrew the amendment, but proposed another provision, calling for an inventory of Outer Continental Shelf oil-and-gas reserves, that was approved by the Committee on Energy and Natural Resources. Florida Senators Mel Martinez (R) and Bill Nelson (D) fear that this may be the first step toward offshore drilling in Florida, which they view as potentially damaging to the State's beaches and its \$50-billion tourism industry. Both Senators are prepared to battle against offshore drilling.

In a related matter, Governor Bush last week ended 15 years of litigation by signing a landmark settlement between the State and Coastal Petroleum. Florida will pay \$12.5 million to Coastal Petroleum, which has had offshore drilling leases since the late 1940s. Since Florida passed an offshore drilling ban in 1990, the company has fought to win either approval for drilling or a settlement from the state.

### **JESSICA LUNSFORD ACT SIGNED INTO LAW**

On May 2, Governor Bush signed into law legislation aimed at protecting Floridians from sexual predators and offenders. The Jessica Lunsford Act, named in memory of the nine-year-old Citrus County girl who was abducted from her home, raped, and buried alive, enhances penalties for sexual crimes against children. The bill also calls for the creation of a task force charged with ensuring that Florida's law-enforcement agencies work together to communicate information about sex offenders.

### **PARENTAL NOTIFICATION BILL**

On May 25, Governor Bush signed into law the Parental Notice of Abortion Act, a bill requiring physicians to notify a parent or guardian before performing an abortion on a minor. A similar bill was signed in 1999, but was struck down by the courts on the grounds that it violated privacy provisions in the Florida Constitution. The new law, which was approved by 65 percent of Florida voters in November and went into effect on June 1, requires parental notification in person or by phone 48 hours prior to an abortion or by certified mail 72 hours in advance.

### **CONGRESSMAN WELDON FUNDRAISING LETTER**

Congressman Dave Weldon (R, FL-15) recently sent a fundraising letter offering White House tours to anyone who bought two \$2,500 tickets to a June fundraising dinner honoring you. The White House condemned the letter as inappropriate, and news coverage drew parallels between the letter and President Clinton's exchange of Lincoln Bedroom stays for donations. Weldon believes the White House overreacted.

### **2005 HURRICANE SEASON**

The 2005 Atlantic Hurricane season officially began on June 1. Governor Bush signed into law a bill that gives consumers new tools to understand insurance policies and that helps them make coverage decisions. Governor Bush also signed legislation creating a sales-tax holiday for the first 12 days of the hurricane season, allowing consumers to save money on hurricane-related necessities. Last year's four catastrophic hurricanes caused an estimated \$22 billion in damage to Florida.
