### Records Related to a National Security Meeting at President George W. Bush's Crawford Ranch on or about December 28, 2006

#### Extent

1 folder, approximately 18 pages / 201 assets

#### Access

Collection is open to all researchers. Access to George W. Bush Presidential records is governed by the Presidential Records Act (PRA) (44 USC 22, as amended) and the Freedom of Information Act (FOIA) (5 USC 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

#### Copyright

Records in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Researchers are advised to consult the copyright law of the United States (Title 17, USC) which governs the making of photocopies or other reproductions of copyrighted material.

#### Provenance

Official records of George W. Bush's presidency are housed at the George W. Bush Presidential Library and are administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

#### Scope and Content

The materials in FOIA 2015-0165-F are a selective, not necessarily all inclusive, body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 2015-0165-F requested materials related to a National Security meeting that took place at President George W. Bush's Crawford Ranch on or about December 28, 2006.

This FOIA primarily contains emails of news articles, draft remarks by the President after meeting with his National Security Team, and emails related to administrative or routine office functions. Also included are drafts of the Iraq strategy review event timeline, block calendars of the Chief of Staff, cabinet reports, and NSC meeting summaries. Textual records include the Presidential Daily Diary Backup from December 28, 2006, including schedules, empty call logs, two pool reports, press release remarks, and printed images from Yahoo! News.

Please note that a portion of classified records related to this request has not yet been processed. Additional records will be provided as they become available.

### **System of Arrangement**

The materials in FOIA 2015-0165-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – Staff Member Office Files and George W. Bush Presidential Electronic Records.

Staff Member Office Files are maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Staff Member Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.

The following is a list of electronic search results lists (SRLs) and folders processed in response to FOIA 2015-0165-F:

### ***George W. Bush Electronic Records***

Exchange Email System contains 181 assets, of which 159 are released in full, 20 are withheld in part, and 2 are withheld in full.

NSC Shared Drive contains 3 assets, of which 1 is released in full, and 2 are withheld in part.

WHO Shared Drive contains 17 assets, of which 16 are released in full, and 1 is withheld in part.
