### **Any and All Documents, Correspondence, and Emails Exchanged Between John Ellis (“Jeb”) Bush and President George W. Bush Between January 1, 2007 and January 1, 2008**

#### **Extent**

2 folders, approximately 11 pages

#### **Access**

Collection is open to all researchers. Access to George W. Bush Presidential records is governed by the Presidential Records Act (PRA) (44 USC 22, as amended) and the Freedom of Information Act (FOIA) (5 USC 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

#### **Copyright**

Records in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Researchers are advised to consult the copyright law of the United States (Title 17, USC) which governs the making of photocopies or other reproductions of copyrighted material.

#### **Provenance**

Official records of George W. Bush’s presidency are housed at the George W. Bush Presidential Library and are administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

#### **Scope and Content**

The materials in FOIA 2015-0125-F are a selective, not necessarily all inclusive, body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 2015-0125-F requested any and all documents, correspondence, and emails exchanged between John Ellis (“Jeb”) Bush and President George W. Bush between January 1, 2007 and January 1, 2008.

This FOIA primarily contains printed emails, handwritten notes, and reports regarding such topics as Cuba and the World Bank and involving John Ellis (“Jeb”) Bush.

It should be noted that many of the records in this FOIA have been closed due to National Security classification and/or exemptions of the Freedom of Information Act.

**System of Arrangement**

The materials in FOIA 2015-0125-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas –White House Office of Records Management (WHORM) Subject Files.

The White House Office of Records Management (WHORM) contains a variety of series created to organize and track documents and correspondence. The WHORM Subject Files and Alpha Files were compiled by staff in the White House Office of Records Management and are a series of documents assigned a letter/number combination and filed in a series of categories by subject. WHORM Subject Files and WHORM Alpha Files are processed at the document level.
