I. PURPOSE

To highlight the recent signing of S. 650, the Pediatric Equity Research Act of 2003, and to sign into law the CAN-SPAM Act of 2003.

II. BACKGROUND

Photo Opportunity

S. 650, the Pediatric Equity Research Act of 2003, gives the Food and Drug Administration the authority to require drug companies to conduct safety tests on pharmaceuticals that are to be administered to children.

The Senate passed the bill on July 23 by unanimous consent. The House of Representatives passed the bill on November 19 by voice vote. Due to Constitutional deadlines, you signed this legislation into law on Wednesday, December 3.

Today's photo opportunity will give you an opportunity to highlight the importance of the legislation and thank those who worked to secure its passage.

Senator Mike DeWine (R, OH) was the sponsor of S. 650. Congressman Jim Greenwood (R, PA-08) sponsored a similar bill in the House.

Bill Signing

S. 877, the CAN-SPAM Act of 2003, requires e-mail senders to provide a mechanism for consumers to opt out of receiving future messages, bans deceptive advertising practices, and creates civil and criminal penalties for violators. In addition, the Federal Trade Commission is authorized to implement a do-not-spam registry.

The House of Representatives initially passed the bill by a vote of 392 to 5. After the Senate amended the legislation by unanimous consent, the House agreed to the revised version of the bill by unanimous consent. Senator Conrad Burns (R, MT) is the sponsor of the legislation.

Diane Sawyer Bio

Diane Sawyer has been co-anchor of ABC News' "Primetime Thursday" since September 2000. In addition to her "Primetime" assignment, Sawyer was named a co-anchor, with Charles Gibson, of "Good Morning America" in January 1999.

Since the premiere of "PrimeTime Live" in August 1989, Sawyer has traveled extensively around the United States and abroad to report on and investigate a wide range of topics and to interview a diverse group of newsmakers and personalities.

During the 1989-90 television season, Sawyer co-anchored a special live broadcast from the White House, where she joined President and Mrs. Bush for a tour of the first family's private living quarters. She also co-anchored an unprecedented hour-long broadcast from inside the Kremlin, the historic symbol of Soviet power.

For six months in 1995, Sawyer was co-anchor of the ABC News magazine, "Day One." She is also a substitute anchor for "World News Tonight with Peter Jennings" and "Nightline."

Prior to joining ABC News, Sawyer spent nine years at CBS News where she was a co-anchor for "60 Minutes." Prior to that, she co-anchored the "CBS Morning News" and was the CBS News' State Department correspondent.

She was podium correspondent for the 1988 Democratic and Republican National Conventions and a floor correspondent for the 1984 Republican and Democratic National Conventions and for the 1980 Democratic Convention.

Prior to joining CBS News, Sawyer held several positions in the Nixon Administration. She was part of the Nixon-Ford transition team from 1974 to 1975. She also assisted former President Nixon in the writing of his memoirs in 1974 and 1975.

Sawyer began her career in broadcasting in 1967 in Louisville, Kentucky, where she was a reporter for WLKY-TV until 1970.

A native of Kentucky, Sawyer received a B.A. from Wellesley College in 1967 and completed a semester of law school before deciding on a career in broadcasting.

I. PURPOSE

To hold two consecutive bill signing ceremonies followed by two photo opportunities for:

- H.R. 3491, the National Museum of African-American History and Culture Act;
- H.R. 2297, the Veterans Benefits Act of 2003;
- H.R. 2115, the Vision 100 – Century of Aviation Reauthorization Act; and
- S. 459, the Hometown Heroes Survivors Benefits Act of 2003.

These events will allow you to highlight the importance of these bills and thank those who worked towards their passage.

II. BACKGROUND

Bill Signings

- 1) The African-American History and Culture Presidential Commission was created to provide both you and the Congress with an implementation plan for creating a National Museum of African American History and Culture in Washington, D.C. Over the course of a year, the Commission held several meetings and released their final report this past April, calling for the creation of a National Museum of African-American History and Culture to be built near the Capitol Reflecting Pool. H.R. 3491, the National Museum of African-American History and Culture Act, responds to the Commission's report by authorizing the creation of a museum (within the Smithsonian Institution) dedicated solely to honoring the history and legacy of African Americans in this country. The bill passed the House on November 19 by a vote of 409 to 9. The Senate passed the bill the following day by unanimous consent. Congressman John Lewis (D, GA-05) is the sponsor of the legislation. Senator Sam Brownback (R, KS) sponsored a similar bill in the Senate.
- 2) H.R. 2297, the Veterans Benefits Act of 2003, expands the benefits program for veterans and their surviving spouses. Among the benefits, it allows many surviving spouses of

veterans who die of a service-related cause to qualify for restoration of benefits that were taken away when they remarried; makes it easier for disabled veterans who own businesses to sell their goods and services to the Federal government; gives a 13 percent-higher college-assistance payment to surviving children of those killed in the line of duty; and allows for a lower fee to be charged to reservists who use the Veterans' Affairs home loan program. The House of Representatives passed the bill on October 8 by a vote of 399 to 0. The Senate passed an amended version of the bill on November 19, which the House subsequently passed by voice vote the following day. Congressman Chris Smith (R, NJ-04) is the sponsor of the legislation. Senator Arlen Specter (R, PA) sponsored a similar bill in the Senate.

Photo Opportunities for Bill You Have Already Signed

- 1) H.R. 2115, the Vision 100 – Century of Aviation Reauthorization Act, reauthorizes the FAA for four years and for \$60 billion. The bill ensures that air travelers will continue to have access to a safe and secure aviation system. Also, the conference report contains no prohibition on privatization, which is consistent with current law. The House agreed to the conference report on October 30 by a vote of 211 to 207. The Senate passed the conference report on November 21 by unanimous consent. Due to Constitutional deadlines, you have already signed this legislation, and will only have a photo opportunity today. Congressman Don Young (R, AK-At Large) was the sponsor of this legislation. Senator Jay Rockefeller (D, WV) introduced the reauthorization in the Senate.
- 2) S. 459, the Hometown Heroes Survivors Benefits Act of 2003, ensures that a public safety officer who suffers a fatal heart attack or stroke while on duty will be presumed to have died in the line of duty for purposes of eligibility under the public safety officer survivor benefits program. The House passed the bill on November 22 by voice vote, and the Senate passed the bill on November 25 by unanimous consent. Due to Constitutional deadlines, you have already signed this legislation, and will only have a photo opportunity today. Senator Patrick Leahy (D, VT) was the sponsor of this legislation.

I. PURPOSE

To highlight your commitment to helping all Americans realize the dream of homeownership by signing S. 811, the American Dream Downpayment Act, into law.

II. BACKGROUND

The American Dream Downpayment Act enacts one of the key components of your homeownership initiative, the goal of which is to add 5.5 million new minority homeowners by the end of the decade.

The American Dream Act will help meet your goal by helping first-time homebuyers with their down payment. Many people who can afford a monthly mortgage payment cannot find the money for the down payment. This legislation provides \$200 million annually in down payment assistance for 40,000 low-income families. Of those families, more than half are expected to move out of subsidized or public housing. This legislation also helps stimulate more than \$2 billion of investment and create more than 30,000 new jobs.

This legislation passed the Senate by unanimous consent on November 24, 2003. It passed the House on December 8, 2003. The bill was sponsored by Senator Wayne Allard (R, CO). A similar bill, sponsored by Congresswoman Katherine Harris (R, FL-13), passed the House in October.
