### **STATE ISSUES**

#### **EMPLOYMENT FIGURES**

In February 2006, North Carolina's unemployment rate was 4.6 percent, 2.3 percent below its peak of 6.9 percent in January 2002. As of February 2006, the national unemployment rate was 4.8 percent.

#### **SENATOR JESSE HELMS' HEALTH**

Former Senator Jesse Helms (R, NC) has been diagnosed with vascular dementia and has been moved to a convalescent center. Vascular dementia is the second most common form of dementia after Alzheimer disease. The 84-year-old former Senator was living in Raleigh until he was hospitalized this spring with pneumonia.

#### **DUKE UNIVERSITY LACROSSE TEAM**

Three members of the Duke University Men's Lacrosse team could face criminal charges after an exotic dancer hired to perform at a private party claims she was raped by them. The players and their attorneys deny the rape allegation and police are waiting for DNA tests before filing charges. Duke University has forfeited two games and suspended the season while authorities continue to investigate.

#### **IMMIGRATION LAWS**

Both U.S. Senators from North Carolina have voiced support for a temporary guest worker program, but with the caveat that it cannot be a path to U.S. citizenship. Senator Elizabeth Dole (R, NC) said she would back a temporary guest worker program as long as immigrants eventually returned to their home countries to reapply for legal re-entry. Senator Richard Burr (R, NC) said he favors a temporary guest worker program, but not as a path to U.S. citizenship.

Congresswoman Sue Myrick (R, NC-09) has been the most vocal North Carolina House member on immigration issues. She has called for a meeting with Justice Department officials to discuss North Carolina having their own immigration court. Joining her at a news conference were other members of the North Carolina Congressional delegation, Patrick McHenry (R, NC-10), Virginia Foxx (R, NC-05), Walter Jones (R, NC-03), and Charles Taylor (R, NC-11), who chairs the House Appropriations Subcommittee on Interior and Environment. Taylor said he would help secure the necessary Federal funding.

Myrick has taken a tougher stand on illegal immigration since the July 2005 death of a North Carolina school teacher, who was killed when his car was struck by an intoxicated illegal immigrant who had five previous DUI charges.

Myrick is considering a bid for governor in 2008, and some interpret this legislation as an effort to curry favor with conservatives. Her political ambitions probably spurred her role in the debate over Dubai World Ports when she was a strong opponent of the deal and sent a one-line letter to you reading: "HELL NO."

### **NORTH CAROLINA EDUCATION LOTTERY COMMISSION**

Governor Mike Easley (D) signed legislation in August 2005 creating a state lottery with the proceeds going towards education expenses. At least 35 percent of total proceeds will be used to reduce class sizes, fund school construction, and enhance college scholarships for students who qualify for the Federal Pell Grant. The lottery legislation went into effect on March 30 and first-day sales ended at \$8 million, exceeding expectations.

### **NORTH CAROLINA HOUSE SPEAKER JIM BLACK (D)**

Federal and state officials have multiple investigations centering on State House Speaker Jim Black. Initial investigations revolved around the lottery and allegations of illegal lobbying by a vendor seeking the lottery contract. Black's former chief political adviser is also being investigated for possibly lobbying for the vendor without registering. Kevin Geddings, who Black appointed as a state lottery commissioner, also stepped down from that position when it was revealed he was also on a lottery vendor's payroll. A Federal grand jury has subpoenaed documents from Black's office and testimony from several people, including members of his staff and political supporters.

In addition, state and local authorities are pursuing another investigation regarding campaign contributions in the State Legislature. The State Board of Elections ruled on March 23 that Black and a political action committee representing optometrists violated the law by collecting checks with the payee left blank. Names were filled in later by a PAC leader and distributed to specific candidates. Black, an optometrist, testified he filled in three checks himself. Black forwarded \$4,200 of these checks to former State Representative Michael Decker. Decker switched his party registration from Republican to Democrat in 2003, which made it possible for Black to retain a post as co-speaker in a House evenly divided between Republicans and Democrats. Decker later switched back to the Republican Party to campaign in the Republican primary in 2004. He lost.

State Board of Election members ruled this practice violated disclosure laws, while Black's lawyers say state law allows the practice. Black has appealed the ruling.

The matter has been turned over to Wake County District Attorney Colon Willoughby (D) for possible criminal charges. Willoughby is also considering charges in the lottery investigation.

Four Democrat State Representatives: Pricey Harrison, Lorene Coates, Hugh Holliman and Alice Graham Underhill have called on Black to step down as Speaker.
