Scope and Content

The materials in FOIA 2018-0263-F[47] are a selective, not necessarily all inclusive, body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 2018-0263-F[47] requested previously unprocessed materials related to emails sent or received by Brett Kavanaugh referencing pro-life, pro-choice, fetal, fetus, abomination, existing precedent, existing Supreme Court precedent, or Voting Rights Act between July 2003 and May 2006. There were no responsive records for existing Supreme Court precedent.

This FOIA primarily contains night notes, speech drafts, articles with commentary, cabinet reports, briefing papers, memoranda on embryonic stem cell research, drafts of a proclamation celebrating the 40th anniversary of the passing of the Voting Rights Act, edits to the FY2005 Department of Interior appropriations bill, progress reports on Congressional legislation, and information on judicial nominees. Records from this segment date from July 8, 2003 to April 3, 2007.

System of Arrangement

The materials in FOIA 2018-0263-F[47] are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – George W. Bush Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.

George W. Bush Electronic Records

Pro Life RNCPST contains 2 assets, which are both withheld in part.

Pro Choice Exchange contains 59 assets, of which 56 are released in full and 3 are withheld in full.

Fetal 33Days contains 3 assets, which are all released in full.

Fetal 40Days contains 2 assets, of which 0 are released in full, 1 is withheld in full, and 1 is withheld in part.

Fetal Exchange contains 104 assets, of which 72 are released in full, 8 are withheld in full, and 24 are withheld in part.

Fetal RNCPST contains 4 assets, which are all released in full.

Fetus Exchange contains 28 assets, of which 2 are released in full, 12 are withheld in full, and 14 are withheld in part.

Fetus RNCPST contains 6 assets, which are all withheld in full.

Abomination Exchange contains 8 assets, which are all withheld in full.

Existing Precedent ARMS contains 1 asset, which is released in full.

Existing Precedent Exchange contains 11 assets, which are all released in full.

Voting Rights Act Exchange_1 contains 242 assets, of which 164 are released in full, 10 are withheld in full, and 68 are withheld in part.
