STATE ISSUES

EMPLOYMENT FIGURES

In February 2006, North Carolina's unemployment rate was 4.6 percent, 2.4 percent below its peak of 7.0 percent in January 2002. As of February 2006, the national unemployment rate was 4.8 percent.

DUKE UNIVERSITY LACROSSE TEAM

Members of the Duke University men's lacrosse team could face criminal charges after an exotic dancer alleged she was assaulted and raped by three men at a private party on March 13. The players and their attorneys deny the allegations, and police are waiting for the results of DNA tests before filing charges. Duke has suspended the team's season while authorities continue to investigate.

CHARLOTTE-MECKLENBURG POLICE OFFICER SHOT

A Charlotte-Mecklenburg Police officer was shot in the head on Wednesday, April 5 while serving a rape warrant. The shooter then barricaded himself inside his home. His brother was also in the home and wanted to leave, but was not being allowed to according to police reports. A SWAT team has surrounded the two-story home where the shooting occurred.

The injured officer was taken to Carolinas Medical Center-University in the back of a patrol car, then by ambulance to Carolinas Medical Center's main emergency room near uptown, flanked by police cars. He was being taken into surgery shortly before 1 p.m. Wednesday. Stephens and Charlotte Mayor Pat McCrory said they had visited him, and he was conscious for part of the time.

IMMIGRATION LAWS

The U.S. Senators from North Carolina have been active in the debate over border security and immigration reform. Senator Elizabeth Dole (R) has said border security must be "our top priority." She also supports creating temporary work permits, as long as these workers would have to pay taxes and obey the law. Dole said, "After a time, the workers would have to return to their home country to reapply for legal admission."

Senator Richard Burr (R) has said that he favors a temporary worker program, but not as a path to citizenship.

Congresswoman Sue Myrick (R, NC-09) has been extremely vocal on immigration issues. Recently, she called for a meeting with Attorney General Gonzales to discuss the need for North Carolina to have its own immigration court. Myrick believes the state does not have the tools and resources needed to deport illegal aliens in an expedited manner. Currently, North Carolina is under the jurisdiction of the immigration court in Atlanta. Regarding Myrick's proposal, a DOJ spokesman said that North Carolina "is currently a leading candidate for a new immigration court," adding "That doesn't mean it's a definite."

Myrick has taken a tougher stand on illegal immigration since a July 2005 incident in which a North Carolina school teacher was killed when his car was struck by an illegal immigrant who was drunk driving. Last year, Myrick introduced an amendment to immigration legislation in the house that would require any illegal immigrant convicted of a DWI to be automatically deported; the amendment was adopted by voice vote. Last month, Myrick joined Congressman Patrick McHenry (R, NC-10) and other conservative Representatives in signing a letter to Senator Arlen Specter (R, PA) expressing opposition to proposals in the Senate that would legalize undocumented foreign workers already in the country.

NORTH CAROLINA EDUCATION LOTTERY COMMISSION

Governor Mike Easley (D) signed legislation in August 2005 creating a state lottery, with the proceeds going toward education expenses. At least 35 percent of total proceeds will be used to reduce class sizes, fund school construction, and enhance college scholarships for students who qualify for Federal Pell Grants. The lottery legislation went into effect on March 30.

SPEAKER JIM BLACK UNDER INVESTIGATION

Federal and state officials have multiple investigations centering on State House Speaker Jim Black. Initial investigations revolved around allegations of illegal lobbying by a vendor seeking the new state lottery contract. Meredith Norris, Black's former chief political advisor, is also being investigated for allegedly lobbying for the vendor without being registered to do so. A Federal grand jury has subpoenaed documents and testimony, seeking to learn about contacts between the vendor and Black's office.

NORTH CAROLINA BRIEFING

In a separate matter, the State Board of Elections ruled on March 23 that Black and a Political Action Committee (PAC) representing optometrists may have violated the law by collecting checks with the name of the recipient left blank; names were filled in later, and the checks were distributed to specific candidates. Black, an optometrist, has admitted that he filled in three checks himself. Black's lawyers have said that state law allows this practice, but the State Board of Elections ruled that the actions may have been illegal. The Board has referred the matter to Wake County District Attorney Colon Willoughby (D), who is also considering charges in the lottery investigation.

Many Republicans and some Democrats have called on Black to step down as Speaker.
