**Health IT.** WH staff met today to resolve remaining issues regarding the Monday announcement. HHS accepted all WH edits to the Request for Information. OMB also made edits to the contract proposals to build in the role for NIST. HHS is still reviewing the edits but is likely to accept them. Tomorrow, DPC will staff a draft of the Secretary's speech. There will be remaining issues for discussion regarding the AHIC charter.

**Ryan White.** DPC is behind schedule in implementing the Ryan-White strategy, but they appear to be making progress. They hope to share legislative principles in meetings with the Hill next week. We have not yet seen the draft.

**Avian Flu.** WH staff met today with HHS to discuss a funding strategy for vaccines and antivirals for FY05-FY07. HHS proposes to buy as much vaccine as can be produced in FY06 and FY07. By the end of FY07, HHS would have 20 mil courses of antiviral and 20 million of vaccine. HHS is still working on the funding proposal.

**Democracy Fund.** At last September's UNGA, the President called for establishment of a UN Democracy Fund to help establish institutions in emerging democracies. He committed to make an initial contribution and challenged other countries to contribute as well. We have not yet identified funds from the '05 budget for reprogramming. OMB is discussing options with the State Department.

**New Source Review.** EPA did not announce today that no additional changes are necessary to the NSR Equipment Replacement Provision (ERP) rule. The announcement is now scheduled for release tomorrow. The rule will be stayed, however, until the litigation is resolved.

**Medicaid Commission.** Baucus, Dingell, Reid and Pelosi issued statements that they would not exercise their option to name Members to the Commission.

**DHS Reorganization.** Following discussions with Joe, HSC will set up a briefing next week with interested WH offices. We would ask DHS to present the plan to the Chief the following week (after WH offices have resolved or crystallized any disagreements). If the proposal is ready, we would hope to brief the President the following week.



### Other Issues

- Amtrak (Sharp/DPC; Hook) – Sec. Mineta sent a letter to Amtrak President David Gunn on 5/25 warning that the railroad seemed poised to spend more in '05 than it can afford. Secretary Mineta recommended immediate costs cuts and cash conservation to moderate the cash burn rate and prevent a shutdown or government bailout.
- Appropriations (Kaplan/OMB; Silverberg) -- House has passed Energy & Water, Homeland Security, Interior, and Mil Quality of Life.
- Asbestos (Ho/DPC; Hook)
- Byrd Amendment (Daly/NSC; Katz) – The Administration supports repeal, although congressional support for full repeal is unlikely. NSC and Treasury are reviewing other possible legislative approaches.
- CAFE (Connaughton/DPC; Hook) -- DPC convened an internal deputies meeting on 5/31 to discuss fuel standards for light trucks for model year 2008 and beyond. DOT is required by law to establish standards for these vehicles no later than April 1, 2006. Deputies discussed our regulatory proposal to make the standards size based. A number of offices (OVP, CEA, NEC) would like to pursue legislative changes to restructure CAFE entirely. A second deputies meeting will be convened with the relevant agencies before going to principals.
- CFIUS (NEC; Katz) -- *There will be a Deputies meeting tomorrow to resolve issues associated with potential mitigation measures that would allow the transaction to go forward.*
- Civil Service Reform (Sharp/DPC; Silverberg)
- Clear Skies (Cooney/CEQ; Katz) – At a House Energy and Commerce Air subcommittee hearing, Connaughton and Holmstead agreed to provide some of the modeling requested by Senator Carper.
- Climate Change (CEQ; Hook) – Hagel, Craig and Voinovich will meet to craft a second-degree amendment to Bingaman's proposal to impose a light carbon national cap and trade program.
- *Community College Initiative (Sharp/DPC; Hook) – DOL sent out the first of two solicitations for grant applications (SGA) for the \$125 million in community college grants. The SGA allowed only community colleges to apply for funding. Chairman Regula believes that other entities, including workforce investment boards and one stop centers, should also be eligible for grant money. DPC will meet with OMB and DOL tomorrow to discuss the possibility of configuring the second SGA to permit such grants beyond community colleges.*
- Cooperative Conservation event (Pinero/DPC; Hook) – CEQ is on schedule for a three-day conference at the end of August in St. Louis.
- Corporation for Public Broadcasting (Russell/NEC; Katz)
- Crime/Guns/Lautenberg (Ho/DPC; Hook) – DOJ/OLP formed a study group with the FBI to review the GAO report. The OLP group has developed its recommendations, which are currently before the AG. DOJ is recommending administrative and legislative changes. DPC will review them in the near future.
- Digital Television (Russell/NEC; Katz) – Chairman Barton has stated that he is committed to seeking a hard date of December 31, 2008 for the transition. Dingell and other D's argued the government should provide free DTV converters to all viewers; Barton suggested he might support a narrowly targeted subsidy instead. He plans to attach legislation to the reconciliation package in September after passing it through Committee.



- Drug Reimportation (Leggitt/DPC; Katz) – DPC hosted a meeting with OMB, OVP, OLA, CEA, Communications, FDA and HHS staff to discuss strategies for dealing with potential legislation on the Hill. A growing number of cities and states are passing laws to allow for the importation of drugs from Canada.
- EEO-1 (Sharp/DPC; Hook) – EEOC gave us a cost estimate of compliance with the proposed new form. OIRA is working with EEOC to confirm the numbers. DPC and OMB met Friday with EEOC and asked EEOC to revise their cost estimates based on concerns OMB has raised about their assumptions. Once completed, DPC will meet with Barry and others to review the numbers.
- EEOC Definition of “Applicant” (Sharp/DPC; Hook) – DOL has informally submitted an NPRM and will formally submit in the next week or two.
- Economic and Community Development (Halaska/DPC; Hook)
- Endangered Species Act (CEQ; Silverberg) – Interior has been discussing administrative changes with CEQ. The changes are likely to be very controversial. DPC has scheduled a meeting for the 3<sup>rd</sup>.
- Faith Based Initiative (Towey/OFBCI; Hook) - JCT published a report in January proposing twelve measures designed to eliminate fraud and abuse related to charities. OFBCI has concerns that a number of the provisions are unnecessary and would burden charities unfairly. Grassley is pushing to include a number of these provisions in the CARE Act. NEC hosted a meeting with Treasury’s Office of Tax Policy last week to examine the provisions. Grassley’s staff told OLA that they plan to mark up in late June or early July.
- FDIC (Warsh/NEC; Katz)
- FMLA (Sharp/DPC; Hook) – DPC recently convened a deputies meeting on possible regulatory revisions to the Family and Medical Leave Act. DOL has provided preliminary cost/benefit analysis to OMB and DPC. DPC is planning on reconvening Deputies.
- GSEs (Warsh/NEC; Katz)
- G-8 (Shirzad/NSC; Silverberg) – NSC will brief the President Thursday regarding policy proposals for Gleneagles including a malaria proposal and initiatives on girls education and women’s justice programs, among others.
- Head Start (Halaska/DPC; Hook) – The bill was marked up by Enzi's committee on 5/25. DPC and OLA have serious concerns that the policy does not contain enough reform, and the authorization levels are far above what was in our budget. The committee does plan to continue working and will offer another manager's amendment on the floor, but OLA doesn't hold much hope that we will get what we want.
- Helping America’s Youth Initiative (Medina/DPC; Hook)
- Highway Bill (McMillan/OMB; Silverberg) – A letter from Sec. Mineta to the highway bill conferees went through staffing on 5/31.
- Indian Trust/Cobell (Ho/DPC; Hook) -- DOI is proposing legislation to allow it to buy out Indian lands using a loan from Treasury. Treasury would be paid back over 50 years from proceeds from the land. DOJ, DOI, and Treasury planned to submit a formal proposal to OMB on 6/2. Senator McCain is very focused on the issue and is expected to introduce legislation soon.
- *Immigration (Ho/Blore; Hook) – DPC convened a working group meeting today to refine various proposals for creating financial incentives to return home, including worker savings accounts. The DPC and HSC read ahead papers for principals should go out this evening.*



- *Job Training Reform (Sharp/DPC; Katz) – The Senate is hoping to schedule floor time on WIA in June or July. The bill does not include our reforms and has bad religious hiring language.*
- *Medical Liability (Ho/DPC; Silverberg) - House Democrats Baird, Moran and Ruppertsberger introduced medical liability legislation on 5/25. Their bill would cap non-economic damages at \$800,000 and allow that figure to fluctuate with inflation.*
- *Medicare Drug Implementation (Jackson; Katz)*
- *Methamphetamine (Ho/DPC; Katz) -- To help shut down domestic meth labs, DOJ and ONDCP favor making pseudoephedrine a Schedule V drug, which would require it to be sold behind-the-counter and only when a pharmacist is on duty. This approach is supported by Sen. Talent. HHS is concerned this approach would limit access in rural communities, which may have only limited coverage from pharmacists. DPC will convene a meeting tomorrow. We have asked them to consider another option, which would require BTC sales but would not require that a pharmacist be on duty. We have asked them to either resolve at the Principals meeting on the 8<sup>th</sup> or be prepared to present the issue to the President.*

- *Native Hawaiians (Ho/DPC; Silverberg) – We now think that Senate action on the bill is more likely. Senator Kyl will not block the bill. OMB believes strongly we should go on record with Administration concerns. OPA believes strongly we should weigh in only if necessary. We have asked OMB to draft a views letter, and will solicit Principals views once the draft is prepared. DOJ plans to brief Senator Coburn's staff by the end of this week.*
- *NCLB (Medina/DPC; Hook)*
- *Northwest Airlines Mechanics Negotiations (Sharp/DPC; Hook) -- Northwest Airlines has asked the National Mediation Board (NMB) to release them from mediation. If the NMB agrees that negotiations with the Aircraft Fraternal Mechanics Association have reached impasse, a vote to release the parties will trigger a 30-day cooling off period, following which the union may strike or the airline may lock out workers. The President can convene a Presidential Emergency Board to temporarily avoid a work action and attempt to broker a settlement. The NMB will meet with the union in the coming weeks to determine if an impasse has been reached.*
- *“Open Loop” Technology (Hannegan/CEQ; Katz)*
- *Patriot Act/Anti-Terrorism Tools (Mitnik/HSC; Silverberg) – The working group met on 6/1 to discuss legislative strategy on un-enacted anti-terror proposals (those not covered by Patriot reauthorization). There is concern that we avoid diluting or confusing our message on the Patriot Act with the additional anti-terror proposals. The working group recommendation will be circulated on Thursday evening as the read-ahead for the 6/6 HSC PC.*
- *Executive Order to Prohibit Payroll Deductions for Political Activity (Sharp/DPC; Silverberg) – DPC and OPA are proposing an EO to prevent automatic payroll deductions for political purposes. (E.g., to prevent federal employees unions from exploiting the federal payroll system to fund political activities). They are scheduling a Principals meeting for Friday or Monday.*
- *Personal Stockpiles (Rapuano; HSC; Silverberg) – HHS has prepared a proposal, which Secretary Leavitt will briefly discuss at the HSC Principals meeting.*
- *Postal Reform (Sharp/DPC; Hook) –*



- Protection of Lawful Commerce in Arms Act (Ho/DPC; Hook) -- House Judiciary Committee reported the bill last week. There is some discussion that the House may wait on a vote and let the Senate act, but there is also a possibility that the House will have a vote after recess.
- Real Estate Settlement Procedures Act (Halaska/DPC; Katz) - Secretary Jackson will begin outreach to solicit public reaction to various options (including the rule we considered in 2004).
- *Reformulated Gasoline Program (Hannegan/CEQ; Katz)* -- EPA announced today that it denied requests from CA, CT, and NY for a waiver of the oxygen content requirement of RFG program.
- *School Choice (Medina/DPC; Hook)* – DPC has scheduled a principals meeting for Monday to review school choice options. Tevi hosted a deputies meeting today to discuss the three options that will be presented to principals to expand choice. OMB expressed strong concerns about the cost of Lamar Alexander's plan and similar policy proposals.
- Secure Flight (Sharp/DPC; Hook) – TSA is expecting to issue an Interim Final Rule in mid-June compelling airlines to submit their passenger manifests.
- Steroids (Ho/DPC; Hook) – Chairman Davis's "Clean Sports Act" steroids bill passed the House Government Reform Committee. Davis' staff know that we do not support the bill. Another steroids bill is going through the House Commerce Committee. The two panels will consult and possibly combine the two bills.
- *Strategic Petroleum Reserve (Hutto/NSC; Katz)* - DOE briefed NSC, CEA, OMB and CEQ today on a model to determine the optimal size of the reserve.
- Tax Reform (NEC; Katz) – The tax reform panel was planning on issuing a report at the end of July. Karl has asked that they wait to issue the report until September.
- *TRIA (Warsh/NEC; Katz)* – A Treasury report on the program due June 30, 2005 is expected to be shared with the WH today. Sec. Snow has said the draft report will suggest that TRIA be extended. NEC plans to convene Deputies tomorrow and Principals next week to discuss the draft.
- Tricare Rx (Leggitt/DPC; Katz) – The Coalition for Government Procurement filed suit against the DOD/VA in U.S. District Court on March 24.
- Union Financial Transparency (Sharp/DPC; Hook) – OIRA has begun its review of the proposed rule and has asked DOL for stronger justification. OMB is working with DOL to improve the rule in anticipation that it will undergo OMB clearance.
- Universal Service Fund (Russell/NEC; Katz) - Following up on the Principals telecom meeting, we are developing options on USF. NEC hosted a meeting on 5/31 where we reviewed options for modernizing USF and ERATE from OMB, CEA, Education and Commerce.
- Voting Rights Act (Ho/DPC; Silverberg) – In advance of the anniversary of the VRA, we will need to settle on policy regarding reauthorization of Section 5. DPC will begin a policy process to resolve the issue.
- VNRs (Brosnahan/WHC; Silverberg)
- Welfare Reform (Halaska/DPC; Hook) – The next extension needs to be passed by June 30, 2005. DPC continues to work with Congress on how best to proceed.
