#### **Scope and Content**

The materials in FOIA 2016-0252-F[1] are a selective, not necessarily all inclusive, body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 2016-0252-F[1] requested photographs of President George W. Bush's pets.

The first segment of this FOIA primarily contains photographs of President George W. Bush's dogs Spot and Barney from January 2001 to July 2002. Some photos of the Bushes' cat India are also included. Photographs depict pets interacting with President George W. Bush, Mrs. Laura Bush, Bush family members, White House administration staff and White House residence staff including Dale Haney, Gary Walters and Maria Galvan at the White House, Camp David, and Prairie Chapel Ranch in Crawford, Texas.

Spot and Barney are often pictured boarding and disembarking Air Force One and Marine One during arrivals and departures at both the White House and Camp David. They are also seen travelling aboard Air Force One and Marine One. President Bush is shown walking and playing with Spot and Barney and is pictured driving his truck with Barney at Prairie Chapel Ranch.

Pets are photographed throughout the White House and its grounds. Spot and Barney are photographed during meetings and phone calls in the Oval Office, as well as playing on the South Lawn and in the Rose Garden. Spot is shown playing in snow and swimming in the pool. Spot and Barney are both pictured throughout the White House with holiday décor.

Barney, Spot and India are photographed as part of portrait sessions with and without President and Mrs. Bush. Notable portrait sessions include Mrs. Bush and EPA Administrator Christie Todd Whitman participating in a Town and Country photo shoot with their dogs, Barney and Coors in the Jacqueline Kennedy Garden, President Bush running on the White House track with Barney during a Runner's World photo shoot, and President Bush posing at Prairie Chapel Ranch for portrait painter Robert Anderson. Pets are also pictured during media interviews including those with Oprah, Lary King, Barbara Walters, Tom Brokaw, and Hugh Sidey.

Events with world leaders are pictured, including Tony Blair's visit to Camp David and visit to Prairie Chapel Ranch with his family as well as a visit by Vladimir Putin to Prairie Chapel Ranch. Leaders welcomed to the White House include President Jose Maria Aznar and Ana Botella de Aznar of Spain and President and Mrs. Kwasniewski of Poland. Other visits to the White House include those by actor Sean Connery, Mrs. Hosni Mubarak, Cyclist Lance Armstrong, and Prince Edward, Earl of Wessex.

Other White House events featuring pets include a National Governors Association Dinner, the President greeting members of the Young Gentlemen's Club from Cleveland Elementary School, a 4th of July celebration, Barney's First Birthday Party, White House Children's Story Hour, a press preview of the new Oval Office carpet, an Easter Egg Roll sponsor breakfast, and President Bush greeting VFW Leaders and posing with VFW Youth Winners on the South Portico stairs.

#### **System of Arrangement**

The materials in FOIA 2016-0252-F[1] are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – George W. Bush Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program.
