You asked where the administration stood by way of unanimous ITC decisions. We could not find where the administration and the ITC were apart on the 13 unanimous ITC decisions in the last five years.

I added source citations confirming the respective administration's support to material i sent the other day.

Let me know if we need to take this back further.

Unanimous ITC decisions, 1998-present

Note: Our research revealed 13 unanimous ITC decisions.

Vietnamese fish: "ITC advised the Department of Commerce to proceed with an investigation into alleged "dumping" on the U.S. market of Vietnamese frozen basa and tra fillets." (Pittsburgh Post-Gazette, 8/18/02)

--The Bush Administration agreed with the ITC decision to investigate. (AJC, 12/11/02)

Canadian lumber: "A unanimous ruling from the ITC found that cheap lumber imports had hurt the U.S. timber industry, clearing the way for duties to be imposed on Canadian timber producers." (Financial Times, 5/3/02)

--The Bush Administration agreed with the ITC finding and supported imposing duties. (Journal of Commerce, 6/3/02)

Uranium production: "The International Trade Commission ruled unanimously that USEC; the only U.S. producer of low-enriched uranium was being threatened by the trade practices of its European competitors. The ruling means the Commerce Department can impose duties on the nuclear fuel produced by Eurodif of France and Urenco, a European conglomerate." (Washington Post, 1/23/02)

--The Bush Administration agreed with the ITC ruling. (Washington Post, 4/29/02)

Dear Mr. President,

An attack against Iraq will be the equivalent to attacking Israel. An attack against Iraq may result in the destruction of Israel.

Having lived with the Kurds in eastern Turkey in 1966, worked in Iran from 1969 to 1975, and collaborated directly with heads of government in eight countries in the Middle East, I predict that the rage against the United States and the potential destabilization of Pakistan, Turkey, Iran, Egypt, Jordan and Saudi Arabia will eventually result in an attack against Israel.

I sent the attached letter to President Hussain. He has not yet replied. The majority of people outside and inside Iraq would like to have President Hussein removed from power, but an attack that compromises the integrity of the United Nations Security Council may result in the destruction of Israel. The post-Hussain, "democratically-elected government" is not going to love the country that just dropped 3,000 bombs on it.

With hopes that the United States will have the unanimous support of the United Nations Security Council before going to war with Iraq.

Why don't you invite 15,000 additional inspectors to Iraq to determine once and for all if there are any weapons of mass destruction? If they find weapons, they will be destroyed. Under no circumstances will the U.S. attack Iraq if there are 15,000 American inspectors in the country.

With hopes that you will give this suggestions some consideration.



As the financial media has been reminding us all weekend, today is the third anniversary of the record-high close of the NASDAQ above 5000 -- irrational exuberance, and all that jazz.



"Q1 2000 Upside Down?" October 1, 2002

So I can't help but be reminded of the observation we made last fall after **Pimco's Bill Gross** predicted "Dow 5000" -- that we could now be experiencing a replay of the first quarter of 2000, but upside down (see "Q1 2000 Upside Down?" October 1, 2002). By that we meant a climax of bearish sentiment and corresponding undervaluation that would mark the beginning of a long and painful bottoming process -- just the opposite of the climax of optimism and overvaluation that marked the beginning of the 2000 top. If this *is* a replay, and if this were a baseball game, then we'd be in the final inning right now.

We all remember the drama of the NASDAQ's March 2000 peak and the subsequent crash, as though "the top" took place all in one blaze of glory. But the NASDAQ peak was only a spectacular side-show. The broader market made an extended double-top that took a full 161 days to play out. The S&P 500 peaked at a closing value of 1527.46 on March 24, two weeks after the NASDAQ's top. But it rallied back to close at 1520.77 on September 1 -- attaining all but onehalf of one percent of the March peak (it made a new higher high, actually, if dividends earned since March are included).

This chart shows what it would look



like if the 2000 top were to play out again now -- literally upside-down, as a bottom. The pink line in the chart is the S&P 500 in 2000, plotted upside down. The blue line superimposed upon it is the S&P 500 from September 2002 to present. The two lines are coordinated on the chart so that the March 2000 top nests with the October 2002 bottom.

If it plays out this way, we have yet to see the second bottom on the S&P 500 -- but it's coming right up. If the final inning occurs 161 days from the October bottom, that will be March 19 -- one day after the Fed's next meeting, and two days after the Iraq disarmament deadline proposed by the United Kingdom in the latest draft UN Security Council resolution.

But this exercise in analogy reminds us of *what is possible* -- just when it may feel the most *impossible*. Dow 5000? With an earnings recovery well on track, monetary deflation off the table, equities undervalued across the board, and strong relative performance from the market's most risk sensitive sectors -- technology stocks and high-yield bonds -- this historical analysis comports with our sense that an imminent resolution of military-political uncertainties should trigger a significant and positive revaluation of equities. Congress is currently considering a proposal by President Bush to eliminate the federal income tax on dividends paid to investors. The amount of taxable dividend income you received in 2002 from the investments you own through Edward Jones was \$7,495.61. Under current law, the entire amount is subject to federal income tax. The income is taxed at the corporate level before it is paid to you, so in essence, current law taxes dividend income twice.

End the Double Taxation of Dividends

Job Creation

The Council of Economic Advisors finds the dividend provision produces 31 percent of the new jobs by 2004 - 431,000 out of the total 1.4 million jobs created by the President's plan during this time period.

Price Water House Coopers (PWC) estimates that the dividend exemption will create 1 million new jobs over the next two years and reduce unemployment on average by $\frac{1}{2}$ a percentage point. Over the ten-year life of the plan, this provision could help create more than five million jobs.

PWC estimates that this part of the plan will add more than a trillion dollars to GDP through 2012. It will contribute nearly \$100 billion to GDP through the end of 2004.

Corporate Governance

The payment of dividends is a good way to judge business health. Under the proposal, taxes would not affect the decision to pay dividends or retain earnings, restoring balance to the decision-making process and providing concrete evidence of economic health through the increased transparency of dividend payment. Corporations will have less incentive to engage in aggressive and perhaps questionable tax planning.

Fundamental Fairness

Will benefit the 35 million American households that currently receive taxable dividends whose investments in American industry are taxed twice. The number of beneficiaries is likely to increase as the attractiveness of dividend paying stocks appeals to America's rapidly growing investment class.

Also, the U.S is now at a competitive disadvantage because it has the second heaviest tax burden on corporate profits after Japan. Ending double taxation puts the United States on a more equal footing with our biggest trading partners.

The Plan will not cost the Treasury as much in the Long Run

While the static cost has been estimated at \$364 billion over ten years or an average of \$36 billion a year, that does not take into to account the potential growth effects of the measure as well as the confidence boosting effects the plan will have on markets. Recent analysis taking into account the economic growth and other positive effects of this measure puts the ten-year cost at only \$64 billion.¹

On November 11, 2001, two months to the day after the World Trade Center attacks, I sat down with Vice President Cheney at his residence. With me was Charles Jennings, one of my closest friends, and someone who was on a mission to do something from the private sector that would contribute to the fight against terrorism. His idea received direct and enthusiastic encouragement from Cheney.

Since that meeting Jennings started and chairs a public/private partnership called "RAINS" which unites state, local governments, and research universities with high-tech companies in support of homeland security. He has also been an active participant in a key DOD program that enables sensitive but unclassified information sharing from the federal government to local agencies and first responders who need it. A trial run of this program has been undertaken and was deployed in eight emergency operation centers (EOCs) from Baton Rouge to Seattle. It works. This is what local officials have been desperately wanting, and it can be rapidly installed and up and running in months.

Certain people running for the presidency are saying that nothing is being done about this by the administration. They are wrong. It is true, however, that if we take another terrorist hit, and in its aftermath it is determined that lives were lost because government officials and first responders failed to communicate properly, there will be hell to pay. Despite all the talk about information sharing there has been precious little done about it since 9/11--except for that small, but highly successful effort inside the Pentagon: the homeland security Advanced Concept Technology Demonstration (ACTD). This program can be turned into reality, and start bringing invaluable preparedness information and vital new emergency response capability to the nation's top 56 EOCs and the hundreds of thousands of first responders they can reach.


Charles Jennings has come up with an important idea that can get things kicked into high gear, an idea that will have an immediate impact this year. It also requires no supplemental funding on the federal level, and will give local governments precisely what they have been clamoring for. He is working directly with Neil Patel in the Vice President's office. Ken Adelman is also helping out.

I will be in Washington next week, and would love to get you together with Charles. He's in Portland, Oregon, but given a day's notice can fly out. The best time for him would be any time next Tuesday or Wednesday or Thursday morning. He has more information that I don't want to discuss in this note that you especially should hear.

USAID contracts go to porn purveyor

The U.S. Agency for International Development has awarded nearly \$170 million in contracts to manage health programs, including those designed to curb sexually transmitted diseases, to a company founded by a man who has since become one of America's largest purveyors of pornography.

The contracts, according to USAID records, went to Population Services International Inc. (PSI), a nonprofit corporation founded in 1971 by Philip D. Harvey, who also created and operates a \$70 million-a-year pornographic mail-order distribution business in North Carolina known as Adam & Eve.

Mr. Harvey serves as a PSI board member.

He also is a founder and board member of DKT International, a District-based charitable organization that manages social marketing programs in nine countries — mainly involving the distribution of condoms.

DKT International reported \$40 million in operating revenue last year, with \$39 million in program and administrative expenses, according to Internal Revenue Service documents.

Officials at USAID, an independent agency funded by taxpayer dollars to provide economic development and humanitarian assistance around the world, told The Washington Times on Friday that Andrew S. Natsios, the agency's administrator, has "ordered an immediate review of the PSI contract."

"He was not aware of Mr. Harvey's business activities outside of PSI," a USAID spokeswoman said.

A spokesman for Sen. Richard G. Lugar, Indiana Republican and chairman of the Senate Foreign Relations Committee, which oversees USAID, did not return a call for comment.

Mr. Harvey created Adam & Eve in 1974 as the country's first mail-order condom distributor. Since then, the firm and its parent company, Phil Harvey Enterprises Inc., offers a wide range of products, including X-rated videos and photographs, lingerie, sex toys and "love dolls" — all available through the Internet, a wholesale branch, three retail stores and at-home parties.

Last year, 1.5 million customers bought nearly \$70 million worth of Adam & Eve merchandise.

Mr. Harvey told The Washington Times there was no conflict of interest concerning his ownership of Adam & Eve and his involvement in PSI, saying he was "simply serving as a board member."

While his PSI responsibilities included oversight of the firm's financial accountability, he said he has no managerial role and is paid "absolutely nothing" as a board member.

"I don't see any conceivable conflict in being a businessman with serving nonprofit organizations. Indeed, the confluence of interests seems to have worked well over the last 30

years," said Mr. Harvey, who served as PSI's chief executive for seven years after its 1971 founding.

PSI President Richard A. Frank said that while Mr. Harvey founded the nonprofit organization and remains on its board of directors, he has not had management responsibilities for decades.

"He is not involved in PSI nor is PSI involved in whatever you just mentioned, whatever it's called," Mr. Frank said when asked about Adam & Eve. "We have nothing to do with what he does in his private life and I don't know much about his private life but it has zero to do with us."

PSI contracts include a June award of \$90 million over five years to curb the spread of HIV/AIDS and other sexually transmitted infections in Africa and other countries, and a December award of \$3 million over four years to increase the capacity of local health organizations in Burundi in HIV/AIDS prevention.

Also, a \$75 million 1997 contract to begin an HIV/AIDS prevention program in 29 countries, and a \$1.4 million contract in November for a health communication program in Afghanistan to combat life-threatening childhood illnesses.

A Justice Department anti-pornography task force targeted Mr. Harvey for seven years.

"There's no doubt he was violating federal obscenity laws when we targeted him in the mid-1980s," said a former federal prosecutor. "He was distributing and selling obscene materials and was under indictment in several jurisdictions.

"But he knows how to use the system, how to delay the process and when he brought a lawsuit against the Justice Department in our case in 1993, [Attorney General Janet] Reno dropped the case in exchange for him dropping the suit," the former prosecutor said. "That's what happened, pure and simple."

Mr. Harvey, who said he has a "long-standing interest in international family planning and the social marketing of condoms and other contraceptives and related products," has since emerged as a sex business icon, joining Hustler founder Larry Flynt on stage for a keynote address before the Free Speech Coalition in November 2001.



Here's what I've found out about MoveOn.org:

MoveOn org was founded in on in September 1998 by two Silicon Valley entrepreneurs, Joan Blades and Wes Boyd, who were against the impeachment of President Clinton. They organized an online petition calling for Congress to Censure President Clinton and then move on. Creating a sense of community with online chat rooms and active e-mail lists, they have grown into a formidable online grassroots advocacy organization, raising and donating close to \$2 Million in the 2000 election cycle, and over \$1 Million in the 2002 election cycle. Group participation is one of their hallmarks, and soliciting opinions through e-mail and via their website chat-rooms they have developed a system for their users/members to vote on what issues MoveOn.org focuses on. These issues have included impeachment, campaign finance reform, energy conservation/consumption, and Iraq.

Their tactics include online petitions, organizing members for phone and fax protests, and raising money for candidates and issue advocacy commercials. Their most recent activities include airing a series of TV ads against a possible war in Iraq (knock-off of the Daisy ads Johnson aired against Goldwater) and a phone and fax protest to Congress and the White House on Feb. 26, 2003 protesting a possible war in Iraq. According to the Staff Secretary's WH Comment Line Office, approximately 2,000 phone calls to the White House received on Feb. 26 were people calling that had signed up to call on MoveOn.org's website.

MoveOn.org has joined a loose coalition organized under the name Win without War in an effort to pool resources to voice opposition against a possible war in Iraq. Other members of this anti-war group include: True Majority (founded by the Ben & Jerry ice cream founders), the Sierra Club, the National Organization for Women, Physicians for Social Responsibility, the Rainbow/PUSH Coalition, and Business Leaders for Sensible Priorities.



BEGALA: Welcome back to CROSSFIRE. By all accounts, White House senior adviser Karl Rove is one of the most influential members of President Bush's inner circle. According to a new book, he's even more than that. Authors James **Moore** and Wayne **Slater** say Rove is really "Bush's brain." They are here to explain how Karl Rove made George w. Bush presidential.

Gentlemen, good to see you.

(APPLAUSE)

CARLSON: Now, Mr. Moore...

JAMES MOORE, CO-AUTHOR, "BUSH'S BRAIN": Yes, sir.

CARLSON: ... before we even get inside your book, let's consider the title: "Bush's Brain: How Karl Rove Made George W. Bush Presidential." It's kind of a sly way to imply the president's not quite presidential.

MOORE: Never meant to be pejorative. From the beginning, that has been Karl's nickname in Texas. He is Bush's brain. He's the brainy guy who comes up with the policies, the strategies, the issues that would drive him to become governor, to become president.

CARLSON: So it's not another way of saying that the president is not very bright and that he requires someone to sort of do the heavy lifting for him?

MOORE: What I'll say, Tucker -- what I'll say is this: that they are two parts of one creature. The president is a very capable man. He is intelligent, and whatever else you say about the president, he has leadership genius, a kind of genius of his own.

He makes decisions, he has certitude. People are drawn to him. What he lacks, however, is the

intellectual depth which Karl gives him. Karl groomed him.

(APPLAUSE)

MOORE: Karl groomed this man to become president of the United States. George Bush was a candidate before he knew it in 1990.

BEGALA: And Wayne, you guys go even beyond that. Let me read you out of the book. "The end result is obvious," you write. "Karl Rove thinks it, George W. Bush does it. That's the way it works and it works well." "Rove is," you write, "the co-president of the United States, and Americans cannot deny his influence."

WAYNE **SLATER**, CO-AUTHOR, "BUSH'S BRIAN": Why are you surprised? You know Rove. And the fact is, Rove was not only the co-president in the way that we've written it, he was the co-governor in Texas, where Jim and I covered the governor. He was very much a part of that administration, although he wasn't officially in the state house.

He was a co-candidate. He was the person who, in 1990, was putting together the plan, even before George Bush knew that he wanted to run for governor. Certainly didn't know he was going to run for president. Karl Rove had details, a detailed plan how to make George Bush the president of the United States is one decade.

BEGALA: But why is that -- first off, I do know Karl and I like him. So I'm burdened with that history with him. I actually do like Karl from my years of knowing him in Texas. Why is that a problem? Lincoln had Willie Herndon. You know FDR had Harry Hopkins and Harold Ickes. You known I was a political consultant who worked for the president of the United States.

SLATER: Bill Clinton had you. And obviously extraordinarily capable people. You did a great job for Bill Clinton.

You look at Mike Deaver with Reagan, great job. You look at other people. Let me tell you why Karl is different, despite your considerable gifts.

You've got three people around the president. The president's had people who were political, great advisers. People who had policy, very good on the issues. Or people who have known them for years, a long time.

Our book shows that Rove brings all three elements. He's a brilliant political tactician. I think you would agree.

BEGALA: Sure.

SLATER: He is an extraordinary guy with respect to policy; at least he believes he is. He's moved into policy. And he was the man who was with George Bush, making him the president of the United States, driving the campaign for governor even before George Bush knew it.

MOORE: Let me add this difference, Paul. The difference in Karl's case is that, when Clinton decided he wanted to be president, he had the vision; he had dreams. He had things he want to accomplish politically for himself and for the country in terms of policy. And then he went out and he looked for Paul Begala and James Carville and said, guys come help me do this.

In this case, it was Karl Rove who identified George Bush. George Bush didn't have the ambition, George Bush didn't have the vision. And Karl Rove actually created his candidacy and groomed him to make him president.

CARLSON: But back to Karl Rove himself, I want to get to the point of the book that sort of annoyed me the more I thought about it. You have a description in here...

MOORE: Glad to be of service.

CARLSON: Well, yes, thanks. You make essentially the allegation that in the mid '80s, during a campaign Karl Rove was running, a campaign for governor, planted a bug in his own office, blamed it on the other guy...

MOORE: Right.

CARLSON: ... and thereby affected the outcome of the race. That's not the point that annoyed me. What annoyed me is you don't come out and say it. You attack him by innuendo.

You say, well, was it was a coincidence? Not even Karl Rove is that lucky. Lucky Karl. Look, if you're going to make an allegation, why not just make the allegation? Why not just say so?

MOORE: Why not let the evidence speak for itself? It's much more powerful if you let the FBI report, which contradicted everything Karl said, speak for itself. If you let the FBI agents "speak for itself" that contradicted Karl.

If you let all of that material -- the woman that he had dinner with who said he was bragging about the fact that he had done this and gotten away with it and was full of himself. Why not let that...

CARLSON: Well, I'll tell you exactly why. Because it's weasly. If I say to you, you know, Mr. **Moore,** you're not the brightest guy in the world, probably not the highest IQ. You say, are you calling me dumb? No, I'm not calling you dumb. I'm just saying you're not maybe that smart.

MOORE: Do you want me to say it here, Tucker?

CARLSON: Yes -- no, my point is -- yes, why don't you say it.

MOORE: I don't think -- I come from a journalistic background. This is the first kind of point of view writing I've done. But I felt that the case was very, very strong that the evidence spoke for itself and that people could read it. And I didn't need to push them off the cliff to get them to come to that conclusion. They came to it on their own, and I feel it's more effective that way.

BEGALA: Wayne, let me ask you about another place in there. The promotional materials for the book include this sentence: There is, "a possibility that Rove may have committed perjury while providing testimony in sworn documents."

As someone who has spent a lot of times defending false charges of perjury, I was not persuaded by this book, candidly, that Karl committed perjury. And what's your proof? And if it's strong enough, why do you couch it in those kind of weasly words?

SLATER: Well, it is strong enough. In this particular case, Karl said one thing in federal documents that had to do with international broadcasting, a job that he had. And clearly, in other documents, in other conversations, clearly what he said it testimony, what he said was wrong. It was absolutely wrong.

Now you may not think that's perjury. In fact, I may not think that's perjury. But it was wrong, it was in error. He was saying something that was not true under oath.

And I know another case. That wasn't the only one. There was another case in the book where he was defended Kay Bailey Hutchison, who was then a U.S. senator at the very beginning of her term, and went to the witness stand and said things that were --- I'll defer to your sensibilities --- that were untrue under oath.

And in that case, I can guarantee you they were untrue. Why? Because they were about me and the media. And I can just tell you -- and other members of the media. And what happened in her case that had to do with her campaign. It was untrue. Not just once, but twice.

MOORE: You know what happened?

CARLSON: I am sorry, Mr. Moore. We're going to have to leave it there because we are completely out of time. Jesse Jackson is taking up golf.

DAVID BLOOM, co-host:

Karl Rove is a political guru who's been called everything from boy genius to co-president and lots of other things. Rove is a senior adviser to the president. His role is so unique, his relationship with the president so close, a new book is calling him "Bush's Brain." It's written by Wayne **Slater** of the Dallas Morning News and former television correspondent James **Moore**.

Gentlemen, good morning.

Mr. WAYNE **SLATER** (Bush's Brain: How Karl Rove made George W. Bush Presidential): Good morning, David.

BLOOM: I can just hear people at home saying, 'Co-president, Bush's brain, that's ridiculous.'

Mr. JAMES **MOORE** (Bush's Brain: How Karl Rove made George W. Bush Presidential): Well, I'll tell you what, he was co-candidate; he was co-governor. This is a guy who not only gave the president the vision to run for president, but he--he groomed him. This is a guy who made George Bush a candidate before George Bush even knew he was a candidate. In 1990, he was talking about George Bush becoming president. George Bush wasn't even governor of Texas yet.

BLOOM: OK, but wait. Aren't you guys intentionally overstating the case to sell books or do you really think he is Bush's brain?

Mr. **SLATER:** Well, look, George Bush--w--we know George Bush and we've covered him for 15 years. He's not a stupid guy. These people who say he's a dim bulb are wrong. He's very bright, but he has kind of a leadership genius. He has a wonderful way with people. He has an ability to sift through details and make decisions and have--has a certain certitude about those decisions. What he does not have and what Rove has always brought from the very beginning of their relationship is a tactical, political sense. How do you get elected and once you're elected, how do you consider public opinion?

BLOOM: But lots of people, I mean, have had this. James Baker was that to the--to the former President Bush. What makes Rove unique here?

Mr. **MOORE:** The difference is that Rove picked out Bush. When Bill Clinton decided to become president, he had a vision. He had ideas. He had things he wanted to do and he went out and hired a...

BLOOM: So he went and found Paul Bel...

Mr. MOORE: He found Paul Begala.

BLOOM: ...Begala.

Mr. **MOORE:** In this case, what happened was Karl looked at George Bush and said, 'This guy would be president.' And then he gave George Bush ambition. He gave him vision; he gave him policy; he gave him politics and strategy, and they took off. They're two--they're two heads on the same body, and that makes them a formidable team.

BLOOM: We see them right now in that video in--in former first lady Hillary Rodham Clinton's office, and--and as we know at the White House, proximity is everything.

Mr. **SLATER:** Proximity is everything. Let me tell you, when--when--you--you talked about the co-president idea; he's co-president in the sense that...

BLOOM: Again, I think a lot of people would--would say that that's absurd.

Mr. **SLATER:** I know. I know they would. He--but he is--if you read the book, he is in the sense--and I know you have--but he is in the sense that--that he was co-governor of Texas. No important policy decision crossed Bush's path without Rove's imprimatur.

BLOOM: Let's talk about a specific issue: Iraq. The country is very focused on whether we're going to go to war or not. Explain to me why you believe Karl Rove has--has been very influential in this whole focus on Iraq and say, off of, some people would say, the war on terrorism.

Mr. **MOORE:** Karl didn't wake up and say, 'Mr. President, if we go to war with Iraq, it's going to help us avoid criticism over not being able to find Osama bin Laden. It's going to distract from the economy.' But when he's in that room full of advisers, he--the president is listening to him. And when Karl is saying he's in favor of certain things, he knows that domestic politics is driving it. There's a lot of upside for--for us taking control of Iraq in terms of domestic policy.

BLOOM: So you say domestic-you say domestic politics is driving it. People would say-they would scoff at that notion. I mean, say the country, they would say, is--is deeply--at best reserved--at best--maybe distrustful of why we're going to war.

Mr. SLATER: There actually are advantages, considerable political advantages, and Karl is the

person who has thought through those political domestic advantages.

BLOOM: Like what?

Mr. **SLATER:** Here's one advantage: Although there's been a lot of criticism about going ininto the Middle East and creating instability, one possibility is, this goes well for the United States and goes well for democracy and the president looks good. Moreover, the oil fields there are stabilized, not because American troops are in charge, but because a regime that's better for America, that's better for our economy.

BLOOM: But don't--but don't people like the secretary of State, the secretary of Defense, aren't they the ones thinking like that? You're saying that Rove is the one in the end who's bringing all those political calculations together?

Mr. SLATER: Absolutely.

Mr. MOORE: Absolutely. No question.

Mr. **SLATER:** Don Rumsfeld, Richard Pearl, Paul Wolfowitz--those people who are advisers are deciding and are making recommendations on policy. What Karl makes recommendations on and considers considerably are the politics.

BLOOM: I want to talk about he--the dirty tricks part of this book, I'll call it. I mean, one of the things that you guys try to do is go back over Rove's career and say, 'He's--a lot of things that happen here, maybe they weren't just coincidence.' You--you cite one incident involving a gubernatorial race where Rove's office was supposedly bugged...

Mr. MOORE: Right.

BLOOM: ...which tainted the rival gubernatorial candidate and you suggest that maybe Rove or his cohorts are the ones who did the bugging to--to try to hurt that candidate.

Mr. **MOORE:** I--I was there that day, David. And there wasn't a reporter in the room who didn't think Karl in that campaign bugged that room. Nobody took that news conference seriously. And in the book--if you look in the book, there--there is an FBI report which completely contradicts Karl's assertions that he didn't have anything to do with it. There is an FBI agent who makes a quote that he thinks--and the--the investigators thought that he did it. There was a woman that Karl had dinner with, said Karl was full of himself, bragging and taking credit for it.

BLOOM: OK, I can hear a lot of folks saying, you know, this is inside baseball. I don't really care what happened to Karl Rove. Why does this matter to people now?

Mr. **SLATER:** You know, let me tell you one reason why it matters and multiply it by a million. Karl Rove was influential in deciding--recommending to the president that he apply steel tariffs. This is a free-market president, but when it same to steel tariffs, Karl Rove convinced the president we ought to have these tariffs. He--he can make the case politically--make it in terms of policy, but the truth is, it will help Bush ...

BLOOM: He was going after Ohio, Pennsylvania and Michigan.

Mr. **SLATER:** He was Ohio--he was going after Ohio and Pennsylvania. But what's the result for you and me, David? Next time we buy a car, it's more expensive.

BLOOM: OK. Wayne Slater, James Moore. Thank you both so much.

Mr. MOORE: Thank you.

BLOOM: Appreciate it.
