FOIA 2023-0148-F requested materials related to correspondence between Harlan Crow and President George W. Bush between January 2001 and January 2009.

This FOIA primarily contains copies of form letters to individuals and families regarding the George W. Bush Presidential Library, correspondence regarding a candidate recommendation for the Medal of Freedom, birthday greetings to certain members of the Crow family, and a letter signed by members of the Trinity Commons Foundation with copies of reply sent by the Department of the Army.

System of Arrangement

The materials in FOIA 2023-0148-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – White House Office of Records Management (WHORM) Subject Files.

The White House Office of Records Management (WHORM) contains a variety of series created to organize and track documents and correspondence. The WHORM Subject Files and Alpha Files were compiled by staff in the White House Office of Records Management and are a series of documents assigned a letter/number combination and filed in a series of categories by subject. WHORM Subject Files and WHORM Alpha Files are processed at the document level.
