Dear Mr. President,

We commend you for proposing the Emergency Plan for AIDS Relief, a five-year, \$15-billion initiative to assist millions globally affected by HIV/AIDS. We believe that your principles as outlined are the right approach to stem the tide of this devastating epidemic. In order to be effective, any global AIDS legislation should be built around the following pro-family, pro-life principles that we share with you:

- 1. Prevention through proven methods: the Ugandan ABC model.
- 2. Treatment that emphasizes family preservation.
- 3. Pro-life: no funds for abortion providers.
- 4. Bilateral aid governed by U.S. policy—not UN policy.
- 5. Faith-based participation and protection.
- 6. Prevention through initiatives to combat sexual violence.

1. The ABCs of Prevention: Prevention programs that address behavior must emphasize risk elimination. Uganda's successful "ABC" prevention approach prioritizes abstinence, being faithful to a monogamous partner, and only then, condoms. Ugandans have overwhelmingly responded to this campaign with a dramatic delay in the onset of sexual debut by teens, a reduction in the number of sexual partners, and, as a result, an even more dramatic decline in HIV incidence. On the other hand, the African nations that have promoted only condom use and have the highest condom user rates on the continent—South Africa, Zimbabwe, Botswana and Kenya—also tend to have the highest HIV prevalence rates. Historically, U.S.-funded programs have largely ignored the "A" and "B" and emphasized and supported only the "C" in the ABC approach. USAID is the world's largest supplier and distributor of condoms. Condoms must no longer be treated as a panacea of HIV prevention. U.S. global HIV/AIDS prevention must reprioritize and espouse in practice and principle the successful Uganda and Jamaica approaches by making risk avoidance—abstinence, delaying sexual activity, marriage and monogamy—the primary defense against HIV.

2. Family Preservation through Treatment: Nearly 30 million Africans are living with the AIDS virus-- including three million children under the age of 15. Due to the high cost of treatment and the vast number of those infected, the President's \$15-billion initiative—even combined with other efforts—will unfortunately still not be enough to treat everyone in need. Because many of those who are already sick, are parents of children who will be orphaned and join the ranks of 14 million other AIDS orphans worldwide, treatment programs must emphasize family preservation. Prioritizing treatment for pregnant women and families with children will help alleviate the ever-growing epidemic of AIDS orphans who have lost their parents to HIV

and maintain social order. This approach will also reduce perinatal HIV transmission to newborn children, ensuring fewer Africans begin life already infected with HIV.

3. Pro-life: no funds for abortion providers.

Abortion is not AIDS prevention or treatment, and groups that promote abortion promote a "safe sex" agenda that will not save lives. The existing "Mexico City policy" that protects federal international family planning funds from being used to subsidize organizations that perform or promote abortion does not apply the same abortion-related restrictions to federal HIV/AIDS funding. As a result, such organizations are currently being subsidized with tens of millions of U.S. taxpayer dollars intended to assist people at risk or infected with HIV. The moral integrity and effectiveness of U.S. global AIDS funding must not be threatened by being permitted to be used to subsidize organizations that perform and promote abortion.

4. Bilateral Aid: The United States should exercise strict control over the dispersal of global AIDS funds through bilateral agreements rather than relying on international bureaucracies, such as the Global AIDS Fund. The Global Fund is not accountable to the U.S. government or the taxpayer. Any funds we provide to the Global Fund are not subject to U.S. federal laws and could be used to pay for injection drug equipment for addicts, abortions, political advocacy and other objectionable activities. The Global Fund is an untried entity with no record of success. With the lives of hundreds of millions currently at risk, time and resources are precious. Every cent that is spent on bureaucrats and bureaucracy at the Global AIDS Fund or other international entity is that much less that will reach those affected by AIDS we are attempting to assist. Moreover, bilateral aid should be governed by U.S. policy, not bound by UN policies, such as the UN Declaration of Commitment on HIV/AIDS.

5. Faith-Based Organizations: Faith-based groups must be a key element of all HIV prevention and AIDS treatment programs. Successful HIV prevention programs in Uganda, Jamaica and elsewhere have made local churches and faith-based groups central to efforts to promote behavior changes to prevent HIV, to reduce stigma associated with HIV infection, to treat those afflicted with the disease and to care for orphans. The Catholic Church alone currently cares for one in four people being treated for AIDS worldwide. Religious missionaries already possess much of the infrastructure, experience, knowledge, and compassion that will be needed to carry out these programs and must be an integral part of U.S. efforts. Church groups and Christian organizations must also be protected from being coerced from promoting activities that violate or contradict their faith as a condition of receiving U.S. financial assistance.

6.Initiatives to Combat Sexual Violence: Any effective initiative to combat the spread of HIV/AIDS must aim to protect the population that is both key to its spread *and* totally unprotected by all other HIV/AIDS protection programs – namely, the victims of sexual violence, particularly rape and sex trafficking. Traditional prevention strategies seek to encourage and empower healthy choices about sexual behavior, but victims of coercive sexual encounters do not get to make choices about their sexual activities. In South Africa for example, the ever-increasing spread of AIDS can be traced back to a simple fact – with one in nine South Africans living with AIDS, sexual assault is tantamount to a death sentence for the one in three women raped there. Meanwhile in Cambodia, considered by many to be the new sex tourism capitol of the world, it is not merely coincidental that as many as 40 percent of sex workers are infected with AIDS and the

country has the highest rate of increase of HIV infection in all of South East Asia. Clearly, the most urgent priority and the greatest opportunity for leveraged impact are in programs and initiatives that promote the reduction of sexual violence through rule of law and criminal accountability.

Dear Mr. President:

We write because we share the view that it is essential to bring Saddam Hussein's dictatorship in Iraq to an early end. Broad and bi-partisan support at home -- not simply passive assent -- must be sought for this objective. It is a deeply serious undertaking, with great risks, heavy costs and long-lasting

responsibilities. Steps are also needed to respond to misconceptions abroad about the underlying causes of this conflict and your purposes that feed an ugly anti-Americanism. We must act alone if that proves necessary, but first we must do all we can to win allies.

We believe you can now alter the course of this debate by making a clear and specific statement about your plans for helping to lay a foundation for representative government, freedom of speech, human rights and the rule of law in Iraq. Time and again, the commitment to human rights and democracy has been the saving grace of American foreign policy.

The legal and procedural issues now before the United Nations are immensely important. The threat Iraq and its weapons pose to us and to others is truly grave. But attention to these matters must not allow us to lose sight of the vast and continuing cruelty of Saddam Hussein's rule, or the possibilities that will be created by his departure. Inadequate concern for the plight of the people of Iraq and for their future has diminished debate about Iraq here and, even more so, abroad.

Many here and abroad who question the wisdom of going to war nevertheless acknowledge that the Iraqi dictator is among the most oppressive and vicious rulers of our time. A Special Rapporteur for the United Nations Human Rights Commission has described his abuses as ???the worst since World War II.??? For many years Freedom House has rated Saddam Hussein's regime as among "the worst of the worst" violators of political and civil rights, and Human Rights Watch has called for his trial for crimes against humanity. After the Balkan catastrophes, it is widely acknowledged that war criminals should not be granted the immunities traditionally enjoyed by heads of sovereign states.

Many in your Administration are clearly committed to helping establish democracy in Iraq. But some at times have questioned the value of such ???nation building,??? have shown reluctance to make farreaching international commitments, or have been hesitant about steps that may unsettle traditional allies. So far, your Administration's plans for American political and humanitarian assistance to post-war Iraq leave some significant uncertainties. The budget just passed by Congress includes little money for the substantial reconstruction effort that will almost surely be needed. Nor is it likely that such costs will be paid unless those asked to shoulder them can see that they are fairly shared.

There are those who fear that ???regime change" in Iraq may not mean that a new regime will necessarily be a free and democratic one.. There are those who fear that once we have satisfied our own security concerns, we will become indifferent to the security needs of those in Iraq and elsewhere in the region who have helped us. You can challenge these doubts and appeal to those who abhor Saddam Hussein by announcing a plan to help establish freedom and democratic self-government in Iraq.

In our view, such a strategy should commit the United States to

?? Maintaining substantial U.S. military forces in Iraq for as long as may be required to ensure a stable, representative regime is in place and functioning.

?? Insisting that genuine democracy must be based on the free choice of all Iraqis who reside in the country. During a transition period, U.S. military authority and the efforts of pro-democracy Iraqis should be supplemented by the presence of monitors and technical experts drawn from societies that have been through the difficulties of change from authoritarian to democratic rule, especially those who are adherents of Islam.

?? Insisting that democracy must be much more than the election of a government. It will require guarantees of civil and political rights, freedom of the media, freedom of religion, the impartial administration of justice, and the other bedrock practices and institutions of democratic governance. It will require the development of institutions of civil society as well as those of politics and government.

?? Recognizing the legitimate concerns of distinct ethnic and religious groups within Iraq, and assisting in the creation of a federal system that sustains Iraq's integrity while permitting latitude for local administration.

?? Guaranteeing that Iraq's oil wealth will be used for the benefit of the Iraqi people, and explaining how this will be accomplished.

?? Assuring that adequate resources will be available for this undertaking, even if many among our traditional allies shirk their responsibilities.

We believe that a significant body of opinion can be persuaded of the view argued by Prime Minister Tony Blair: "Ridding the world of Saddam would be an act of humanity." A clear statement of your plan for supporting democracy and human rights in Iraq and elsewhere in the Middle East will help us all reach out to those who are open to this truth.

Homeland Security Considerations for the State of Hawaii

Thank you for your continued leadership in our nation's war on terrorism and for your support in building stronger state and local government response capabilities. I am confident that under your leadership, the nation is prepared to prevent a terrorist attack and to respond to its consequences. I recognize, as do many other governors, that much of the progress we have made is a direct result of your untiring efforts to literally fight for the resources we need at all levels of government while being concerned for the needs of private industry and our citizens.

Hawaii has benefited from your efforts. We are currently in the midst of implementing recent federal awards made available through the FY 2002 Supplemental Appropriation that you worked very hard for. An assessment of our State Emergency Operating Center is nearly complete; one of two video teleconferencing systems has been installed; and funds earmarked for planning, Citizen Corps councils, and to support development of Community Emergency Response Teams have been distributed to our four county mayors.

Like other states, Hawaii's growing needs in homeland security far exceed State and county fiscal resources. We will need your continued and strong support in our efforts to prevent terrorism and for programs that protect our citizens and critical infrastructure. A recent survey of our homeland security needs indicate that we require substantially more for critical systems and facilities. The Honorable Tom Ridge February 19, 2003 Page 2

While we are grateful for the support we have received, I believe that Hawaii's unique circumstances with respect to its strategic importance to U.S. defense interests in the Pacific and Asia merit your special consideration in terms of policy and program development. Military commands and other Federal agencies based in Hawaii serve a vital role in maintaining regional stability to include an active role in deterring foreign terrorist groups.

In light of our unique circumstances, I feel strongly that the prevention of a potential terrorist attack against Hawaii is our first task. As such, I recommend that you establish a Department of Homeland Security Regional Office in Honolulu. A regional office in Hawaii will effectively orchestrate Federal resources and help to accommodate the special homeland security needs of the State and other Pacific insular jurisdictions. I further seek your support for robust Federal intelligence and information sharing systems to prevent or to interdict terrorist acts against Hawaii and other U.S. interests in the Pacific.

As you are aware, the insular nature of our State places a tremendous responsibility on the State and counties to be prepared for emergency response operations in the event of a terrorist attack. Rapid assistance to affected counties in terms of law enforcement, security, medical treatment, isolation and containment, decontamination if applicable, and continuity of government will challenge the State's emergency response system.

I ask for your support for policies and programs that expand State, Hawaii National Guard, and local emergency response capabilities to include funding to establish a Pacific Training Facility for Homeland Security. I will be happy to share a listing of our specific requirements in homeland security with appropriate members of your directorate.

I cordially invite you to open our Hawaii Homeland Security Symposium, to be held in Honolulu during the period of November 19-21, 2003. A proposed topic would be the National Homeland Security Strategy and the role of states in support of that strategy.

Please accept my sincere thanks and appreciation for your steadfast and continuing support to secure our Nation from terrorism.

The NAM's Strategy for Growth and Manufacturing Renewal

Whereas, American Manufacturing is essential as ever to the strength of the American economy and its prospects for future growth and is as central to our national security as it is to our economic security; and,

Whereas, the manufacturing sector for decades has accounted durably for about 25% of U.S. economic output and the overwhelming percentage of American exports, and continues to do both today while leading the economy in productivity; and,

Whereas, manufacturing in the United States is innovative, efficient and productive with the best workers in the world, technologies on the global cutting edge and R&D programs and efforts capable of keeping it there; and,

Whereas, manufacturing is challenged as never before -- finding itself on the front lines of the most intense global competition in history which makes it virtually impossible to raise prices even as costs continue to rise for many reasons including actions by government or its failure to act; and,

Whereas, the costs of domestic production for reasons ranging from health care inflation, and regulatory and legal burdens to volatile energy prices have combined with slow economic growth domestically and around the world, a persistently overvalued dollar, terrorism and geopolitical uncertainty, to increase the complexity of the challenge facing manufacturing; and,

Whereas, the economic climate has yielded the slowest manufacturing recovery in decades and a decline in manufacturing employment totaling a loss of two million jobs, despite productivity gains and threatening a loss of the critical skills associated with them; and,

Whereas, an effective strategy for manufacturing renewal to reverse these adverse trends depends in large part on the enactment and implementation of an effective policy agenda for growth by Congress and the Executive Branch as articulated in the NAM's Agenda for Growth and Manufacturing Renewal for the 108th Congress; and,

Whereas, among the priorities in that agenda, special emphasis must be placed on:

- **Tax policy** that enhances economic growth and encourages productivity through technology and investment incentives;
- **Trade Policy** that levels the global playing field for American manufacturers by opening markets, lowering tariffs, modernizing export controls and sanctions policies, enforcing trade laws and achieving market driven currency valuations;
- **Cost-cutting reforms** that will permanently improve the legal, regulatory, health care and retirement systems while lowering the anti-growth and costly job-destroying burdens they currently impose;

- A national energy policy is essential to ensuring sustainable economic growth in manufacturing, with emphasis on reliable supply at affordable prices, conservation, increased efficiency, strengthened infrastructure, and investments in new technologies.
- Asbestos litigation and the legal system are especially ripe for reform as the explosion of asbestos liability has bankrupted companies, cost workers their jobs and threatened retirement savings with an accumulated present and future liability burden of \$250 billion acting as an anchor on manufacturing's ability to recover;
- **Technology policy** that will preserve and enhance the U.S. lead in R&D and innovation and assure protection of intellectual property and strengthen our engineering and advanced skills;
- Worker and skills enhancing efforts, first, to put people back to work and further, to empower today's workers and tomorrow's, now in school, to meet the demands and better appreciate the rewards of modern jobs in modern manufacturing.


Whereas, President Bush and his Administration have recognized the unique stresses confronting manufacturing, including the loss of employment, and have offered a number of concrete proposals to advance such an agenda, most recently in the NAM-supported program to foster economic growth, job creation and spur capital investment unveiled by the President; and,

Whereas, to further refine, clarify and advance a broader public awareness of the centrality of manufacturing, the pro-growth policies needed to maintain it and the nature and magnitude of the challenges facing it, the president should appoint a Blue-Ribbon Commission, interdisciplinary and inter-departmental, to analyze each of these and to propose a strategy and plan of action for the federal government to complement private sector actions to effectively sustain U.S. leadership at the top of global competitiveness.


Now therefore be it resolved that the National Association of Manufacturers commits its energies and resources to a multi-year effort to advance this strategy for growth and manufacturing renewal with every member of Congress and other federal officials. We will seek to involve our member companies and their workers in this effort to spread the manufacturing message in Washington and around the country -- and encourage our 350 member associations to do the same; and,

Be it further resolved that members of the National Association of Manufacturers shall renew our conviction that what we seek with this strategy for growth and manufacturing renewal is in the interest of millions of manufacturing workers -- the people who make things in America – and their families, and in the broader interest of the country and the economy as a whole. Relying on a proven ability to innovate, a consistent commitment to quality and excellence in products and processes and a durable entrepreneurial spirit, modern manufacturers will do their part.
