





OHA hires lobby firm to help push Akaka bill

The Office of Hawaiian Affairs has hired a well-known law and lobbying firm in Washington to add muscle to its push for a bill that would give Hawaiians federal recognition.

The legislation — known as the "Akaka bill" after sponsor U.S. Sen. Daniel Akaka, D-Hawai'i — would create a formal process for Hawaiians to form their own sovereign government that would be recognized by the United States, much like American Indians and Native Alaskans. The Senate Indian Affairs Committee approved the bill last week, and it could now go to the full Senate for a vote.

OHA trustees on Thursday authorized a maximum of \$450,000 for expenditures by Patton Boggs, LLP, an international law firm that the board hired after conducting interviews last week in Washington, said Clyde Namu'o, OHA administrator.

The trustees will receive weekly reports from the firm to monitor their spending and progress, Namu'o said.

The firm's work will include the preparation of a report on the federal recognition campaign for the Bush administration, in the hopes of persuading the White House to support the bill, according to Namu'o.

"There's a window of opportunity to get this bill passed, and we need to do everything we can do," he said.

Patton Boggs lobbies for such heavyweights as AOL Time Warner, Mars Corp. and Sony. Its roster of about 225 lobbying clients also includes major trade associations and state and local agencies.

Thomas Hale Boggs Jr., one of its principals, is known as a prominent Democrat who has taken a personal interest in Hawaiian recognition. He is considered one of the capital's most well-connected and influential lobbyists.

Hawai'i's congressional delegation has made progress on Hawaiian recognition since Akaka first proposed the bill in 2000, but has not been able to overcome opposition from conservative Republicans. Republican Gov. Linda Lingle and her staff have approached the Bush administration for its support.

Sen. Dan Inouye, D-Hawai'i, has said that a White House endorsement is key. The Clinton administration supported a version of the bill in 2000, when it passed the House but stalled in the Senate. Last session, a version of the bill cleared the Senate Indian Affairs Committee and the House Resources Committee before being blocked.

- -a dollar value for each statistical life saved is determined based on studies of wage premiums for hazardous jobs and surveys of consumers considering purchases of safer products (e.g., smoke detectors).
- -used by EPA (\$6 million per statistical life) and FAA (\$3 million per statistical life); the same economic value is assigned regardless of age or other personal characteristics.
- —lifesaving benefits are computed as the number of statistical lives saved multiplied by the dollar value of a statistical life.
- --method is popular among environmental economists, though rarely used in public health or medicine because lives are never really "saved", though duration of life can be increased.
- -Experts: Professor W. Kip Viscusi, Harvard Law School, James Hammitt (Harvard Center for Risk Analysis) and Dr. Alan Krupnick (Resources for the Future).

THE LIFE-EXPECTANCY METHOD

- -measures the number of years of life saved by regulations that reduce probabilities of premature death from injury and disease; life tables are used to compute life expectancy gains; method is applied to "statistical" or "identified" lives.
- --a dollar value for each year of life saved is derived from "statistical life" studies (e.g., if a premature death is valued at \$3 million, and if the person had a remaining life expectancy of 30 life years, then the average benefit is \$100,000 per life year saved).
- --FDA uses a constant value for each life year saved (\$100,000 \$200,000 per life year). EPA's recent use assigns a higher value (\$472,000) to life years for those over age 65 (since remaining life years are scarce!).
- --lifesaving benefits are computed as the number of years of life saved by a regulation, multiplied by the average economic value of a year of life. (Sometimes a more advanced tool called the "quality-adjusted life year (QALY) is used, which weights each year if life according to its health-related quality).
- --in benefit-cost analysis, an explicit value is assigned to each life year; in cost-effectiveness analysis the life-year value is left implicit, for determination by the patient, hospital or policymaker.
- --the method is popular among health economists, decision scientists and physicians and is widely employed in the peer-reviewed medical literature, but is criticized as unfair to the elderly and disabled.
- --Experts: Harvey Fineberg, President, Institute of Medicine (DC), Professor Richarc Zeckhauser, Kennedy School of Government, Professor Milton C. Weinstein, Harvard School of Public Health, Professor Cass Sunstein, University of Chicago Law School.



Efrain Gutierrez, who moved to Greenville three years ago from Columbia, said he was glad a White House official came to visit but remained skeptical about whether Bush will really address the issues raised.

"The meeting is important to shed light on all the problems," he said in Spanish. "But at the same time, I don't think the answers will come as easily and quickly as has been presented to us."

One South Carolina representative who attended the meeting, Gloria Haskins, said she plans to call for a task force to study Hispanic issues at a statewide level. Haskins, R-Greenville, is Hispanic.

"I think we have a lot of work to do," she said.



DON'T UNDERCUT NEEDED FAA REFORM by Robert W. Poole, Jr.

Rep. James Oberstar plans to offer an amendment to the FAA reauthorization bill to redefine air traffic control as "inherently governmental." But recent testimony by DOT Inspector General Ken Mead shows why fundamental ATC reform is still needed—reform that Oberstar's bill would likely block.

Mead described an ATC system run for the benefit of its unions, not its users. The deals signed by former Administrator Jane Garvey boosted controller pay by 47 percent, so that the average base salary is now above \$106,000. Over 1,000 controllers made more than \$150,000 last year. The union managed to subvert the new FAA accounting system so that it cannot properly track their time—making promised productivity gains impossible to measure.

Then there's the debacle of ATC "modernization." Mead cited five major technology upgrades that "have experienced cost growth of over \$3 billion and schedule slips of 3 to 5 years," because there's "a lack of basic contract administration at every stage." The next day GAO's Gerald Dillingham described FAA's modernization effort as "plagued by cost overruns, schedule delays, and performance shortfalls."

Oberstar sings the union song about ours being "the best air traffic control system in the world." That Pollyanna view ignores a global wave of ATC reform that has seen 29 countries create high-performance, customer-responsive ATC companies. Altogether, about 30% of the world's air traffic is now controlled by these providers.

Former Vice President Gore's National Performance Review drew on these corporations as models for transforming our ATC system into a government corporation called USATS. Direct user payments would give it a bondable revenue stream to finance modernization, using businesslike procurement methods.

Unfortunately, Congress ignored USATS. When the subsequent Mineta Commission proposed a user-funded, bond-issuing business unit within FAA, Congress enacted only bits and pieces, ignoring the key financial reforms. And when President Clinton issued an executive order on those reforms, the union pounced, inserting the words "inherently governmental" in reference to the ATC system.

Last June, the Bush Administration removed those two words. That means ATC is potentially commercial and could be provided in ways other than a tax-funded bureaucracy. Though Lautenberg and NATCA portray this as unthinkable, it reflects the conclusion reached by 29 other countries.

It also reflects the judgment of four former FAA Administrators and other retired senior FAA officials. They signed a statement in 2001 declaring that "Air traffic control is a 24 hour-a-day, 7 day-a-week high-tech service business," which "can and should be

operated by a separate corporate entity, paid directly by its customers, and directly accountable to its customers for performance."

Instead of directly engaging this approach, Oberstar and NATCA attack a phantom they call "privatization," and a supposed conflict between profits and safety. But no private, for-profit ATC system exists in any of those 29 countries. All but two have created commercial but government-owned ATC corporations, and the other two are nonprofit corporations.

NATCA has also falsely claimed that near-misses in the U.K. have increased by 50% since "privatization" there. But the U.K. Airprox Board reports near-misses at record lows. Lautenberg even raises national security, justly praising our controllers for safely landing all flights on September 11th. But he neglects to point out the equally fine work of Nav Canada controllers, praised by White House Chief of Staff Andy Card.

NATCA's campaign is aimed at just one thing: undercutting fundamental ATC reform. We now know that ATC corporations are transforming stodgy bureaucracies into high-performance service providers. These reforms have enabled the same workforce, led by new top management, to become significantly more productive.

To her credit, Marion Blakey has an open mind on corporatization. As she tackles FAA's serious problems, the last thing she needs is a legal mandate to preserve ATC as a tax-funded bureaucracy. Our ATC system is broken and needs to be fixed. Congress should not preclude such reforms by law.



Dear Mr. President:

I write to express our continuing support of your pro-growth policies, and also to convey to you and your administration a conciliatory message from leaders of the French business community that stands in stark contrast to the official posture of the French government.

Your steadfast emphasis on the importance of economic growth, and in particular your insistence upon tax cuts that will encourage confidence among consumers, businesses and investors, are greatly appreciated by our members. We are working hard to rally support for your legislation around the country, with a special focus on Democratic Senators who are concerned about business investment. I am optimistic that our good friend Senator Ben Nelson of Nebraska will provide you a decisive vote.

You should know also that the French business community is extremely upset by the deterioration of relations between the United States and France, and at the policies of Prime Minister Jacques Chirac whom they believe went too far in opposing our position on Iraq. At a well-attended business summit in Montreal last week, my French counterpart, Ernest-Antoine Seillière, President of MEDEF, conveyed this sentiment forcefully in a public gathering where we both spoke. "We were horrified by the terrorist attacks suffered by your country on September 11 and shared your national grief," he said. "Whilst it is not our place to cast judgment on the way in which your country intervened in Iraq, we do share the opinion of those who believe that boldness and courage freed this country from a most terrible dictatorship. From now on, we shall strive to strengthen links and promote again the friendship between our countries."

Mr. Seillière urged me to convey this message to our members and the American business community at large. I thought it prudent to inform you of the French business community's views prior to your meeting with Chirac next month. I believe it also represents an opportunity for American business to take a proactive approach to our French counterparts to strengthen private sector activities in areas such as the Transatlantic Business Dialogue, which Secretary Evans has decided to re-launch with his European Commission counterparts.

Again, on behalf of our 14,000 members and affiliated organizations, I thank you for your courageous leadership in these perilous times, and for your continuing commitment to manufacturing. Please let me know if there is anything else we can do for you and your administration.

Opening statement of Ernest-Antoine Seillière

What could be a better context for today's discussion between a representative of entrepreneurs in the United States and France than this international forum in Montreal? Paul Desmarais knows/how much we love and admire Canada and of course Quebec. I am delighted to be here today alongside Jerry Jasinowski, the President of the National Association of Manufacturers, in this part of the American continent which was formerly French.

As French entrepreneurs, we are concerned by globalization, European construction and the specific features of French society and these are all issues that we wish to address. However, we are also preoccupied at this time by Franco-American relations.

There is no denying that the differences which emerged between France and the United States regarding Iraq produced a crisis in relations between the governments and, to a certain extent, public opinion in our two countries.

As the spokesperson for French entrepreneurs, I have been asked to say the following words to the American entrepreneurs' representative who is here beside me today:

"Jerry, the links established between us over the past decades in all fields of business are sound, friendly and often fraternal. We have developed strong affinities in the fields of commerce, finance, investment, in the training of young people and in cultural exchanges.

We share the values of freedom, responsibility, initiative and free enterprise which have fostered our common outlook on things. We admire your capacity for innovation and adaptation, your taste for success and your enthusiasm.

Without venturing too far onto foreign territory, I would nevertheless like to stress the following: we were horrified by the terrorist attacks suffered by your country on September 11 and shared your national grief. Whilst it is not our place to cast judgment on the way in which your country intervened in Iraq, we do share the opinion of those who believe that boldness and courage freed this country from a most terrible dictatorship.

From now on, we shall strive to strengthen links and promote again the friendship between our countries. We shall seize every opportunity to develop the relations, already so important, between French and American entrepreneurs in order to build a world of innovation, progress and prosperity, the values of which we both share in economic matters."

I would like to thank you, Paul, for permitting me to address Jerry with these sincere words, inspired in particular by a spirit of friendship. I would like him to transmit our message throughout his country to all our American entrepreneurial friends.





Canadian Stumpage Is Heavily Subsidized Commerce Final Decision




US Lumber Production: 1978 - 2002




U.S. Production has been flat or declining for 15 years.


Canadian Lumber Imports: 1978 - 2002




Canadian Lumber Imports continue to rise.

Canadian Lumber Imports as a percentage of total US Lumber Consumption 1978 - 2002






Random Lengths Composite Lumber Index: 1993-2002

Reshaping Medicare, Rural Roots in Mind

F: Meditare Refin CRESTON, Iowa, May 28 — When it comes to running the all-powerful Senate Finance Committee, geography is often destiny.

As the committee begins an overhaul of Medicare, it matters that the chairman is from Iowa: Senator Charles E. Grassley, Republican, farmer, a man who says he spends, on average, two nights a week in his bed on his 710-acre corn and soybean farm in New Hartford.

If Mr. Grassley has his way, the interests of rural America will loom large in the push to enact a Medicare law. And that could make life complicated for the Bush administration and its conservative allies, who want to transform Medicare from a traditional government health insurance program for the elderly to a new marketplace of competing private health plans.

Mr. Grassley, 69 and fresh from a brutal battle over tax cuts, in which his committee also played a central role, describes his challenge on Medicare as twofold: getting enough Democratic support for a bill to prevent a filibuster, and holding onto the more conservative Republicans that he describes as "the purists."

Along the way, he wants to raise the reimbursements for doctors and hospitals in rural areas and look after the interests of elderly beneficiaries in places like Iowa. They are overwhelmingly reliant on traditional Medicare and skeptical that health maintenance organizations and other private plans will ever really be accessible to them. And not without reason.

Until now, H.M.O.'s have not been available to Medicare beneficiaries in many rural areas.

"I don't have any quibbling with the desires of my colleagues who are more purist," Mr. Grassley said one night recently, over an Iowa pork chop. "But the practical thing is, you've got to sell it here at the grass-roots, not only in Iowa but all over the country."

That means promising people, he said, that they can stay with the traditional program, where they have free choice of doctors and hospitals, and still get a comprehensive new drug benefit. In contrast, the Bush administration and many of its conservative allies would prefer to use drug benefits as an incentive to entice people into the private plans; as a result, they have proposed offering far less generous drug coverage in the traditional program.

As Mr. Grassley made the rounds of town meetings in southwestern Iowa this week, he said that he disagreed with that approach. Asked by a skeptical doctor at a meeting in Atlantic whether Mr. Grassley would not, in the end, push the Bush plan, the senator replied: "No. Well, some elements of it would be."

"But let me explain," he added, while about 75 Iowans hung on his words. "When it finally got said and done, Bush never had a bill to present to Congress, because they didn't really know what they were doing. Not that their ideas were wrong, but they didn't have them well thought out, or put together in a perfect piece of legislation. So they ended up just establishing some principles.

"Now, those of us who have been working on Medicare and prescription drugs for the last two or three years, we feel like we know how to do it. So what we finally talked the president into, back in probably February or early March, was, `We ain't going to wait for a bill; we're going to go ahead.' "

Mr. Grassley added, very plainly and carefully, his words highlighting the political risk of this issue: "We're going to give seniors a maximum of choice. If they want to keep their current Medicare, they can get it with prescription drugs. And if they want to go into a new Medicare, they can get that with prescription drugs, too."

Mr. Grassley is hardly the only member of the Finance Committee who is sensitive to rural America. In fact, the 21-member committee also includes senators from Montana, West Virginia, South Dakota, North Dakota, Maine, Vermont and Wyoming. It makes a difference, Mr. Grassley said, and he added, with a smile, that New York did well on Medicare issues when Senators Daniel Patrick Moynihan and Alfonse M. D'Amato of New York were on the Finance Committee.

The committee is expected to begin voting on a Medicare bill in early June, and Republican leaders in the House and Senate hope to act on the legislation before the July Fourth recess.

It will require Mr. Grassley once again to work closely with his counterpart in the House, the chairman of the Ways and Means Committee, Representative Bill Thomas, Republican of California. The tension between the men was apparent, repeatedly, in the battle over tax cuts.

Mr. Grassley said he assumed the relationship had healed, but added, "Have you ever seen him explode?"

"I just say the reality of it," said Mr. Grassley, who struggled to hold together his party's one-vote majority on the committee. At one point, Mr. Grassley said with some amusement, he told Mr. Thomas that more changes were needed in the tax bill to hold the Republican Senate moderates, and Mr. Thomas stormed from the room — even though it was his own office.

"They don't understand us," Mr. Grassley said of the House. "I can understand them. I served in the House. What it amounts to is, the majority party can get anything done they want to get done there."

Not so in the Senate, where some say Mr. Grassley will need significant Democratic support to get a bill passed.

"If this proposal significantly moves toward privatizing Medicare, I think there's a reasonable chance that Democrats will feel so strongly about defending the program that 60 votes will be needed to overcome a filibuster," said Ron Pollack, executive director of Families USA, a liberal advocacy group.

Mr. Grassley, who grew up on a farm but has spent the last 44 years in the state Legislature, the House and the Senate, carries himself modestly, happy to stay at economy motels on his round of town meetings, stopping by Wal-Mart at the end of the day. He is up for re-election next year and says he expects to raise "a massive amount of money" to meet what he expects to be a stiff challenge from the Democrats. He won 68 percent of the vote in 1998 and 70 percent in 1992.

Even after 23 years in the Senate and becoming chairman of a powerful committee, Mr. Grassley seems determined to present himself as an Iowan, first and foremost.

Doug Sickler, a retired banker active in economic development in Corning, told Mr. Grassley this week: "This is the heartland of America. Don't forget about us."

Mr. Grassley replied: "I come home every weekend. It's not easy to forget Iowa when you come home every weekend."

Hearing to Affect Government's Ability to Try Terror Suspects in Civilian Courts

WASHINGTON, June 1 — The Justice Department's ability to continue prosecuting members of Al Qaeda and other important terrorist suspects in civilian courts is on the line in a landmark appeals court hearing this week in the government's case against Zacarias Moussaoui, Bush administration officials and defense lawyers agree.

The specific question before the United States Court of Appeals for the Fourth Circuit, in Richmond, Va., on Tuesday is whether Mr. Moussaoui, the only person charged in an American court with conspiring in the Sept. 11, 2001, terrorist attacks, has the right to question captured Qaeda members held overseas whose testimony may aid in his defense.

The Justice Department is arguing that he has no such right and that the government cannot make captured terrorists available for testimony without divulging national security secrets and interrupting the government's effort to interrogate them for information that might pre-empt terrorist attacks.

But twice this year, Judge Leonie M. Brinkema of Federal District Court in Alexandria, Va., has ruled that Mr. Moussaoui's right to seek out trial testimony for his defense overrides the government's claims of national security damage.
