Scope and Content

The materials in FOIA 2014-0236-F are a selective, not necessarily all-encompassing, body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 2014-0236-F requested records sent to, sent by, or received by, President George W. Bush on the dismissal of eight United States Attorneys between January 2005 and December 2007.

This FOIA primarily contains production documents provided to Congress and the Department of Justice per subpoena requests for testimony and/or records. A vast majority of the production documents consist of email printouts from the Exchange Email system. The email printouts and other textual correspondence between the White House and Congress pertains to White House

staffers including Harriet Miers, Karl Rove, Fred Fielding, and Emmett Flood. The email printouts constitute the back and forth between staffers regarding the proposed dismissal or replacement of United States Attorneys in November and December 2006 specifically. They discuss the proposed plan and means for dismissal of Attorneys; the roles played by specific Administration staff; the House and Senate Judiciary Committees investigations; as well as nomination selections and pertinent information. Most of the email printouts are repetitive. There is textual correspondence between Congress and Department of Justice officials, including Attorneys General Alberto Gonzales and Michael Mukasey, and Solicitor General Paul Clement. There is back and forth communication between staffers about White House claims of executive privilege and include final memorandums from President George W. Bush who asserted executive privilege in response. Also present within the textual production documents are talking points and statements, news articles and press releases, Congressional hearing transcripts and reports, and published Presidential records. Audiovisual records consist of two video clips of a farewell reception for Karl Rove on September 14, 2007.

System of Arrangement

The materials in FOIA 2014-0236-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – White House Office of Records Management (WHORM) Subject Files and Staff Member Office Files (SMOF).

The White House Office of Records Management (WHORM) contains a variety of series created to organize and track documents and correspondence. The WHORM Subject Files and Alpha Files were compiled by staff in the White House Office of Records Management and are a series of documents assigned a letter/number combination and filed in a series of categories by subject. WHORM Subject Files and WHORM Alpha Files are processed at the document level.

Staff Member Office Files are maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Staff Member Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

White House Communications Agency records are processed at the folder/videotape level. While this method maintains folder/videotape integrity, it frequently results in the incidental processing of videotapes that are not wholly responsive to the subject area.
